## 2023 Renewal REMINDER

The Board of Liquor License
Commissioners for Baltimore City
(BLLC) issued a Press Release on April
18<sup>th</sup> to remind all stakeholders about
the 2023 License Renewal period.
Since the deadline of March 31st,
renewal applications will continue to
incur a late fee of \$50 per day. In
order for a licensed establishment to
operate legally, it is imperative that
renewals be processed and a new
license be displayed on premises by
May 1st.

ANY LICENSEE NOT DISPLAYING A
VALID LICENSE ON OR AFTER MAY
1ST WILL BE POSTERED BY BLLC
INSPECTORS AS CLOSED TO
ALCOHOL SALES UNTIL THE
RENEWAL PROCESS IS COMPLETED.
