**Alleged violation of Rule 3.12 (General Welfare) when at approximately 1:40 a.m. on May 13, 2017 members of the Baltimore City Police Department responded to the establishment for a call related to a “cutting” when the officer observed 3 males suffering from multiple stab wounds.**

**Alleged violation of Rule 4.16 (Illegal Conduct) when at approximately 1:40 a.m. on May 13, 2017 members of the Baltimore city Police Department responded to the establishment for a call related to a “cutting” when the officer observed 3 males suffering from multiple stab wounds. When the suspect was identified at Shock Trauma, the State’s Attorney’s office for Baltimore City indicted the suspect.**
