The Greater Greektown Neighborhood Alliance (GGNA) is writing to formally protest the renewal of Casa Luna Sports Bar, Inc. owned by Jose Luna, located at 500 S. Lehigh Street, Baltimore, MD 21224 liquor license for the year starting on May 1, 2017.

GGNA is deeply concerned about the continued negative impact that the lawless operation of this establishment is having on the quality of life of local residents. Over the past year, numerous neighbors living within close proximity of this establishment have contacted GGNA expressing frustration with the daily operation of Casa Luna Sports Bar, Inc.

Despite a violation issued by the Baltimore City Liquor Board this past year for operating after 2:00am, subsequently receiving fines and being forced to shut down temporarily, Casa Luna Sports Bar, Inc. continues to operate in a haphazard manner. This should come as no surprise considering Casa Luna Sports Bar, Inc. has violated the law multiple times dating back to January 2013. The multiple examples of this establishment's ownership failing to properly follow regulations designed to protect Baltimore City communities is more than disrespectful it is reckless, an affront to the Baltimore City Liquor Board and potentially dangerous to local residents.

The negative impact Casa Luna Sports Bar Inc. has had on the public health of the surrounding community cannot be understated. The persistent negative impacts directly associated to this establishment include trash, loitering, excessive noise, drunk driving, illegal parking, and drug trafficking. Together these somewhat minor problems combine to form a pattern of disrespectful behavior and flagrant disregard for the law that ends up posing a true threat to the health and vitality of Greektown's future. The establishment's ownership continues to operate in a manner that lacks accountability and concern for the well-being of both bar patrons and surrounding neighbors.

Greektown itself is home to a diverse variety of different commercial establishments, restaurants, and bars. GGNA will continue to support the vast majority of business operations within Greektown that operate in a responsible manner and who have a vested interest in the health of the surrounding community. However, GGNA would be doing local residents and businesses alike a disservice by turning a blind eye to Casa Luna Sports Bar, Inc. who has repeatedly operated in a manner that violates liquor license regulations and negatively impacts the surrounding community. With this in mind, GGNA is submitting this letter to formally protest the renewal of Casa Luna Sports Bar, Inc.'s liquor license for the year starting on May 1, 2017.

PETITON TO PROTEST THE RENEWAL OF THE LICENSE

We, the undersigned residents PROTEST the renewal of the liquor license of Redd Tavern for use as a Bd7, located at 2533 Pennsylvania for the following reasons:

- Patrons are often disorderly and disruptive as they leave the premises;
- Patrons regularly loiter and litter on the sidewalks and surrounding premises;
- Patrons engage in violent altercations inside the establishment that spill out into the surrounding neighborhoods including one murder;
- Drug activity occurs both in and on the periphery of the establishment, and
- Patrons discard trash throughout the community
- Tavern has not been open to the Public for over a year and owners knowingly allow people to drink in cut rate and stand on the sidewalks

Residents and businesses alike have concerns about safety in the neighborhood due to belligerent and raucous patrons. In the past year, residents have made over 100 calls to the police because of disruptive activity at the bar. Responsible area businesses are fearful and tired of paying to repair their storefronts due to vandalism and disturbances on the property.

Churches, business owners, community organizations, and residents, in cooperation with the police in our district, oppose the renewal of the liquor license.
