(c) **Purchase Price of Business:** 100% transfer of ownership of corporation from Tracy Proietti to applicant Leigh Hitz through corporate buyback of license.

(d) **Qualified Voters:** Ebony Nicholson, Charles Uttenreither, Jr., and Mary Uttenreither are qualified Baltimore City voters.

(e) **Zoning:** Applicant has applied for a USE permit, for the continued use of the property as a hotel with 107 guest rooms on the 4th through 14th floors, staff offices throughout, conference rooms, main reception area and main kitchen on the second floor. A café on the 1st floor restaurant and bar rooftop level, and indoor live entertainment.

(f) **Corporate Standing:** LL Pro Hospitality Baltimore, LLC is a MD LLC and as of 5/19/2020 is active and in good standing.

(g) **Posting Report:** The location was posted on 5/18/2020, and checked on 5/28/2020. This meets the 10-day rule. There are 8 licensed liquor establishment(s) in the 2x2 area: "A" BWL-1; "B" BWL-4; "C" BWL-2; and "Hotel/Motel"-1.

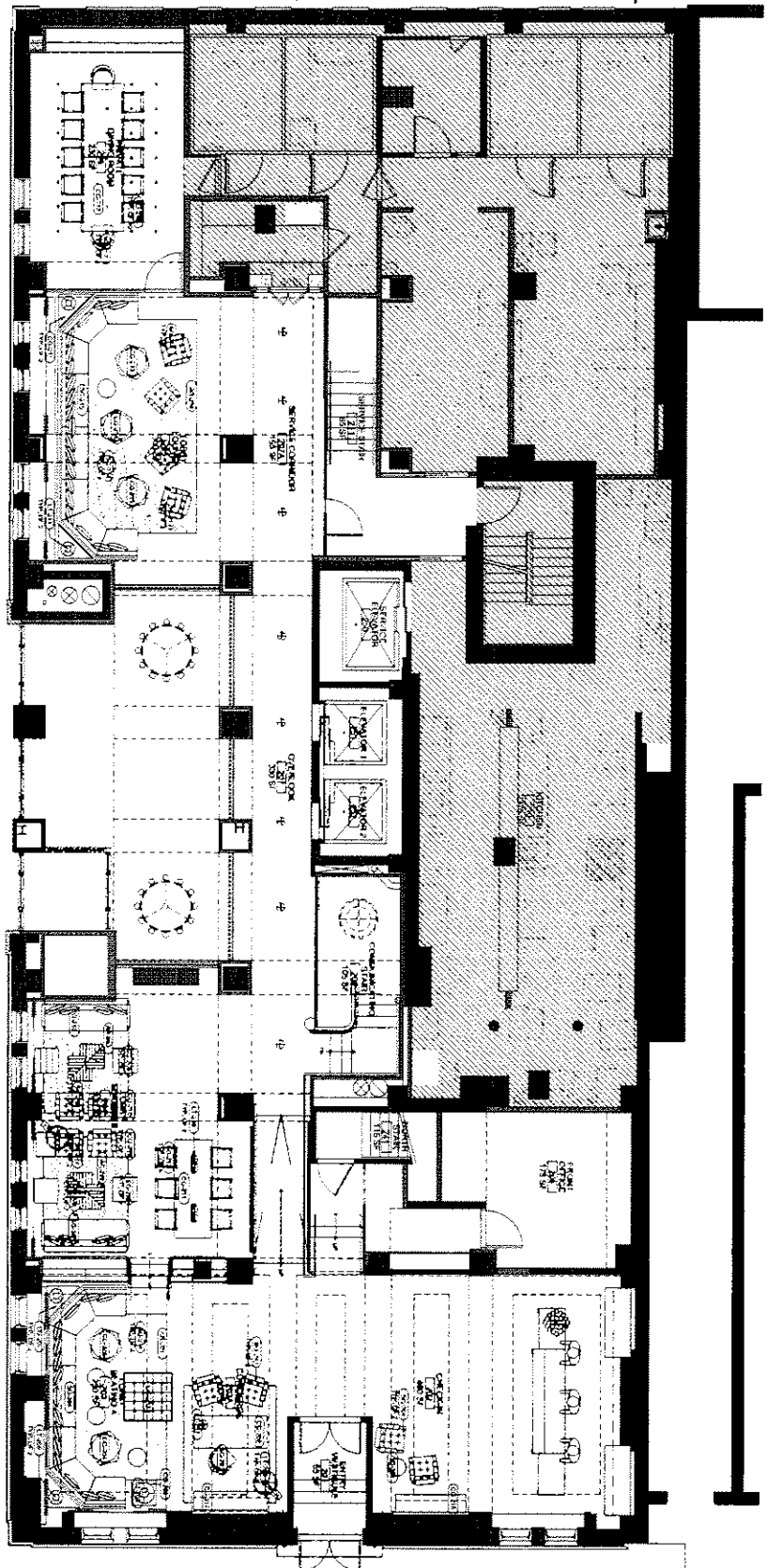

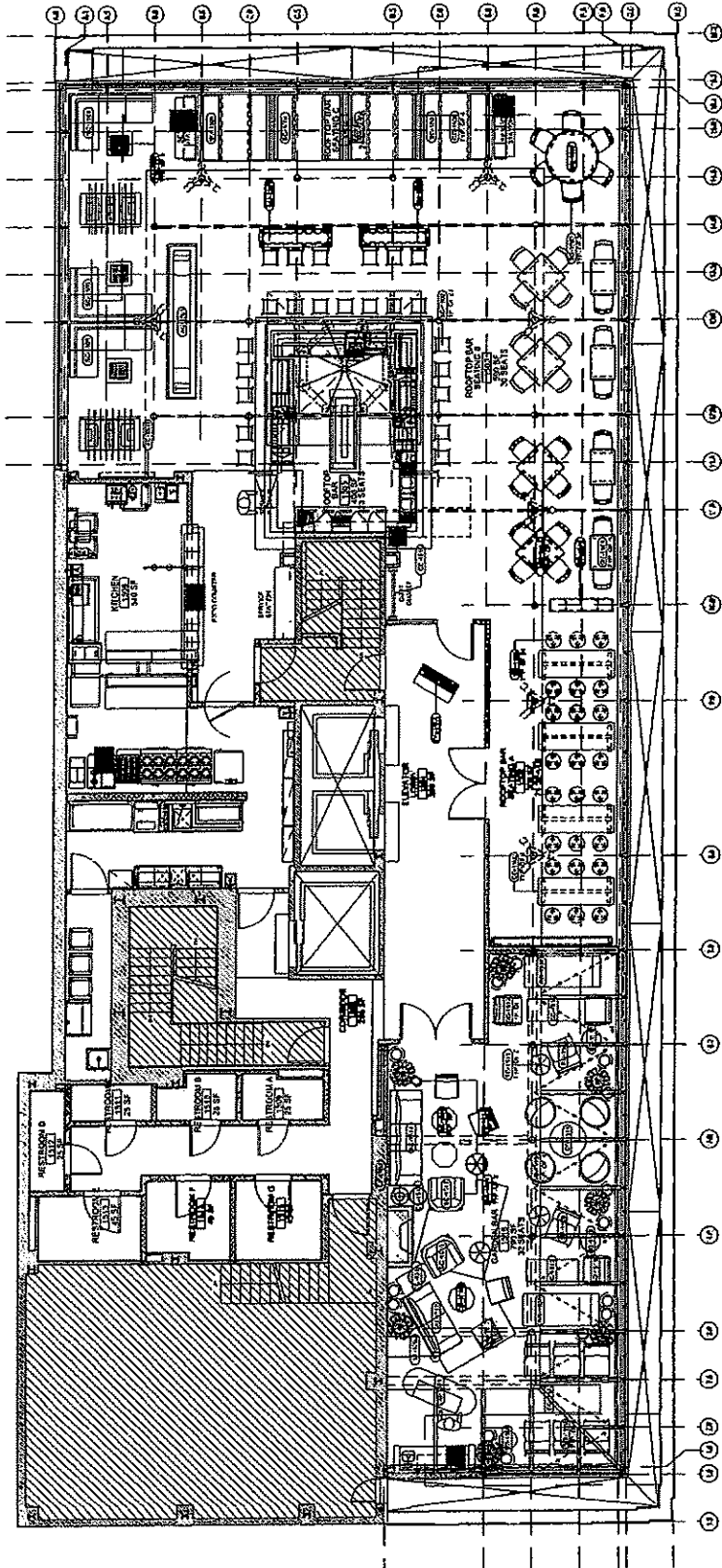
