Alleged violation of Rule 3.08(a) (Sanitation and Safety) when at approximately 10:55 p.m. on February 17, 2017 members of the Baltimore City Police Department, Department of Housing and Community Development, and the BLLC conducted an investigation of the establishment due to a complaint from BGE stating the establishment were using generators to power the building. Upon inspection, all three parties saw two generators in the backyard powering the establishment and heaters to provide heat. Due to the violations, the established was asked to close.

Alleged violation of Rule 4.16 (Illegal Conduct) when at approximately 3:48 p.m. on March 25, 2017 members of the BLLC conducted a review of the corporate status of the entity and found that the entity was forfeited by the State Department of Assessments and Taxation. Corporate Standing: Elite Lounge, LLC is a forfeited Maryland corporation not in good standing as of March 25, 2017.
