BOARD OF LIQUOR LICENSE COMMISSIONERS TO HOLD AT LEAST THREE PUBLIC HEARINGS PER MONTH DURING THE FIRST QUARTER OF 2017

Baltimore, **MD** – On January 5, 2017, Chairman Albert J. Matricciani Jr. of the Board of Liquor License Commissioners for Baltimore City (BLLC) announced the Board's intention to hold at least three public hearings per month during the first quarter of 2017.

Matricciani stated that the Board "will be sitting formally in docket hearings three Thursdays for each month for the next four months and on the fourth Thursday [when the Board is not in session] we have conferences scheduled among ourselves to deal with internal agency business."
