- (b) Ownership Breakdown: (1) Solomon Weldekirstos (99%); (2) Kibrom Samuel (1%)
- (c) Purchase Price of Business: The purchase price of the business is \$204,000, and will be paid at settlement.
- (d) Qualified Voters: Daniel Ghebrekiden, Tigist Michael, and Kibrow Ghebrekiden are qualified Baltimore City voters.
- (e) **Zoning**: Applicants have applied for a USE permit, use of the property as a tavern.
- (f) Corporate Standing: O'Ryan, LLC is a MD LLC and as of 2/08/2017 is active and in good standing.
- (g) **Posting Report**: The location was posted on 1/04/2017 and checked on 1/17/2017. This meets the 10-day rule. There are 6 licensed liquor establishments in the 4x4 area: "B" BWL-2; "D" BWL-1; and "BD7" BWL-3.
