RESOLUTION

This matter comes before the Board on appeal from the decision of the Zoning Administrator for Baltimore City denying Julie Tice's ("Petitioner" or "Appellant") application to construct a third floor addition with rear decks located on the second and third floors all for use by the existing restaurant.

BACKGROUND

This property is located in an R-8 Zoning District and is improved by a two-story masonry attached building with prior authorized use as a restaurant on the first floor and one dwelling unit on the second floor.

Appellant filed this appeal to the Board on January 9, 2017, and appeared for a public hearing on January 31, 2017. No one appeared in opposition to this appeal. Board staff and the Planning Department prepared memoranda evaluating the appeal.

DISCUSSION

Appellant proposes to construct a third floor addition with rear decks located on the second and third floors all for use by the existing restaurant. Under ZC §§ 4-1101, 4-1103, or 4-1102, restaurants are not listed as a permitted, conditional, or accessory use in this zoning district. The restaurant use is authorized as a lawfully existing nonconforming use under permit USE2011-05252. The proposed construction, therefore, would be an expansion of a Class III non-conforming use.

The existing nonconforming restaurant occupies approximately 4,722 square feet of the first floor of the structure. The proposed expansion use will occupy approximately 5,754 square feet, which is a total increase in the non-conforming use by 17.93%. Under § 13-406, a Class III non-conforming use may not be expanded in any manner, unless that expansion is made to conform to the regulation of the district in which the structure is located. However, under ZC §13-714, the Board may authorize the expansion of a Class III non-conforming use if the Board finds that: (1) The extension or moving will not cause a greater volume of traffic than that generated before the extension; (2) The extension will not violate in any manner the bulk regulations of the district in which the property is located; (3) The effect of the extended or moved use on the health, safety, or general welfare of the community will be no worse than the existing or last use; (4) for the extension of a Class III or Class III nonconforming use, the extension will not result in



adversely affect transportation; (vii) unduly burden water, sewer, school, park, or other public facilities; (viii) increase the danger of fire; or (ix) otherwise endanger the public safety; (6) the variance is not precluded by and will not adversely affect: (i) any Urban Renewal Plan; or (ii) the City's Master Plan; (7) the variance will not otherwise: (i) be detrimental to or endanger the public health, security, general welfare, or morals; or (ii) in any way be contrary to the public interest; (8) the variance is in harmony with the purpose and intent of this article; and (9) within the purpose and intent of this article, the variance granted is the minimum necessary to afford relief, to which end a lesser variance than that applied for may be permitted.

The conditions on which this application is based are unique to this property because of its location. The unnecessary hardship or practical difficulty caused by a strict application of the Zoning Code has not been created by the intentional action or inaction of any person who has a present interest in the property. The purpose of the requested variance is not based exclusively on a desire to increase the value or income potential of the property as no such evidence was adduced at the hearing or can be inferred from the plans. The Board finds by competent evidence that the variance requested will not impair light, air, or neighboring property values, will not overcrowd the land, create undue concentration in population or increase traffic on streets or parking, unduly burden public utilities, or increase public safety hazards. The Board further finds that the requested variance will not be detrimental to or endanger the public health, security, general welfare, or morals, or be contrary to the public interest. The variance requested is not precluded by law or by any applicable Urban Renewal Plan or the Baltimore City Master Plan and is in harmony with the purpose and intent of the Zoning Code of the City of Baltimore. Lastly, the variance requested are the minimum necessary to afford relief under this application as the structure on this lot is an existing structure and the proposed changes merely return this lot to its original design.

For the reasons set forth above, and after giving public notice, reviewing the zoning records, holding a public hearing, considering all data submitted, and by authority of Ordinance No. 1051, approved April 21, 1971, known as the Zoning Ordinance, it is this 13 day of February 2017, by the Baltimore City Board of Municipal and Zoning Appeals, hereby

RESOLVED, that Petitioner's request to construct a third floor addition with rear decks located on the second and third floors all for use by the existing restaurant is **GRANTED**.
