Mr. Goden took the members of the Task Force to the back yard where 2 generators were located under a tarp. During the inspection it was discovered that the establishment also had 2 propaine heaters running inside for a source of heat. The Fire Marshal at that time explained to the operator that the establishment needed to close due to Fire code violations. The operator was cooperative during the process and the establishment was cleared out. The fire marshal issued citations for the violations and the Task Force exited the location without any further incident.







