I am writing to express my objection in giving an approval to the application from Boston's Restaurant & Sports Bar to have live entertainment and outside table service on their premises at 819 E Pratt St.

I live in a townhouse at right across from the said business. I am also writing in the protest on behalf of my neighbor, Dr. Mohamed Rached, who lives at and is away in Turkey for the summer.

Having a sports bar in residential areas of Little Italy and the Albemarle Square neighborhood with small children is already unconscionable. To have live entertainment and outside table service will disturb the peace and quiet of these neighborhoods and their residents. Moreover, there is no room to have tables outside without infringing on the sidewalks.

There has never been a sports bar this conspicuous in Little Italy. As the name indicated, the business is basically emphasizing on serving alcohol. When patrons have too much to drink, rowdiness and public nuisance will ensue. This is the outcome we residents in these two communities want to avoid.

When I first moved to my townhouse in 2007 the premises used to be an Italian restaurant like all other restaurants in Little Italy. When the restaurant closed a couple years later a Chinese restaurant opened but was in business for less than a year. The building was vacant for six or seven years before it was bought and renovated extensively in the past year or so.

And now the Boston's Restaurant & Sports Bar is opening and with it bringing negative environment to our communities. As a resident, I hope the Board will deny its application to have live entertainment and outside table service.

(Senate Bill 384)

AN ACT concerning

Baltimore City - Alcoholic Beverages - Old Goucher Revitalization District Licenses

FOR the purpose of exempting an applicant for a <u>certain</u> Class B–D–7 license in a certain Old Goucher Revitalization District in the 43rd alcoholic beverages district in Baltimore City from certain zoning requirements; creating an exception <u>exceptions</u> under which the Board of License Commissioners for Baltimore City may issue certain new Class B–D–7 licenses <u>in certain alcoholic beverages districts</u> under certain circumstances; specifying that, notwithstanding certain other provisions of law, the Board may issue certain licenses to certain establishments that are located in certain areas and meet a certain minimum capital investment requirement; specifying that a <u>certain</u> Class B–D–7 license may be transferred within, but may not be transferred out of, the Old Goucher Revitalization District; specifying that a certain distance restriction for the issuance of new alcoholic beverages licenses within a certain distance of a school or place of worship does not apply to a property in a certain Old Goucher Revitalization District; defining a certain term; <u>making this Act an emergency measure</u>; and generally relating to alcoholic beverages in Baltimore City.

BY repealing and reenacting, without amendments, Article – Alcoholic Beverages Section 12–102, 12–905, and 12–1605(a)(1) Annotated Code of Maryland (2016 Volume and 2016 Supplement)

BY repealing and reenacting, with amendments, Article – Alcoholic Beverages Section 12–1407, 12–1603, and 12–1605(a)(2) Annotated Code of Maryland (2016 Volume and 2016 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article - Alcoholic Beverages

12 - 102.

This title applies only in Baltimore City.

12-905.

2017 LAWS OF MARYLAND

- (a) There is a Class B–D–7 beer, wine, and liquor license.
- (b) (1) The Board may issue a Class B-D-7 license if the Board determines that the license is reasonably necessary for the convenience of the public.
- (2) In making the determination, the Board shall consider the number of beer, wine, and liquor outlets in a given area and the number of days the outlets are open, rather than the nature of the outlets.
- (c) The license authorizes the license holder to sell beer, wine, and liquor at retail at the place described in the license, for on– and off–premises consumption.
- (d) The license holder may sell beer, wine, and liquor during the hours and days set out under § 12–2004(c) of this title.
- (e) The Board shall adopt regulations to determine the manner of operation of a licensed premises.
 - (f) The annual license fee is \$1,320.

12 - 1407.

- (a) (1) The Board or the Board's designee shall examine each application for the issuance or transfer of a license within 45 days of receipt of the application to determine whether the application is complete.
- (2) [An] EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, AN application for the issuance, transfer, or renewal is not complete unless the applicant has:
- (i) obtained zoning approval or verification of zoning if the application is for renewal;
 - (ii) submitted all documents required in the application; and
 - (iii) paid all fines and fees that are due.
- (3) An application for the issuance, transfer, or renewal of a Class B–D–7 license <u>That may be issued under § 12–1603(c)(5)</u> 12–1603(c)(6) of this title in the Old Goucher Revitalization District under § 12–1603(e) of this title is complete without an applicant obtaining zoning approval or verification of zoning.

- (b) (1) A license hearing may not be scheduled unless the Board determines that the application is complete.
- (2) A complete application with all submitted documents shall be posted online at least 14 days before the hearing date.
- (3) The postponement of a hearing shall be posted online not less than 72 hours before the hearing date.
- (c) (1) To incorporate a change in the application document after the Board or the Board's designee has determined the application to be complete, the applicant shall submit the change to the Board not later than 15 days before the scheduled hearing.
- (2) After the hearing on the application, an applicant may change the application only at a new hearing.
- (d) The Board shall impose a fine that it determines for failure to comply with the requirements under this section.

- (a) The alcoholic beverages districts described in this section at all times are coterminous with the legislative districts in the Legislative Districting Plan of 2002 as ordered by the Maryland Court of Appeals on June 21, 2002.
- (b) Except as provided in subsection (c) of this section, the Board may not issue a new license in:
 - (1) the 40th alcoholic beverages district;
 - (2) the 41st alcoholic beverages district;
 - (3) the 43rd alcoholic beverages district;
 - (4) the 44th alcoholic beverages district; and
 - (5) the 45th alcoholic beverages district.
 - (c) The Board may issue:
- (1) in the alcoholic beverages districts specified in subsection (b) of this section:
 - (i) a 1-day license; or
 - (ii) a Class B beer, wine, and liquor license to a restaurant that:

- 1. has a minimum capital investment, not including the cost of land and buildings, of \$200,000 for restaurant facilities; and
 - 2. has a minimum seating capacity of 75 individuals;
- (2) a Class C beer, wine, and liquor license in the 45th alcoholic beverages district;
- (3) a Class C beer, wine, and liquor license in ward 5, precinct 1 of the 44th alcoholic beverages district; [and]
- (4) a Class C beer, wine, and liquor license in the 200 block of West Saratoga Street in ward 4, precinct 3 of the 40th alcoholic beverages district; AND

(5) A CLASS B–D–7 LICENSE IN THE 100 BLOCK OF NORTH AVENUE IN THE 45TH ALCOHOLIC BEVERAGES DISTRICT; AND

- (5) (6) Subject to the requirements under subsection (e) of this section, four Class B-D-7 licenses in the 43rd alcoholic beverages district.
- (d) One Class B–D–7 license issued for a property surrounded by Morton Street on the west, West Eager Street on the north, North Charles Street on the east, and West Read Street on the south may be transferred to a property surrounded by 21st Street on the north, Morton Street on the west, North Charles Street on the east, and 20th Street on the south.
- (E) (1) IN THIS SUBSECTION, "OLD GOUCHER REVITALIZATION DISTRICT" MEANS THE AREA SURROUNDED BY HOWARD STREET ON THE WEST, 25TH STREET ON THE NORTH, ST. PAUL STREET ON THE EAST, AND 22ND STREET ON THE SOUTH.
- (2) IF AN ESTABLISHMENT HAS A MINIMUM CAPITAL INVESTMENT, NOT INCLUDING LAND AND ACQUISITION COSTS, OF \$50,000, THE BOARD MAY ISSUE ONE CLASS B–D–7 LICENSE FOR USE IN EACH OF THE FOLLOWING PROPERTIES IN THE OLD GOUCHER REVITALIZATION DISTRICT:
- (I) A PROPERTY THAT IS SURROUNDED BY MARYLAND AVENUE ON THE WEST, 24TH STREET ON THE NORTH, MORTON STREET ON THE EAST, AND 22ND STREET ON THE SOUTH;

- (II) A PROPERTY THAT IS SURROUNDED BY MORTON STREET ON THE WEST, 23RD STREET ON THE NORTH, CHARLES STREET ON THE EAST, AND 22ND STREET ON THE SOUTH;
- (III) A PROPERTY THAT IS SURROUNDED BY MORTON STREET ON THE WEST, WARE STREET ON THE NORTH, CHARLES STREET ON THE EAST, AND 24TH STREET ON THE SOUTH; AND
- (IV) A PROPERTY THAT IS SURROUNDED BY MARYLAND AVENUE ON THE WEST, 24TH STREET ON THE NORTH, MORTON STREET ON THE EAST, AND 23RD STREET ON THE SOUTH.

(3) A CLASS B-D-7 LICENSE

- (1) THAT MAY BE ISSUED UNDER § 12–1603(C)(5)
 12–1603(C)(6) OF THIS TITLE MAY BE TRANSFERRED WITHIN THE OLD GOUCHER
 REVITALIZATION DISTRICT: AND
- (II) MAY NOT BE TRANSFERRED OUT OF THE OLD GOUCHER REVITALIZATION DISTRICT.

12 - 1605.

- (a) (1) (i) Except as otherwise provided in this subsection, a new license may not be issued for and an existing license may not be moved to a building that is within 300 feet of the nearest point of the building of a place of worship or school.
- (ii) In the 45th legislative district, a new Class A license of any type may not be issued for a building that is within 500 feet of the nearest point of the building of a place of worship or school.
 - (2) Paragraph (1)(i) of this subsection does not apply to:
- (i) a Class B beer and wine license outside the 46th legislative district;
- (ii) a Class B beer, wine, and liquor license outside the 46th legislative district;
- (iii) A CLASS B-D-7 LICENSE IN THE OLD GOUCHER REVITALIZATION DISTRICT UNDER § 12–1603(E) OF THIS SUBTITLE;
 - (IV) a Class C beer and wine license; and
 - [(iv)] (V) a Class C beer, wine, and liquor license.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2017 is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.





THIS OPERATING MEMORANDUM (as amended from time to time in accordance with the provisions hereof, this "Memorandum") is made and entered into this 21st day of March, 2017 by THE PRODUCERS CLUB OF MARYLAND, INC., a Maryland non-stock corporation (the "Member").

ARTICLE I

Introduction

- Section 1.1. Formation of Limited Liability Company. Parkway Theatre Service, LLC, desiring to form a Maryland limited liability company under the Maryland Limited Liability Company Act, Title 4A of the Corporations and Associations Article of the Annotated Code of Maryland (as amended from time to time, the "Act"), has made this Memorandum and has executed and filed the Articles of Organization attached hereto as Exhibit B (the "Articles") with the Maryland State Department of Assessments and Taxation. The Company's business shall be conducted under the name "Parkway Theatre Service, LLC". This Memorandum is subject to, and governed by, the Act and the Articles. In the event of a direct conflict between the provisions of this Memorandum and either the Articles or the mandatory provisions of the Act, such provisions of the Articles or the Act, as the case may be, will be controlling.
- **Section 1.2. Defined Terms.** The terms defined in the Preamble hereto and in Section 1.1 shall have the meanings specified therein, and all other capitalized terms used in this Memorandum shall have the meanings set forth below.
- 1.2.1. "Accountants" means such accounting firm as may be retained from time to time by the Member.
- 1.2.2. "Additional Member" means any individual or Entity admitted as a Member pursuant to Section 2.6 hereof.
- 1.2.3. "Affiliate" or "Affiliated Person" means any Person, directly or indirectly, through one or more intermediaries, controlling, controlled by, or under common control with, a Member. The term "control" as used in the immediately preceding sentence, means, with respect to a corporation, the right to exercise, directly or indirectly, more than 50% of the voting rights attributable to the controlled corporation, and, with respect to any Person, the possession, directly or indirectly, of the power to direct or cause the direction of the management or policies of the controlled Person.
- 1.2.4. "Authorized Person" means each of those persons who shall be authorized by the Member acting pursuant to Article III to execute or file documents on behalf of the Company and to otherwise act as its agent.

- 1.2.5. "Available Cash" of the Company means all cash funds of the Company on hand from time to time (other than cash funds obtained as contributions to the capital of the Company by the Member and cash funds obtained from loans to the Company) after (i) payment of all independent third party operating expenses actually incurred and paid by the Company as of such time, (ii) provision for payment of all outstanding and unpaid current obligations of the Company as of such time.
- 1.2.6. "Capital Account" of the Member means the account established and maintained for the Member pursuant to Section 2.4 hereof.
- 1.2.7. "Capital Contribution" means the total value of cash and agreed fair market value of tangible and intangible property contributed and agreed to be contributed to the Company by the Member, as shown in Exhibit A, as the same may be amended from time to time. Any reference in this Memorandum to the Capital Contribution of a then Member shall include a Capital Contribution previously made by any prior Member in respect of the interest of the then Member, reduced by any distribution to such Member in return of "Capital Contribution" as contemplated herein.
- 1.2.8. "Code" means the Internal Revenue Code of 1986, as amended. All references herein to sections of the Code shall include any corresponding provision or provisions of succeeding law.
- 1.2.9. "Company" means Parkway Theatre Service, LLC, the limited liability company that was formed under the Act upon the filing of the Articles, and that is the subject of this Memorandum.
- 1.2.10. "Entity" means any association, corporation, general partnership, limited partnership, limited liability company, limited liability partnership, joint stock association, joint venture, firm, trust, syndicate, business trust or cooperative, and any foreign associations of like structure.
- 1.2.11. "Interest" in the Company means the entire ownership interest of the Member in the Company at any particular time, including the right of the Member to any and all benefits to which the Member may be entitled as provided in this Memorandum and under the Act, together with the obligations of the Member to comply with all of the terms and provisions of this Memorandum.
- $\,$ 1.2.12. "Member" means THE PRODUCERS CLUB OF MARYLAND, INC., and any Additional Member.
 - 1.2.13. "Person" means any individual or Entity.
- 1.2.14. "Principal Office" means the principal business office of the Company as established from time to time by the Member, initially being 105 Ridgewood Road, Baltimore, Maryland 21210.

- 1.2.15. "Regulations" means the federal income tax regulations promulgated under the Code, as amended from time to time, and including corresponding provisions of succeeding regulations.
- 1.2.16. "Resident Agent" means the resident agent as provided in the Articles attached hereto as Exhibit B, and any successor resident agent as provided in the Act.
- 1.2.17. "Term" shall refer to the term of this Company, beginning on the date the Articles were filed and being perpetual in duration, unless terminated pursuant to the Act or the terms of this Memorandum.
- Section 1.3. Company Purpose. The Company's purpose shall be to operate food and beverage services at the Parkway Theatre located at 3 W. North Ave, Baltimore, MD 21201, and to engage in any other lawful act or activity which may be carried on by a limited liability company under the Act which the Member of the Company may from time to time authorize or approve pursuant to the provisions of the Company's Operating Memorandum, whether or not related to the business described elsewhere in this Article I or to any other business at the time or heretofore engaged in by the Company.
- Section 1.4 Tax-Exempt Status of Member. All acts, activities and business carried on by the Company shall be consistent with the tax-exempt status of the Member under Section 501(c)(3) of the Code.

ARTICLE II

Members and Membership Interests

- Section 2.1. Name and Address of Member; Principal Office. The Member, the Member's address, and its initial Capital Contribution to the Company are set forth on Exhibit A attached hereto and made a part hereof.
- **Section 2.2. Form of Contributions.** The initial Capital Contribution was in the form and in the amounts or values provided in <u>Exhibit A</u>. Subsequent contributions shall be in such amounts and may be in any type of property as may be determined by the Member. The Member shall not be required to make any Capital Contribution to the Company other than the initial Capital Contribution, except as may be provided under Section 2.4 hereof.
- Section 2.3. Member Loans or Services. Loans by the Member to the Company shall not be considered contributions to the capital of the Company. Services may be considered contributions to capital if so determined by the Member.

Section 2.4. Capital and Capital Accounts.

2.4.1. An individual Capital Account shall be established and maintained on behalf of each Member, including any Additional Member or Substitute Member who shall hereafter receive an Interest in the Company. The Capital Account of each Member shall consist of: (i) the amount of cash such Member has contributed to the Company plus (ii) the agreed fair market value

of any tangible or intangible property such Member has contributed to the Company, net of any liabilities assumed by the Company or to which such property is subject, <u>plus</u> (iii) the amount of profits or income (including tax-exempt income and any other item required to be credited for proper maintenance of capital accounts by the Regulations under Section 704(b) of the Code) allocated to such Member, <u>less</u> (iv) the amount of losses and deductions allocated to such Member, <u>less</u> (v) the fair market value of any property distributed to such Member, net of any liability assumed by such Member or to which such property is subject, and <u>less</u> (vii) such Member's share of any other expenditures which are not deductible by the Company for federal income tax purposes and which are not allowable as additions to the basis of Company property; all, however, subject to such other adjustments as may be required for proper maintenance of capital accounts by the Regulations under Section 704(b) of the Code. The Capital Account of a Member shall not be affected by any adjustments to basis made pursuant to Section 743 of the Code, but shall be adjusted with respect to adjustments to basis made pursuant to Section 734 of the Code.

- 2.4.2. The opening entry for the Member shall be the Member's Capital Contribution as set forth on Exhibit A. No interest shall be paid on any Capital Contribution.
- **Section 2.5. Contribution of Additional Capital.** Additional capital may be contributed to the Company.
- **Section 2.6.** Admission of Additional Members. The Member may admit to the Company additional Member(s) who will participate in the profits, losses, available cash flow and ownership of the assets of the Company on such terms as are determined by the Member. Such Additional Members shall be allocated gain, loss, income, or expense by such method as may be provided in this Memorandum.
- Section 2.7. Limitation of Liability. The Member shall not be liable under a judgment, decree or order of the court, or in any other manner, for a debt, obligation or liability of the Company, except as otherwise required by law, it being the intent of the Member to have the fullest limitation of liability allowed by law. The Member shall not be required to loan any funds to the Company. Except as may be expressly provided otherwise herein, the Member shall not be required to make any contribution to the Company by reason of any negative balance in the Member's Capital Account, nor shall any negative balance in the Member's Capital Account create any liability on the part of the Member to any third party.

ARTICLE III

Management and Control of Business

- **Section 3.1. Overall Management Vested in Member.** Management for the purpose of the business of the Company shall be vested in the Member and all powers of the Company shall be exercised by or under the authority of, and the business and affairs of the Company shall be managed under the direction of, the Member. The Member may appoint any natural person as an Authorized Person and may appoint such officers and hire such employees, and may charge such officers and employees with such duties, as the member deems appropriate.
- **Section 3.2. Officers.** The Member may appoint such officers of the Company and hire such employees, and invest such officers and employees with such duties, as the Member deems appropriate. All such officers and employees of the Company shall be subject to removal by the Member.
- **Section 3.3. Authorized Persons.** Any Authorized Person may execute any document or instrument authorized to be executed on behalf of the Company without the necessity of joinder by the Member of any other person. Any Authorized Person and any officer or employee designated by the Member shall have authority to sign checks.

ARTICLE IV

Accounting and Records

Section 4.1. Records and Accounting.

- 4.1.1. The books and records of the Company shall be kept, and the financial position and the results of its operations recorded, in accordance with the accounting methods elected to be followed by the Company for federal income tax purposes. The books and records of the Company shall reflect all Company transactions and shall be appropriate and adequate for the Company's business.
- 4.1.2. The Member may engage a Person to be responsible for: authenticating the records of the Company, including keeping correct and complete books of account which show accurately at all times the financial condition of the Company, safeguarding all funds, notes, securities and other valuables which may from time to time come into possession of the Company, depositing all funds of the Company with such depositories as the Member shall designate. Such employee shall have such other duties as the Member may from time to time prescribe, but under no circumstances shall such employee have any of the rights, powers, responsibilities or duties of the Member of the Company as prescribed herein or by law.
- **Section 4.2. Accounting Decisions.** All decisions as to accounting matters, except as otherwise specifically set forth herein, shall be made by the Member. The Member may rely upon the advice of the Accountants as to whether such decisions are in accordance with applicable accounting methods for federal income tax or general accounting purposes.

- **Section 4.3. Federal Income Tax Elections.** The Company may make all elections for federal income tax purposes, including but not limited to, the following:
- (i) to the extent permitted by applicable law and regulations, the election to use an accelerated depreciation method on any depreciable unit of the assets of the Company; and
- (ii) in case of a transfer of all or part of the Member's Interest or the distribution to the Member of Company property, the election pursuant to Sections 734, 743 and 754 of the Code to adjust the basis of the assets of the Company.

ARTICLE V

Allocations; Distributions; Interests

- Section 5.1. Allocation of Net Income, Net Loss or Capital Gains. In accordance with the Code and Resolutions, all net income or net loss and/or capital gains of the Company for each fiscal year of the Company shall be allocated to the Member.
- **Section 5.2. Distribution of Available Cash.** Upon the decision of the Member, the Available Cash of the Company shall be distributed to the Member, or in such other manner as the Member may decide. Available Cash of the Company shall not be distributed if such cash is required to maintain a reasonable working capital reserve for the Company.

Section 5.3. Allocation of Income and Loss and Distributions in Respect of Interests Transferred.

- 5.3.1. If any Interest in the Company is transferred, or is increased or decreased by reason of the admission of a new Member or otherwise, during any fiscal year of the Company, each item of income, gain, loss, deduction or credit of the Company for such fiscal year shall be assigned pro rata to each day in the particular period of such fiscal year to which such item is attributable (i.e., the day on or during which it is accrued or otherwise incurred) and the amount of each such item so assigned to any such day shall be allocated to the Member based upon his or her respective Interest in the Company at the close of such day. For the purpose of accounting convenience and simplicity, the Company may treat a transfer of, or an increase or decrease in, an Interest in the Company which occurs at any time during a monthly period (commencing with the monthly period including the date hereof) as having been consummated on the first day of the calendar month following such monthly period, regardless of when during such monthly period such transfer, increase or decrease actually occurs (i.e., sales and dispositions made during any month will be deemed to have been made on the first (1st) day of the next calendar month).
- 5.3.2. Distributions of Company assets in respect of an Interest in the Company shall be made only to the Members who, according to the books and records of the Company, are the holders of record of the Interests in respect of which such distributions are made on the actual date of distribution. Neither the Company nor the Member shall incur any liability for making distributions in accordance with the provisions of the preceding sentence, whether or not the Company or the Member has knowledge or notice of any transfer or purported transfer of ownership of Interest in the Company. Notwithstanding any provision above to the contrary, gain or loss of the

Company realized in connection with a sale or other disposition of any of the assets of the Company shall be allocated solely to the parties owning Interests in the Company as of the date such sale or other disposition occurs.

ARTICLE VI

Changes in Members

- **Section 6.1. Dissolution.** There shall be no events of dissolution except as required by applicable law, or by Section 7.1.1. Upon the occurrence of a mandatory event of dissolution under applicable law, the Company shall dissolve and its affairs shall be wound up and its properties liquidated, in accordance with Section 7.1.2.
- Section 6.2. Transfer and Assignment of Member's Interest; Admission of Additional Members. The Member shall be entitled to assign, convey, sell, pledge, hypothecate, encumber or in any way alienate (hereinafter, collectively a "Transfer") all or any part of its Interest in the Company. No transferee or Additional Member shall become a Member, however, unless or until such transferee agrees in writing to be bound by this Memorandum as the same may be amended to accommodate such admission.
- **Section 6.3. Effect of Transfer.** Any permitted transfer of all or any portion of the Member's Interest in the Company will take effect on the first (1st) day of the month following such transfer.

ARTICLE VII

Termination

Section 7.1. Termination of the Company.

- 7.1.1. The Company shall be dissolved, its assets shall be disposed of, and its affairs wound up on the first to occur of the following:
- (i) a determination by the Member that the Company should be so dissolved;
 - (ii) the occurrence of a mandatory event of dissolution under applicable

law;

- (iii) the termination of the Member's existence: or
- (iv) at such earlier time as may be required by applicable law.
- 7.1.2. In settling accounts of the Company after dissolution, the liabilities of the Company shall be entitled to payment in the following order, all as required by the Act:
- (i) liabilities to creditors, in the order of priority as provided by law, except liabilities to the Member of the Company on account of its contributions;

- (ii) liabilities to the Member of the Company in respect of its share of the profits and other compensation by way of income on its contributions; and
- (iii) liabilities to the Member of the Company in respect of its contributions to capital.

ARTICLE VIII

Indemnification

Section 8.1. Liability and Indemnification of the Member and Authorized Persons.

- 8.1.1. No Authorized Person shall be liable, responsible or accountable, in damages or otherwise, to the Member for any act performed by it within the scope of the authority conferred on it by this Memorandum, except for acts of fraud, willful misconduct or gross negligence.
- 8.1.2. The Member and each Authorized Person shall be entitled to indemnity from the Company for any act performed by it in good faith and within the scope of the authority conferred on it by or pursuant to this Memorandum, except for acts of fraud, willful misconduct or gross negligence and for damages arising from any material misrepresentation herein or material breach of warranty herein.
- 8.1.3. Any indemnity under this Section 8.1 shall be provided out of and to the extent of Company assets only, and the Member shall not have any personal liability on account thereof beyond its Capital Contribution.
- 8.1.4. The Company may purchase and maintain insurance for its benefit, the benefit of the Member or any Authorized Person who is entitled to indemnification under this Section or both, against any liability asserted against or incurred by the Member or Authorized Person in any capacity or arising out of the Member's or such Authorized Person's service with the Company, whether or not the Company would have the power to indemnify such individual against such liability.

ARTICLE IX

Miscellaneous

- **Section 9.1. Effect of Memorandum.** This Memorandum is intended to be the Operating Memorandum of the Company within the meaning of Section 4A-402 of the Act.
- **Section 9.2.** Governing Law. This Memorandum and the rights of the parties hereunder will be governed by, interpreted and enforced in accordance with, the laws of the State of Maryland.
- **Section 9.3. Binding Effect.** Subject to the provisions of this Memorandum relating to transferability, this Memorandum will be binding upon and inure to the benefit of the Member and its respective distributees, heirs, successors and assigns.

- Section 9.4. Terms. Common nouns and pronouns will be deemed to refer to the masculine, feminine, neuter, singular, and plural, as the identity of the Person may in the context require.
- Section 9.5. Headings. All headings herein are inserted only for convenience and ease of reference and in no way define, limit or describe the scope of this Memorandum or the intent of the provisions thereof and are not to be considered in the construction or interpretation of any provision of this Memorandum.
- **Section 9.6. Severability.** If any provision of this Memorandum is held to be illegal, invalid, or unenforceable under the present or future laws effective during the term of this Memorandum, such provision will be fully severable; this Memorandum will be construed and enforced as if such illegal, invalid, or unenforceable provision had never comprised a part of this Memorandum, but with due regard to the intent of the Member, and the remaining provisions of this Memorandum will remain in full force and effect and will not be affected by the illegal, invalid, or unenforceable provision or by its severance from this Memorandum.
- **Section 9.7. No Third Party Beneficiary.** This Memorandum is made solely and specifically by and for the benefit of the party hereto, and its respective successors and assigns subject to the express provisions hereof relating to successors and assigns, and no other Person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Memorandum as a third party beneficiary or otherwise.
- **Section 9.8.** Amendments. This Memorandum may not be amended except by written amendment signed by the Member.
- **Section 9.9. Title to Company Property.** Legal title to all property of the Company will be held and conveyed in the name of the Company.

I write to add my strong support for this Board to grant a Class BD7 license to the historic Parkway Theater, which re-opened its doors in April of this year with great fanfare and well-deserved acclaim. I am proud to have supported the reinvigoration of the Parkway Theater, which helped to return this unique asset to the citizens of Baltimore and I am just as proud to support the Parkway on the journey to receive this license.

As you may know, the State of Maryland is an important partner in the Parkway Theatre, most notably in the form of historic tax credits that played a significant role in the overall economic feasibility of the redevelopment project. As such, the State has a vested interest in the Parkway's success, which hinges primarily on delivering patrons an exceptional movie-going experience in every respect – including a menu of food and drink options that incorporates alcoholic beverages. This is a customary amenity in the world of theater as the Landmark, Charles and Senator Theaters, as well as the new CineBistro in Hampden, all serve alcoholic beverages accordingly.

For this reason, I was pleased to support legislation in the 2017 session to permit the establishment of a Class BD7 license for the Parkway Theatre. In the interest of clarity, I note that the law refers geographically to "[t]he 100 block of North Avenue in the 45th alcoholic beverages district". My intent and the intent of my colleagues was to treat this reference as a "unit block", i.e., 0-100 North Avenue, with application intended specifically and solely to the Parkway Theatre. We are most willing to clarify this as necessary in any future legislative session.
