(d) **Qualified Voters:** Man Fai Lau, Han Fang Lim, and Naomi Gordan are qualified Baltimore City voters.

(e) **Zoning:** Applicants have applied for a USE permit, for the continued use of property as a patented medicine, and prepackaged goods and liquor.

(f) **Corporate Standing:** Yangs, LLC is a MD LLC and as of 6/14/2017 is active and in good standing.

(g) **Posting Report:** The location was posted on 6/1/2017, and checked on 6/12/2017. This meets the 10-day rule. There are 13 licensed liquor establishments in the 4x4 area: "A" BW-1; "D" BW – 1; "A" BWL-4; "B" BWL-1; "D" BWL-2; and "BD7" BWL-4.

(h) **Timeline:** Last inspection by BLLC was performed 6/7/17. At that time, the establishment was open and operating.

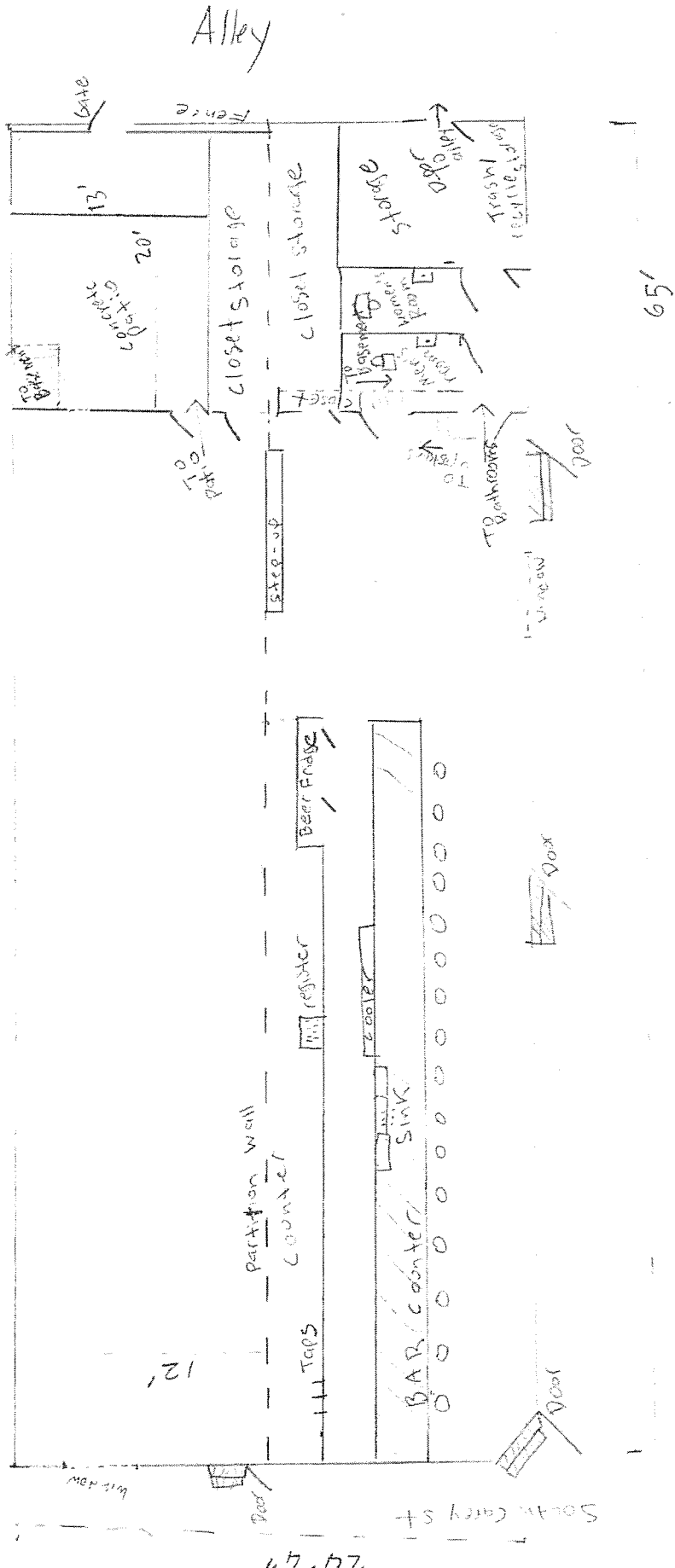

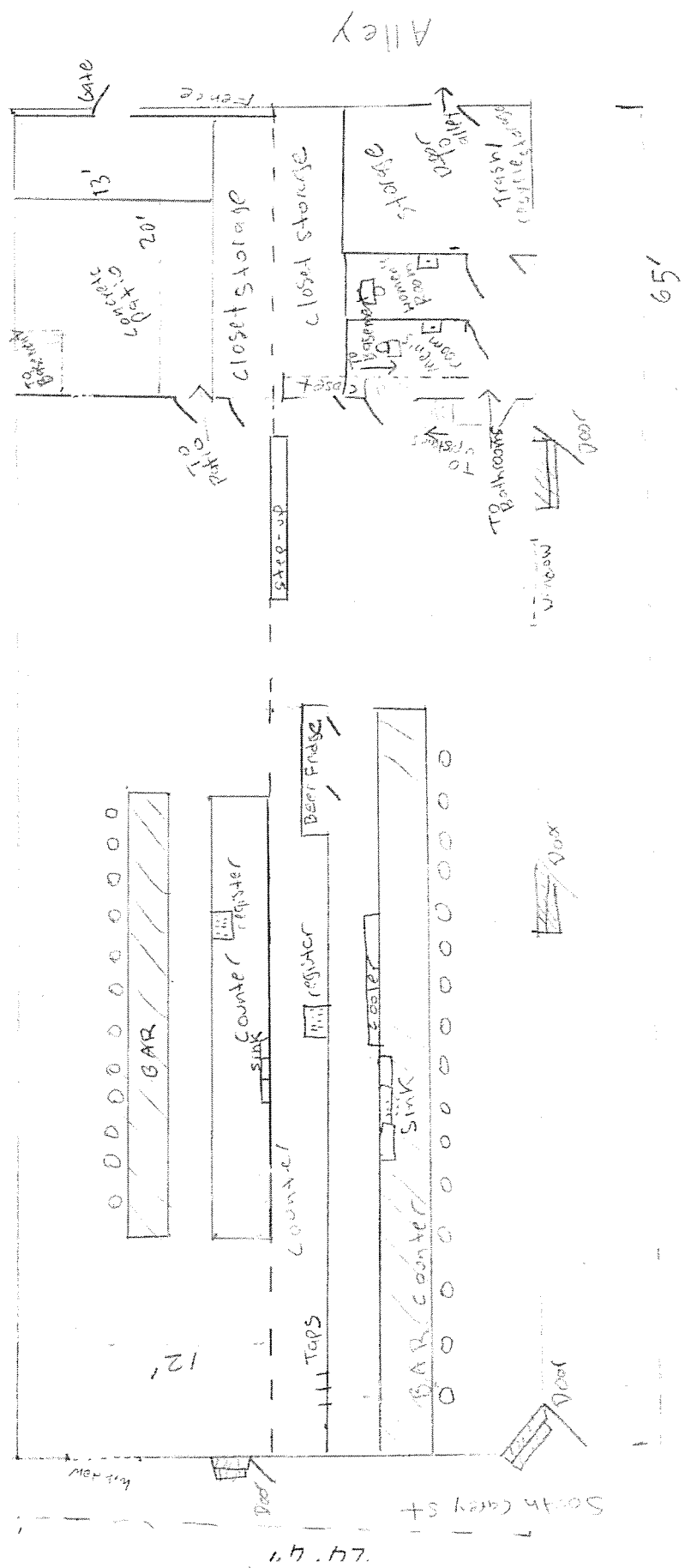
