FOR the purpose of authorizing the holder of a certain alcoholic beverages license in Baltimore City or another appropriate interested party to make a written request to the Board of License Commissioners for Baltimore City to extend the time authorized for the transfer of the license due to hardship; authorizing the Board to grant a certain time extension for the transfer of a certain license if the Board makes a certain finding after a hearing; limiting the time period of a certain extension approved by the Board; and generally relating to the transfer of alcoholic beverages licenses in Baltimore City.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article - Alcoholic Beverages

12 - 102.

This title applies only in Baltimore City.

12 - 1705.

(A) [A] EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A transfer of a license shall be completed on or before 180 days after the Board approves the transfer.

- (B) (1) WITHIN 180 DAYS AFTER THE BOARD APPROVES THE TRANSFER OF A LICENSE, THE LICENSE HOLDER OR ANOTHER APPROPRIATE INTERESTED PARTY MAY MAKE A WRITTEN REQUEST TO THE BOARD TO EXTEND THE TIME AUTHORIZED TO COMPLETE THE TRANSFER DUE TO HARDSHIP.
- (2) THE BOARD MAY GRANT THE EXTENSION IF THE BOARD FINDS AFTER A HEARING THAT AN EXISTING HARDSHIP CAUSED THE DELAY IN TRANSFERRING THE LICENSE.
- (3) AN EXTENSION MAY NOT PROLONG THE PERIOD AUTHORIZED TO COMPLETE THE TRANSFER BEYOND 360 270 DAYS AFTER THE BOARD APPROVES THE TRANSFER.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2017.

l represent The Sobo Taco Spot, LLC. On October 5, 2016 The Sobo Taco Spot, LLC filed an Application to expand the Licensed Premises to include 1118 S. Charles St, Unit 101, Baltimore, MD 21230. On the same Application, The Sobo Taco Spot, LLC also requested to transfer a 50% ownership interest to Andrew Dunlap and to add Andrew Dunlap as Licensee and remove Bruce Richardson as Licensee. As such, the October 5, 2016 Application contained both a "transfer of a license" that is required to be completed within 180 days pursuant to Alcoholic Beverages Article ("AB") §12-1705(a) and an expansion of the licensed premises that is not a "transfer of a license" and therefore, not subject to the requirement of AB §12-1705(a) that a "transfer of a license shall be completed within 180 days after the Board approves the transfer."

In any event, the expansion project is fully under way, but final inspection and obtaining a use and occupancy permit are not expected to occur until September 1, 2017. Since The Sobo Taco Spot, LLC continues to own the liquor license and operate the licensed premises, there is no impediment to completing the transfer of the licensees on the liquor license on behalf of The Sobo Taco Spot, LLC from Michael White and Bruce Richardson to Michael White and Andrew Dunlap. I had previously requested that the Liquor Board complete the transfer portion of the dual request (expansion and transfer) and had initially filed the 2017 Renewal Application in the new Licensees' names, but was told that both the transfer and expansion had to be done simultaneously (and the Renewal Application was amended to reflect the pre-application licensees), which position was again recently reiterated by you.

On behalf of my clients, I make the following request (for which a one day window exists): That pursuant to AB §12-1705(b)(MD Laws Ch. 465, effective July 1, 2017) the Licensees/Applicants request and additional 90 days to complete the transfer due to hardship- in that although Licensees have acted with due diligence, the construction process has exceeded 180 days. Having made this request, it is still my position that the expansion portion of the Application is not a "transfer of a license," but to the extent that the Liquor Board considers the expansion to be a part of or inseparable from the transfer, then such hardship request is made. Should the Liquor Board find it appropriate to deny the hardship request, the Licensees would request that only the transfer be denied and that the expansion request remain viable.

AN ACT concerning

Alcoholic Beverages – Baltimore City – Transfer of License – Hardship Extension

FOR the purpose of authorizing the holder of a certain alcoholic beverages license in Baltimore City or another appropriate interested party to make a written request to the Board of License Commissioners for Baltimore City to extend the time authorized for the transfer of the license due to hardship; authorizing the Board to grant a certain time extension for the transfer of a certain license if the Board makes a certain finding after a hearing; limiting the time period of a certain extension approved by the Board; and generally relating to the transfer of alcoholic beverages licenses in Baltimore City.

- (3) An extension may not prolong the period authorized to complete the transfer beyond $\frac{360}{270}$ days after the Board approves the transfer.
