II. Violations:

1. Eduardo Reyes, Sole Proprietorship, T/a El Rancho Blanco, 100 S. Fagley Street – Class “BD7” Beer, Wine & Liquor License – **Violation of Rule 3.09(b) Rest Room Facilities and Health Regulations – April 21, 2017** – At approximately 9:25 PM, the Social Club Task Force, which consisted of the Police Department, Health Department, and the BLLC conducted a routine inspection of this establishment. During the inspection, Ms. Jessica Speaker of the Health Department observed the following health code violations: rat droppings along and behind the bar and standing water in the basement. Due to these violations the establishment was closed until a further health inspection could be performed to ensure compliance.
2. ~~Shailja Anand, 5302 Frankford, LLC, T/a Tusker Lounge, 5302 Frankford Avenue – Class “BD7” Beer, Wine & Liquor License – **Violation of Rule 4.20(c)(ii) Class BD7 Licensees: Open and Operating Tavern at all Times – April 26, 2017** – At approximately 10:45 PM, members of the Baltimore City Police Department’s Vice Unit and members of the BLLC’s Inspection Division conducted an undercover investigation of this establishment to determine if staff would grant access to the tavern portion of the licensed premises to patrons. At this time, Det. Akinwande entered the establishment in an undercover capacity and attempted to gain access to the tavern portion of the premise. Mr. Lalit Mohan, who was the attendant present at the location, told~~

Akinwande "No" indication that the rear bar area was closed to customers when the detective requested entry to the tavern portion of the premise. Akinwande exited the establishment and informed members of the Vice Unit and BLLC inspection division of the violation. Members from each team entered the establishment and informed Mr. Mohan, the manager on location, of the violation of Rule 4.20(c)(ii). **POSTPONED**

3. **Walid Farousi and Mike Jissri, Walfar, Inc., T/a J & J Bar & Liquors, 1801 Ramsay Street – Class "BD7" Beer, Wine & Liquor License – Violation of Rule 4.20(c)(ii) Class BD7 Licensees: Open and Operating at all Times – March 30, 2017** – At approximately 10:00 PM, members of the Baltimore City Police Department's Vice Unit and members of the BLLC's Inspection Division conducted an undercover investigation of this establishment to determine if staff would grant access to the tavern portion of the licensed premises to patrons. At this time, Det. Garrett entered the establishment in an undercover capacity and attempted to gain access to the tavern portion of the premise. Mr. Donald Nelson, who was the attendant present at the location, told Garrett "No" indicating that the rear bar area was closed to customers when the detective request entry to the tavern portion of the premise. Garrett left the establishment and informed members of the Vice Unit and BLLC inspection division of the violation. Members from each team entered the establishment at approximately 10:15 PM and informed Mr. Nelson, the manager on location, of the violation of Rule 4.20(c)(ii).

- ~~4. **Jae Ran Chong and Soo Il Kim, JC Star, LLC, T/a Red Fox Liquors, 2733 35 Pennsylvania Avenue – Class "BD7" Beer, Wine & Liquor License – Violation of Alc. Bev. Art. § 6-313(a)(2) Tampering with alcoholic beverage container – June 5, 2017** – At approximately 12:13 PM, investigators Mangold and Southworth from the Maryland State Comptroller's Office conducted a routine inspection of the establishment. While conducting his inspection, inspector Southworth observed that the alcohol displayed on the tavern side of the establishment was discolored. Inspectors then compared similar bottles of alcohol that were on display with those that were for sale on the package goods portion of the establishment and noticed that the displayed alcohol was lighter in color than the unopened bottles of the same brand. Inspector Mangold also noticed a 1.75 liter bottle of Seagram's Gin had a very faint odor of alcohol. Based on their observations, inspectors confiscated 17 bottles of alcohol to be submitted to the Controller's Laboratory for chemical analysis to determine the actual percentage of alcohol within each bottle. On June 7, 2017 a report from an analyst within the Comptroller's laboratory found that of the 17 bottles tested, four (4) had been tampered with. **POSTPONED**~~
