Alleged violation of Rule 4.16 (Illegal Conduct) when at approximately 7:00 p.m. on January 17, 2021 members of the BLLC arrived on the premises. Upon entering, the inspector observed three (3) patrons standing at the bar with open beers in front of them watching a football game, two with open bottles, the third had an open 32oz container with no lid. The inspector informed the manager of Mayor Scott's Executive order issued on December 12, 2020, which forbade consumption of food or beverages on premises. The manager mentioned the patrons were waiting on food, however the inspector informed the manager that patrons were prohibited from having open containers while they waited. The patrons then exited the establishment without food.

Alleged violation of Rule 3.12 (General Welfare) when at approximately 7:00 p.m. on January 17, 2021 members of the BLLC arrived on the premises. Upon entering, the inspector observed three (3) patrons standing at the bar with open beers in front of them watching a football game, two with open bottles, the third had an open 32oz container with no lid. The inspector informed the manager of Mayor Scott's Executive order issued on December 12, 2020, which forbade consumption of food or beverages on premises. The manager mentioned the patrons were waiting on food, however the inspector informed the manager that patrons were prohibited from having open containers while they waited. The patrons then exited the establishment without food.

The inspector observed the fire marshal rated capacity for the 2nd floor and determined that 25% would allow for 38 persons total, per Mayor Scott's Executive Order. The inspectors informed the manager of the violation of the Mayor's Executive Order and that he was to close immediately.
