2025 BLLC License Renewal

Every year license holders are required to submit a renewal application in order to continue operating for the new license year. The renewal period is from March 1 – March 31. New licenses are issued for the license year which starts on May 1 and ends April 30 of each year. Renewal letters, 2025 Renewal Applications, a Frequently Asked Questions (FAQ) Sheet, and additional renewal information, have been sent out to all alcoholic beverages licensees.
