### Office Remains Closed to General Public

Currently, the BLLC requests that all applications, correspondence, and related materials be **mailed in to the office at 1 North Charles St., Suite 1500, Baltimore, MD, 21201**. Phone lines will remain open from 8:30am to 4:30pm each day, though no one will be available in person at the offices. **A new drop box is available for documents, please click here for more information.**

### COVID-19 Restrictions

On August 6, 2021, the BLLC released guidance for Baltimore City's licensed establishments concerning the Baltimore City Health Department's updated Order as it establishes an indoor mask mandate. Aside from the masking requirement, both Governor Hogan and Mayor Scott have lifted nearly all other COVID-19 restrictions. Normal operations have now resumed, and licensees should be aware of any efforts they must make to be current with licensing and permits.

## Special Sunday Licenses

As authorized by the Alcoholic Beverages Article 12-2003(a)(1)(ii) and 12-2004(a)(1)(ii), the holder(s) of a Class "A" Beer & Wine License or a Class "A" Beer, Wine & Liquor License may request a Special Sunday License which allows the license holder(s) to remain open the Sundays that fall between Thanksgiving Day and New Year's Day. The establishment may be open between the hours of 1:00 p.m. and 9:00 p.m. only. Establishments are required to and should post their Special Sunday License in a conspicuous location. **To view a list of the Special Sunday licensees, please click [here](#).**

## 2022 CIAA Tournament in Baltimore

The BLLC would like to remind the public and our licensees about the upcoming CIAA Tournament. **Liquor license holders** that would like to host a **related event with 75 or more people, OR, would like to partner with or have a promoter host a related event with 75 or more people** for the CIAA Tournament between the dates of Event to be held *between February 14, 2022 to February 27, 2022*, **must** follow the Rules and Regulations and use the CIAA Related Event Promoter's Permit Application below and in the Application Process section of our website:
