**COUNCIL PRESIDENT NICK J. MOSBY APPOINTS GRANVILLE TEMPLETON III, ESQ. TO THE
BOARD OF LIQUOR LICENSE COMMISSIONERS FOR BALTIMORE CITY**

Baltimore, MD – Council President Nick J. Mosby appointed Granville Templeton III, Esq., to the Board of Liquor License Commissioners of Baltimore City (Board), to serve a two-year term. Mr. Templeton was administered the oath of office on Wednesday, July 12, by Clerk of the Court Xavier A. Conaway. Per law, the appointment will be considered by the Senate of Maryland for its advice and consent, next session.

Mr. Templeton currently manages his own firm, Templeton Law, in Baltimore City where he focuses on business, general counsel representation, tort litigation, contract, and business consulting. He was also the CEO and Co-founder of 1sqbox, LLC, which created educational technology software. Mr. Templeton has served the community in a variety of capacities: as Chairman of the Board of Project Pneuma, a past President of the Board of the Monumental City Bar Association, and he has been featured on several news outlets as a legal expert.

Chairman Albert J. Matricciani, Jr., stated that “We thank President Mosby for his appointment of Mr. Templeton to the Board. We look forward to his contributions to the agency.” Matricciani added, “As an attorney with nearly two decades of experience, we expect Granville’s background will allow him to quickly understand the role of the Board, and that he will seamlessly begin work on behalf of all stakeholders.”

Commissioner Templeton stated, “I thank Council President Mosby for the honor of being appointed to the Board. I look forward to working with the Chair and other commissioners, and for the opportunity to serve the citizens of Baltimore in this new capacity.”

Commissioner Templeton is expected to sit alongside his new colleagues at the next scheduled hearing date of the Board on Thursday July 20, 2023 in the Board of Estimates room in City Hall.
