The manager shrugged again and asked what the inspectors wanted him to do about it. The manager was informed that the inspectors would not be leaving until he complied with their orders. The manager instructed the DJ to announce that there was to be no smoking inside the establishment and instructed security to enforce it.

Alleged violation of AB Rule 4.16 (Illegal Conduct – No Patrons Under the Age of 21) when at approximately 10:00 p.m. on February 2, 2024 members of the BLLC joined the Social Club Task Force consisting of staff from the Baltimore City Fire and Baltimore City Housing Departments as they conducted fire permit checks on the 400 block of East Baltimore Street. The inspector entered the establishment to assist with Fire Marshal with their inspection but exited the establishment shortly thereafter to wait for the Fire Marshall to complete their inspection. The inspector observed a group of 5 females approach the door and observed security checking identification of the group. The

inspector observed one individual hand the bouncer what appeared to be a vertical ID indicating that the individual is under 21 years of age. The inspectors also overheard security informing the group that they would let them enter after the Task Force left and that there was a \$20 cover charge to enter, one individual in the group mentioned that they had "\$100 in Cash App". When the Task Force completed their inspection of the establishment, the inspectors remained at the establishment to see if the underage group of females would be permitted to enter the establishment. After approximately 5 minutes, the inspector observed the group being allowed inside. The inspectors then proceeded back into the establishment and identified the group of presumed underage patrons sitting on the side benches against the wall facing the stage and bar. The inspector asked to see their ID and upon inspection it was observed that three of the five individuals were under the age of 21. The inspectors made contact with the manager and informed them that the establishment would be receiving a violation.

Alleged violation of AE Rule 3.05(a) (Incorporation of Liquor License Rules and Regulations to Applicable Licensees) when at approximately 10:00 p.m. on February 2, 2024 members of the BLLC joined the Social Club Task Force consisting of staff from the Baltimore City Fire and Baltimore City Housing Departments as they conducted fire permit checks on the 400 block of East Baltimore Street. Disposition: The Board has found that the licensee violated Rule AB Rule 3.12, AB Rule 3.02, AE Rule 3.10(a), AE Rule 3.05(a) on January 26, 2024 and AB Rule 4.16, and AE Rule 3.05(a) on February 2, 2024 and imposed the administrative fee of \$125, payable within 30 days. The Board voted to suspend the licenses for 3 days, commencing immediately.
