Baltimore St. LLC T/a Club 2300 – Class “BD7” Beer, Wine & Liquor - Violation of Rule 3.08 (a) Sanitation and Safety – March 10, 2016 – At approximately 4:45 pm BLLC Inspector Darryl Clark conducted an investigation into the establishment based on a 311 complaint received about the establishment. Upon arrival at the location Inspector Clark**

noticed excessive trash in the back of the establishment. Inspector Clark took photos of the trash. While at the location Inspector Clark verified that the 311 complaint was unfounded. However, Inspector Clark did inform the licensee that he would be issuing a violation to the establishment as this was the second observation of trash at this location in less than a month.
