Alleged violation of Rule 4.05(b) (Prohibited Hours: § 12-2004(a)(1)(ii) permits licensee to operate 1:00 pm – 9:00 pm on Sundays under certain circumstances) when at approximately 10:58 p.m. on December 31, 2023 members of the BLLC investigated a complaint alleging that this establishment was operating outside the scope of their special Sunday license that allows for the business to sell alcohol on Sundays from 1:00 p.m. to 9:00 p.m. between Thanksgiving Day and New Years Day if the license holder has paid a supplementary fee. The inspector arrived at the establishment and observed that the store had several patrons exiting the establishment with alcoholic beverages they had just purchased. Upon entering the establishment, the inspector also observed approximately 4 patrons inside with one of the patrons in the process of purchasing alcohol. The inspector

instructed the manager to stop all sales immediately and informed them that they were operating well beyond the mandated closing time of their special Sunday license and would be issued a violation.
