

Background

This matter comes before the Baltimore City Board of Municipal & Zoning Appeals ("Board") on appeal from the Zoning Administrator for Baltimore City denying the application of September Trees, LLC ("Appellant") to use the first floor of 3100 E. Appellant filed this appeal to the Board on February 22, 2022 and appeared for a public hearing on April 5, 2022. Board staff prepared a memorandum evaluating the appeal. The Department of Planning did not comment on this appeal. Following deliberations and for the reasons set forth below, the Board voted to approve Appellant's request by unanimous vote to use the first floor of the Property as a restaurant under the provisions of the neighborhood commercial establishment section of the Code.

Facts

The Property is located in an R-8 Zoning District and is a rectangular corner lot comprising 1,125 square feet of land area; it is improved with a c. 1920 two-story mixed use brick attached building with 1,890 square feet of floor area. The last authorized use of the premises is as a dry cleaner on the first floor, with one dwelling unit on the upper floor. According to city records, the Property has a decades-long history of commercial uses on the first floor, including a laundromat, a television and electronic equipment shop, and a convenience store.

Mr. Patrick Lundberg and Mr. Randall Matthews testified in support of the appeal, on behalf of Appellant. Mr. Lundberg, a consultant for the project, testified that the Property has historically been used for commercial purposes over the years and was most recently used as a grocery store. Mr. Matthews, the prospective chef and owner of the proposed restaurant, plans to use the Property as a charcuterie restaurant, with a possible breakfast option, but did not provide further details about the proposed menu or hours of operation, since he is still deciding on his business's concept. Several community members submitted letters of support and testified in support of the business; they argued that the proposed use will help to revitalize the corridor and contribute to positive development in the neighborhood.

Several community members testified in opposition to the appeal. Neighbors expressed concern that the restaurant use would impact the viability of an existing coffee bar and breakfast restaurant located across Baltimore Street from the Property, on the opposite corner. Community members expressed frustration that the owner of the proposed restaurant had not provided details about the hours of operation and the concept of the business and how it would serve the community; they requested that the Appellant postpone the hearing until they have provided more

information to the wider community about their plans. Mr. Matthews declined to postpone the case.

Standard of Review

City Code Article 32, § 1-310 (j) defines neighborhood commercial establishment as a non-residential use that is within a residential or office-residential zoning district, but in a structure that: (1) is non-residential in its construction and original use; or (2) has received prior zoning approval for a non-residential use, as evidenced by permits, construction, or historical evidence of lawful non-residential use.

If a property qualifies for the neighborhood commercial establishment use, the appeal is then evaluated as a conditional use. Under the conditional use approval standards found in City Code Art. 32 § 5-406(a), the Board of Municipal and Zoning Appeals may [not] approve a conditional use unless, after public notice and hearing and on consideration of the standards required by this subtitle, it finds that: (1) the establishment, location, construction, maintenance, or operation of the conditional use would not be detrimental to or endanger the public health, safety, or welfare; (2) the use would not be precluded by any other law, including an applicable Urban Renewal Plan; (3) the authorization would not be contrary to the public interest; and (4) the authorization would be in harmony with the purpose and intent of this Code.

In making its determination, under City Code Art. 32 § 5-406(b), the Board must consider the following factors, where appropriate: (1) the nature of the proposed site, including its size and shape and the proposed size, shape, and arrangement of structures; (2) the resulting traffic patterns and adequacy of proposed off-street parking and loading; (3) the nature of the surrounding area and the extent to which the proposed use might impair its present and future development; (4) the proximity of dwellings, churches, schools, public structures, and other places of public gathering; (5) accessibility of the premises for emergency vehicles; (6) accessibility of light and air to the premises and to the property in the vicinity; (7) the type and location of adequate utilities, access roads, drainage, and other necessary facilities that have been or will be provided; (8) the preservation of cultural and historic landmarks and structures; (9) the character of the neighborhood; (10) the provisions of the City's Comprehensive Master Plan; (11) the provisions of any applicable Urban Renewal Plan; (12) all applicable standards and requirements of this Code; (13) the intent and purpose of this Code; and (14) any other matters considered to be in the interest of the general welfare.

Conditional uses are "presumed valid uses" of land but this presumption may be rebutted by credible evidence indicating that "the proposed use has adverse effects above and beyond those inherently associated with such a [conditional use] irrespective of its location within the zone." Schultz v. Pritts, 291 Md. 1, 22-23 (1981). See also Attar v. DMS Tollgate, LLC, 451 Md. 272, 286-287 (2017).

Discussion

After a thorough review of the file, evidence and testimony submitted in support of this application, the Board evaluated this application under the conditional use standards found in City Code Article 32 and Maryland law.

Neighborhood Commercial Establishment: The Board found, by competent evidence that the Property has historically been used, on its first floor, for commercial purposes over many decades. The land use cards on file with the city show that the Property has been used as a laundromat, a grocery store, a television and radio repair and sales shop, a convenience store, and a dry cleaner. Because of these historic non-residential uses, the Property qualifies to be considered

for the neighborhood commercial establishment use, under the conditional use approval standards in the Code.

Conditional Use: The Board then considered the proposed restaurant use under the conditional use approval standards. The Board found that the establishment, location, construction, maintenance, or operation of the conditional use would not be detrimental to or endanger the public health, safety, or welfare, that it would not be precluded by any other law, including an applicable Urban Renewal Plan, that it would not be contrary to the public interest, and that it would be in harmony with the purpose and intent of this Code. The community opposition to the proposed use mainly sought to protect a similar nearby business; neighbors also expressed frustration that the Appellant had not provided enough detail about his business plan to community members. However, assuming the truth of all of the statements presented by opponents, there was no evidence presented to show that the proposed use would be detrimental to the public health, safety or welfare or that it would be contrary to the public interest.

In its determination, the Board considered the factors set out in City Code Art. 32 § 5-406(b). The Board found that the proposed site is an appropriate location for a restaurant in its size, shape, and structure. There was no evidence to show that the use would impact traffic patterns and off-street parking and loading. Opponents of the use argued that the neighborhood could not support two similar restaurant concepts, which might impair present and future development; the Board did not find this argument compelling enough to deny the use. The Board also found that the proposed use would not be harmful to nearby dwellings and other places of public gathering. There was no evidence to show that there would be any issues around accessibility of the premises for emergency vehicles or adequate utilities, roads, drainage or other public facilities. Appellant did not propose any changes to the physical structure of the building, so there were no proposed effects to the accessibility of light and air to surrounding properties. There was no evidence presented regarding any potential harm to the preservation of cultural and historic landmarks and structures or to the character of the neighborhood. Finally, there was no evidence presented to show that the use would be contrary to the provisions of the City's Comprehensive Master Plan, the provisions of any applicable Urban Renewal Plan, or any other standards and requirements of the City Code.

Under the Schultz v. Pritts standard, conditional uses are presumed to be valid. However, the Board may deny a conditional use when there is evidence presented that the proposed use would have adverse effects above and beyond those inherently associated with the use, irrespective of its location within the zone. In this matter, the opponents of the proposed restaurant use did not present any evidence of any adverse effects to the neighborhood, except for a negative effect on the profitability of a nearby business. The Board found, however, that a potential negative effect on existing restaurant profitability is inherently associated with any new restaurant use. The Board found that this potential harm was too speculative for the Board to deny the use in this case.

Conclusion

RESOLVED, that the Board finds sufficient evidence in the record to support the application of the Appellant to use the first floor as a restaurant under the provisions of the neighborhood commercial establishment section of the Code; and it is further,

RESOLVED, that Appeal No. 2022-129 is GRANTED.





§ 12-1603. New licenses prohibited in the 40th, 41st, 43rd, 44th, and 45th alcoholic beverages districts

- (a) Alcoholic beverages districts coterminous with legislative districts. -- The alcoholic beverages districts described in this section at all times are coterminous with the legislative districts in the Legislative Districting Plan of 2012.
- **(b) Issuance of licenses prohibited. --** Except as provided in subsection (c) of this section, the Board may not issue a new license in:
- (1) the 40th alcoholic beverages district;
- (2) the 41st alcoholic beverages district;
- (3) the 43rd alcoholic beverages district;
- (4) the 44th alcoholic beverages district; and
- (5) the 45th alcoholic beverages district.
- (c) Licenses allowed. -- The Board may issue:
- (1) in the alcoholic beverages districts specified in subsection (b) of this section:
- (i) a 1-day license; or
- (ii) a Class B beer, wine, and liquor license to a restaurant that:
- **1.** has a minimum capital investment, not including the cost of land and buildings, of \$ 200,000 for restaurant facilities; and
- 2. has a minimum seating capacity of 75 individuals;
- (2) a Class C beer, wine, and liquor license in the 45th alcoholic beverages district;
- (3) a Class C beer, wine, and liquor license in ward 5, precinct 1 of the 44th alcoholic beverages district;

- (4) a Class C beer, wine, and liquor license in the 200 block of West Saratoga Street in ward 4, precinct 3 of the 40th alcoholic beverages district;
- (5) If the applicant executes a memorandum of understanding with the Charles North Community Association, a Class C beer, wine, and liquor license to a club in the area bounded by North Charles Street on the west, East Lafayette Avenue on the north, North Lovegrove Street on the east, and East Lanvale Street on the south in the 45th alcoholic beverages district;
- (6) a Class B-D-7 license in the unit block of West North Avenue in the 45th alcoholic beverages district;
- (7) two Class B-D-7 licenses in the 2100 block of North Charles Street in the 43rd alcoholic beverages district;
- (8) two Class B-D-7 licenses in the 2100 block of Maryland Avenue in the 43rd alcoholic beverages district;
- (9) subject to the requirements under subsection (e) of this section, four Class B-D-7 licenses in the 43rd alcoholic beverages district;
- (10) a Class B-D-7 license in the 5400 block of Harford Road the in 45th alcoholic beverages district if:
- (i) average daily receipts from the sale of food are at least 65% of the applicant's total daily receipts;
- (ii) the applicant executes a memorandum of understanding with a community association;
- (iii) the applicant does not create a separate package goods department;
- (iv) alcoholic beverages are served to patrons seated at tables; and
- (v) alcoholic beverages are served only with meals to patrons provided with outdoor table service;
- (11) a Class B-D-7 license in the 4800 block of Harford Road in the 45th alcoholic beverages district if:
- (i) average daily receipts from the sale of food are at least 65% of the applicant's total daily receipts;
- (ii) the applicant executes a memorandum of understanding with a community association;
- (iii) the applicant does not create a separate package goods department;
- (iv) alcoholic beverages are served to patrons seated at tables; and
- (v) alcoholic beverages are served only with meals to patrons provided with outdoor table service;
- (12) a Class B-D-7 license on the eastern side of the 400 block of North Howard Street in the 40th alcoholic beverages district if:
- (i) the applicant does not convert the license to a different license class;
- (ii) alcoholic beverages are served outdoors only to patrons seated at tables or standing in a courtyard area;
- (iii) the applicant does not allow the off-premises sale of alcoholic beverages;
- (iv) alcoholic beverages sales begin no earlier than 10 a.m.; and
- (v) the applicant executes memorandums of understanding with the Downtown Partnership of Baltimore and the Market Center Merchants Association; and
- (13) if the applicant executes a memorandum of understanding with the Bolton Hill Community
 Association, a Class C beer, wine, and liquor license in the 1200 block of Eutaw Place in the 40th alcoholic beverages district.
- (d) Class B-D-7 license. -- One Class B-D-7 license issued for a property surrounded by Morton Street on the west. West Eager Street on the north, North Charles Street on the east, and West Read Street on

the south may be transferred to a property surrounded by 21st Street on the north, Morton Street on the west, North Charles Street on the east, and 20th Street on the south.

(e) Class B-D-7 license -- Old Goucher Revitalization District. --

- (1) In this subsection, "Old Goucher Revitalization District" means the area surrounded by Howard Street on the west, 25th Street on the north, Hargrove Street on the east, and 21st Street on the south.
- (2) If an establishment has a minimum capital investment, not including land and acquisition costs, of \$ 50,000, the Board may issue one Class B-D-7 license for use in each of the following properties in the Old Goucher Revitalization District:
- (i) a property that is surrounded by Maryland Avenue on the west, 24th Street on the north, Morton Street on the east, and 22nd Street on the south;
- (ii) a property that is surrounded by Morton Street on the west, 23rd Street on the north, Lovegrove Street on the east, and 22nd Street on the south;
- (iii) a property that is surrounded by Morton Street on the west, Ware Street on the north, Charles Street on the east, and 24th Street on the south; and
- (iv) a property that is surrounded by Maryland Avenue on the west, 24th Street on the north, Morton Street on the east, and 23rd Street on the south.
- (3) A Class B-D-7 license that may be issued under subsection (c)(6) or (7) of this section may be transferred within the Old Goucher Revitalization District.

Memorandum of Understanding

THIS MEMORANDUM OF UNDERSTANDING ("Agreement") dated July 1st, 2021, by Baltimore Improv Group, Inc., a Maryland nonprofit corporation whose address is 1727 N. Charles Street, Baltimore, MD 21201 ("Business") and the Charles North Community Association, Inc., a Maryland corporation whose current address is 1714 N. Charles St, Baltimore, MD 21201 ("Community").

RECITALS

- A. Business holds a leasehold interest in 1727 N. Charles Street, Baltimore, MD 21201 ("Property"), which is a commercial property owned by Bowling, Inc., a Maryland corporation ("Landlord")
- B. On the Property, which is zoned Commercial, Business intends to acquire a Class C Liquor License ("License") through special legislation by the Maryland State Legislature ("Legislature") as an accessory to its current theater use.
- C. The Business desires to continue to use the Property as a theater but wishes to be able to serve beer, wine, and liquor on premises to its guests with consent of Landlord and pursuant to a License issued to it by the Legislature.
- D. The Community desires to support Business' application for the License on the condition that the Business agrees to the terms set forth in this Agreement.

WHEREFORE, in consideration of the mutual promises contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. BUSINESS AGREES TO THE FOLLOWING:

- a. RESTRICTED HOURS: Business agrees to restrict its operating times during which alcoholic beverages may be sold at the Property during non-holidays and for when special events are not planned at the Property or in the area of the Property (such as Artscape, Maryland Film Festival, or any other type of community-wide event) at no earlier than 5 p.m. on any such day of operation and no later than 1 a.m. on the following such day.
- b. NOISE: The volume of the Live Entertainment must not exceed the noise volumes set by the Baltimore City Noise Ordinance and the Maryland State Department of the Environment Statute, whichever is lower; during any live performances the doors and windows to the Property and performance areas must be kept closed so as to prevent the noise volume from entering the street or sidewalk adjacent to the Property.
- c. THIRD PARTY USE: Business shall not allow third parties to use the Property, either through a rental agreement or as invited guests acting outside of Business' control, for events such as parties, receptions, or any other type of special event (collectively, "Special Events") during which alcoholic beverages will be served unless a representative of the Business is present during the Special Event and Business enters into a license agreement with any such person or entity who intends to use all or any

- portion of the Property for a Special Event, which license agreement shall incorporate the relevant terms and restrictions of this Agreement.
- d. NUMBER OF PATRONS: Business agrees to abide by occupancy limits as set by Zoning and/or Fire Marshal requirements.
- e. SECURITY: Business shall provide oversight of the Property entrances, sidewalk and alley, during all the hours of operations when alcoholic beverages are to be sold, as required to prohibit patrons from: (1) loitering on either N. Charles Street or E. Lafayette Avenue, (2) disturbing the peace or trespassing onto adjacent properties, and (3) drinking alcoholic beverages on the sidewalk or anywhere else outside the Property. Additionally, Business agrees to (i) As soon as practicable, install and maintain both exterior and interior security cameras at the property, (ii) enhance the current lighting on the Property façade as part of the proposed exterior enhancements to be made in collaboration with Landlord, and (iii) engage adequate professional security personnel to benefit Business' guests and staff entering and exiting the Property for events with such security personnel remaining at Property for no less than one hour after each event concludes at the Property or until all guests and staff have dispersed from the exterior of the Property.
- f. SANITATION: Business shall keep the exterior of the Property free of trash and debris at all times, clean all graffiti from the façade of the Property and keep the sidewalks adjacent to the Property free of ice and snow. Business shall dispose of all trash each day of operation from the Property either using a commercial trash removal company or personally disposing of all trash in compliance with applicable law.
- g. COMMUNICATION: As development plans for the Property progress, Business agrees to communicate with the Community, and provide the opportunity for review of plans for any changes in its operations, performance space operations, exterior signage and lighting, etc.
- h. GOOD NEIGHBORS: Business shall make every effort to be a positive member of the community. Upon receipt of notice of community concerns through the Committee or a designated Community contact person (including but not limited to noise, littering, loitering, etc.), Business or its designees shall make any needed repairs, adjustments, and/or contact the Baltimore City Police Department for assistance.
- i. FLYERING: Business shall not pass out flyers throughout the adjacent neighborhoods promoting the theater and events at the Property.
- 2. COMMUNITY AGREES TO THE FOLLOWING: The Community agrees to support the application by Business to obtain the License at the Property, all subject to the terms of this Agreement.
- 3. ACKNOWLEDGEMENT: Business enters into this Agreement voluntarily, with the knowledge that the terms of this Agreement will become enforceable restrictions on the service of alcoholic beverages at the Property pursuant to an approved License.

- 4. BREACH: Unresolved disputes between the Business and Community will be submitted to the Baltimore City Board of Liquor License Commissioners for a public hearing. Any matter remaining unresolved following such a hearing or failure to abide by decisions reached in such a hearing shall constitute a material breach of this Agreement and may lead to a civil court action for breach of contract.
- 5. REPRESENTATIONS: Business and Community respectively represent and covenant as follows: (1) Each party represents that it is authorized to enter into this Agreement; (2) Each party has the duty to implement this Agreement in good faith; and (c) Each party shall rely on the other party's representations and warranties made in this Agreement.
- 6. GOVERNING LAW: This Agreement shall be governed by, construed, and enforced in accordance with the laws of the State of Maryland and Baltimore City.
- 7. SEVERABILITY AND INDEPENDENT COVENANTS: If any term of this Agreement shall be held by a court of competent jurisdiction to be illegal or unenforceable, the terms shall continue in full force and effect. No term herein shall be deemed dependent upon any other term herein unless so expressed. Nothing in this Agreement shall be construed to require any party to violate any applicable law.
- 8. ASSIGNMENT: No party may assign, transfer, or otherwise dispose of this Agreement to any other person, firm, organization, corporation, governmental body or any other entity, absent the written Agreement of all parties to this Agreement.
- 9. AMENDMENT: This Agreement may be modified or amended if in writing and signed by the parties hereto.
- 10. ENTIRE AGREEMENT: This Agreement constitutes the entire understanding between the parties with respect to this subject matter. This Agreement supersedes all prior agreements, arrangements, and communication between the parties, whether oral or written. This Agreement is intended to be an integrated writing and any prior oral or written agreements between the parties are merged into this Agreement and extinguished.
- 11. SUCCESSORS AND ASSIGNS: The terms of this Agreement shall be binding on all aspects of Business' service of alcoholic beverages at the Property, as well as by any respective successors and/or assigns of Business, if applicable.
- 12. NOTICES: Any notice or other communication required to be provided hereunder shall be in writing and shall be conclusively presumed to have been received three (3) days after depositing into the US Mail, if delivery is by postage paid registered or certified mail, or one (1) day if delivery is by FEDEX or other nationally recognized overnight courier service, or on the same day if hand delivered personally to the signatory below. Any notice in any other manner shall be deemed

given when actually received. Notices shall be addressed to the parties at the addresses provided above.
