- (b) Ownership Breakdown: (1 Protasi Sengayimana (20%); and (2) Maria Ndaikengurulaya (80%).
- (c) **Purchase Price of Business:** The purchase price of the business is \$100,000. Down payment of \$5,000 was made. Remaining balance of \$95,000 to be paid at settlement in increments of \$10,000 via savings, \$30,000 via man & savings and \$60,000 via SBA loan.
- (d) Qualified Voters: Sheila Williams, Krystal Peoples, and Ki Jeong Lee are qualified Baltimore City voters.
- (e) **Zoning**: Applicant has applied for a USE permit, for the use of a portion of the premise 1<sup>st</sup> floor as a package goods store (liquor store) with accessory storage in basement area.
- (f) Corporate Standing: CLB 2101, LLC is a MD LLC and as of 12/27/2022 is active and in good standing.
- (g) **Posting Report**: The location was posted on 11/22/2022 and checked on 12/1/2022. This meets the 10-day rule. There are 3 licensed liquor establishments in the 4x4 area: "A" BWL-1; and "BD7" BWL-2.
- (h) **Timeline**: Last Inspection by BLLC was performed 7/6/2022. At that time, the establishment was open and operating.
- (i) Letters of Support/Opposition: At this time the Board has no letter(s) of opposition or support.
