Charles Lanvale LLC t/a Pen and Quill obtained it's current liquor License # LB025 on March 12, 2010 following a transfer from the previous owner (landlord) Ernst Valery t/a Milk & Honey II. From 2014 until the transfer in 2019, management of Pen and Quill operated the restaurant and license under a management agreement with Milk & Honey II. During the six plus years of time, Pen and Quill had not received any violations nor complaints and Charles Lanvale LLC Pen and Quill has continued to be in good standing with the State of Maryland.

As a direct cause of the Covid 19 Pandemic significantly reduced sales and limited occupancy and closures, it became financially necessary for Charles Lanvale to temporarily cease its daily operations, at the time it was hoped to be temporary with hopes of additional funding either local or national would come thru. On july 3rd the daily restaurant service operation ceased however there were two outstanding future dinners during August so we were committed to remaining "open" for those. Unfortunately, as the Covid 19 restrictions continued, both venues cancelled in August. The landlord was able to get a potential tenant in the space and let us know that we should prepare to vacate the premises if they were successful. We met with the potential tenants when they were still negotiating with the landlord and it was considered and requested that we agree to a management agreement with them since they were unsure as to when they may be able to complete construction and also obtain licensing. We confirm we applied for the renewal of the license in March 2020 however have not received an actual renewal license, Citing the Governors order number 20-06-11-01, we wish to request a 180 day hardship extension. This extension should allow for the tenants to complete their renovations and for us to allow them to work under the management agreement while we prepare and apply for the sale and transfer of the license.
