Thank you for notifying us of the impending expiration of our liquor license due to the closure of Germano's PIATTINI and the Cabaret at Germano's during the pandemic. We have invested our time and money over the last 43 years into what has become a Baltimore restaurant and entertainment institution and we would have continued operating but for the Covid-19 pandemic. We have taken all steps necessary to re-commence operations as soon as it is no longer a public safety hazard to do so. We continue to pay all licenses, taxes and fees, including the liquor license. During the last two years we have suffered the death of our manager, several of our employees contracted Covid-19 and my husband and I are currently in Covid quarantine due to Germano's positive test result. Each time we were poised to re-open, Baltimore experienced a surge of positive cases, with the worst being the present surge of Delta/Omicron cases.

For the foregoing reasons, we respectfully request a hardship extension until such time as the public safety hazard posed by Covid-19 has passed. A check in the amount of \$100 is enclosed for the hardship fee.





Dear Commissioners:

This firm represents South Point of Port Covington, LLC ("South Point"), which operates as a seasonal outdoor event venue with alcoholic beverages sales at the above-referenced property (the "Premises"). For the reasons set forth below, on behalf of South Point, I write to request an extension of the 180-day period for which an inactive license may be considered unexpired.

As explained in the March 2019 hearing when the Board approved the transfer of location and ownership of its Class BD-7 License, South Point operated next the waterfront of West Covington Park in Port Covington as a seasonal venue and intended on expanding its operations on a more permanent basis in 2020. However, South Point halted its bar and event operations because of the COVID-19 pandemic. Because of shifting guidance from the CDC and state & local officials on the ability to operate an event venue, South Point remained closed through 2021 and will not resume active alcoholic beverage business operations prior to December 28, 2021, which is the end of the 180-day period by which operations were required to resume following the termination of Executive Order No. 21-03-09-03. Accordingly, pursuant to Section 12-2202(b)(1), South Point respectfully requests an extension of the period by which active operations must resume to extend the life of the License.

This firm represents Cielo Verde, LLC ("Cielo Verde"), which obtained the Board's approval for the transfer of the ownership of a Class B Beer, Wine & Liquor License (the "License") for continued use at 800 Key Highway (the "Premises") in a hearing held on March 12, 2020. For the reasons set forth below, on behalf of Cielo Verde, I write to request an extension of the 180-day period necessary to complete the transfer of the License.

At the time of the Board's approval of the transfer of the License, Cielo Verde already had the Board's approval to operate the Premises inside the American Visionary Arts Museum (the "AVAM") under a management agreement.
