Staff received a transfer hardship extension request letter on 2/6/2023, which was 179 days after the Board approved the amended transfer. This transfer hardship extension request meets the requirements of Alc. Bev. Art. §12-1705, as it was filed within the 180-day period (on or before February 7, 2023).

This firm represents Market Fresh Gourmet at Poppleton, Inc. ("Market Fresh"), the transferee of the above-referenced Class A Beer and Wine License (the "License"). On behalf of our client, I write to request a 90-day hardship extension of the 180-day period established under MD. CODE ANN., Alcoholic Beverages § 12-1705 to complete the transfer of the License.

On September 23, 2021, the Board approved the transfer of ownership and location of the License to the premises known as 101 N. Schroeder Street, Suite #4 for use by Uncorked@Poppelton ("Uncorked"), an affiliate of Market Fresh. Uncorked proposed to operate a high-end beer and wine shop that would provide an amenity to the adjacent Market Fresh Gourmet grocery store. Following the Board's approval of the License's transfer to Uncorked, it became clear that the beer and wine shop and the grocery needed to operate under the same legal entity to meet certain requirements associated with the project's funding. My client therefore submitted an amended transfer application to transfer the License to Market Fresh. The Board approved the amended application at its August 11, 2022 hearing.

Since the Board's approval, Market Fresh has diligently worked to complete construction of its space in order to finalize the transfer of the License, and anticipates opening for business by spring of 2023. However, construction will not be complete in time for the transfer of the License to be finalized by the February 7, 2023 expiration of the 180-day period set forth under Section 12-1705 of the Alcoholic Beverages Article. Accordingly, on behalf of my client, I respectfully request a 90-day hardship extension pursuant to Md. Code Ann., ALC. BEV. §12-1705.
