We are in the process of selling our restaurant business. We have received a Letter of Intent and the potential buyers are currently having inspections done and obtaining financing. Once they are completed we hope to have a scheduled settlement within 90 days.

We have owned and operated the restaurant since March 2003. The last few years have been quite challenging, primarily with regards to hiring and retaining qualified personnel, both in the kitchen and as well management. Sales for the restaurant have declined. After several changes in chefs, cooks and managers, we temporarily closed the first week of September 2017 in order to do some minor repairs, cleaning and renovations and attempt to hire qualified and long term personnel. This firm represents Broadway Group, LLC and Minh Hoang (collectively, "Broadway Group") in connection with the Class BD7 Beer, Wine & Liquor License they hold as secured creditors at 807 S. Broadway (the "License"). On behalf of our client, I write to request an extension of the 180-day period established under MD. CODE ANN., Alcoholic Beverages § 12-2202(a) to transfer the License once it has ceased operation.

On March 30, 2017, the Board approved the transfer of the License to El Coyote Grill, LLC t/a El Coyote Bar & Grill ("El Coyote"). El Coyote operated pursuant to the License until September 4, 2017, when it vacated the premises without prior notice and before the end of its lease term. This action, as well as other breaches of the lease by El Coyote, resulted in the termination of its lease. El Coyote subsequently surrendered the License to Broadway Group, an entity affiliated with its landlord, Westland Investment Group, LLC, pursuant to the terms of its lease. On November 1, 2017, the License was transferred to Broadway Group as a secured creditor.

Since that time, our client has diligently marketed the property in an effort to lease the premises to a new tenant who could utilize the License at this location. They are currently in negotiations with several potential tenants and are optimistic that these negotiations will result in a lease under which a new tenant will resume operations under the License. However, it is unlikely that these negotiations will conclude prior to the expiration of the 180-day period set forth under MD. CODE ANN., Alcoholic Beverages § 12-2202(a), which will occur on March 3, 2018. We therefore respectfully request a hardship extension under MD. CODE ANN., Alcoholic Beverages § 12-2202(b) so that the License may be extended an additional 180 days.


