SECTION 308 OPEN FLAMES

308.1 General *{As in IFC}*

308.1.1 to 308.1.3 *{As in IFC}*

308.1.4 Open-flame cooking devices. Charcoal burners and other open-flame cooking devices may not be operated on combustible balconies or within 10 feet (3048 mm) of any combustible construction or property line.

Exception: A one- or two-family dwelling whose property lines are less than 10 feet from the structure may use an open-flame cooking device as long as:

1. the device is at least 6 feet from any combustible construction; and
2. the following extinguishing agent is available:
 - a. for an LPG burner, a portable fire extinguisher with at least a 2A-10BC rating; and
 - b. for a charcoal or wood burner, either:
 - i. a water fire extinguisher; or
 - ii. a 5-gallon bucket of water.

308.1.5 to 308.1.8 *{As in IFC}*

308.2 Permit required. *{As in IFC}***308.3 Group A Occupancies. *{As in IFC}*****308.3.1 Open-flame decorative devices. *{As in IFC}*****308.3.2 Theatrical performances. *{As in IFC}***

308.3.3 LP gas prohibited in assembly areas. The storage or use of LP-gas containers of any size in any assembly building or in any assembly area of a building is prohibited.

308.3.3.1 Exception. Listed and approved butane-gas commercial food service appliances may be used inside restaurants and in attended commercial food catering operations as long as each of the following conditions is complied with:

1. No appliance has more than two 10-oz. (296 ml) gas containers, with a maximum water capacity of 1.08 lb. (0.049 kg) per container, connected directly to it at any time.
2. The containers are not manifold.
3. All containers are listed and comply with UL 147B, "Standard for Non-Refillable (Disposable) Type Metal Container Assemblies for Butane".
4. Each container is an integral part of the listed and approved commercial food service appliance and is connected to the appliance without the use of a rubber hose.
5. No more than 24 of these containers are stored in the building, with an additional 24 containers permitted to be stored in another storage area in the building if that other storage area is separated or contained by a minimum 2-hour fire wall.
6. The use of LP gas in assembly areas for theatrical performances is subject to the review, evaluation, and approval of the Fire Code Official for each individual event.

SUBTITLE 2
LICENSE REQUIRED

§ 6-201. In general.**(a) *Operation without license prohibited.***

Except as otherwise provided in this section, no person may operate a food service facility without a license to do so from the Commissioner of Health.

(b) *Exception for certain excluded organizations.*

A food service facility may operate without a license issued by the Commissioner of Health if it:

- (i) is operated by an excluded organization; and
- (ii) has, in accordance with COMAR 10.15.03.26A, elected to operate without a license and in compliance with the minimum food safety requirements of COMAR 10.15.03.26B-E.

(c) *License not transferable.*

A license may not be transferred from place to place or person to person.

(City Code, 1976/83, art. 11, §165(b)(1)(1st sen.) (Ord. 99-548; Ord. 06-185; Ord. 14-308.)

§ 6-202. Applications.**(a) *In general.***

An applicant for a license must:

- (1) submit an application on the form that the Commissioner provides; and
- (2) pay the applicable processing fees.

(b) *Contents.*

In addition to any other information that the Commissioner requires, the application must contain building and installation plans and specifications.

(City Code, 1976/83, art. 11, §165(c)(1st, 2nd, 4th(part) sens.) (Ord. 99-548.)

§ 6-203. Inspection and priority assessment of facility.**(a) *Inspection.***

On receipt of an application, the Commissioner must inspect the food service facility to determine compliance with all applicable laws, rules, and regulations.

(b) Priority assessment.

To determine the degree of risk that a food service facility poses for a food-borne disease occurrence, the Commissioner must assess each food service facility and classify it in one of the following priority assessment categories, as defined in COMAR 10.15.03.33:

(1) high priority facilities, which are at high risk for a food-borne disease occurrence;

(2) moderate priority facilities, which are at moderate risk for a food-borne disease occurrence; and

(3) low priority facilities, which are at low risk for a food-borne disease occurrence.

(City Code, 1976/83, art. 11, §165(a)5, (c)(3rd sen.)) (Ord. 99-548; Ord. 14-308.)

§ 6-204. Issuance of license.

The Commissioner must issue a license to the applicant if:

(1) the requirements of all applicable laws, rules, and regulations have been met; and

(2) the applicant pays the applicable annual fee.

(City Code, 1976/83, art. 11, §165(c)(4th sen.)) (Ord. 99-548.)

§ 6-205. Scope of license.

While a license is in effect, it authorizes the operation of the food service facility in accordance with the approved plans and specifications.

(City Code, 1976/83, art. 11, §165(b)(1)(2nd sen. (last cl.)) (Ord. 99-548; Ord. 06-185.)

§ 6-206. Material alterations.**(a) Permit required.**

No person may materially alter a food service facility (e.g., install new or additional equipment, make structural changes, or change the type of operation) without a permit to do so from the Commissioner.

(b) Application.

The application for a permit under this section must be:

(1) submitted on the form that the Commissioner provides;

(2) contain the information that the Commissioner requires; and

(3) be accompanied by the applicable permit fee.

(City Code, 1976/83, art. 11, §165(c)(parts.)) (Ord. 99-548.)

§ 6-207. Term and renewal of license.*(a) Term of license.*

Unless sooner suspended or revoked, a license expires on the 1st anniversary of its effective date.

(b) Application for renewal.

Before a license expires, the licensee periodically may renew it for an additional 1-year term, if the license holder:

- (1) otherwise is entitled to a license;
- (2) submits a renewal application to the Commissioner, on the form that the Commissioner provides; and
- (3) pays the applicable annual fee.

(City Code, 1976/83, art. 11, §165(b)(1)(2nd sen.(1st cl.)), (d)(5)(part.)) (Ord. 99-548.)

§ 6-208. Provisional licenses.*(a) In general.*

If a licensed food service facility is sold or otherwise transferred to a new owner, the new owner may apply for a short-term, provisional license to permit the continued operation of the facility pending the Commissioner's inspection of the facility.

(b) Term and renewal.

Unless sooner suspended or revoked:

- (1) the term of a provisional license is 60 days; and
- (2) the license may be renewed for one additional 60-day term.

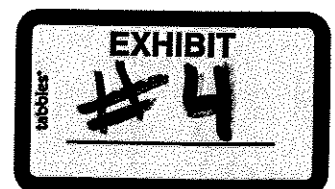

TITLE 12
TOBACCO PRODUCTS AND SMOKING DEVICES

SUBTITLE 1
INDOOR SMOKING

Editor's Note: Chapters 501 and 502, Laws of Maryland 2007 (approved May 17, 2007) enacted a statewide "Clean Indoor Air Act", codified at State Health-General Article, Title 24, Subtitle 5. The prohibitions become effective February 1, 2008 {He § 24-504}. The State law expressly states that it does not "preempt a county ... from enacting and enforcing more stringent measures" {He § 24-510}.

§ 12-101. Definitions.

(a) *In general.*

In this subtitle, the following terms have the meanings indicated.

(b) *Electronic smoking device.*

(1) *In general.*

"Electronic smoking device" means an electronic or battery-operated device that delivers vapors for inhalation, whether manufactured, distributed, marketed, or sold:

- (i) as an electronic cigarette, electronic cigar, or electronic pipe; or
- (ii) by any other product name or descriptor.

(2) *Exclusions.*

"Electronic smoking device" does not include an asthma inhaler or similar product that:

- (i) contains no tobacco nor any nicotine; and
- (ii) has been specifically approved by the U.S. Food and Drug Administration for use in mitigating, treating, or preventing disease.

(c) *Enclosed area.*

- (1) "Enclosed area" means an area that is bounded on all sides by walls that extend, with or without doors, windows, vents, or like openings, from floor to ceiling.
- (2) "Enclosed area" includes the interior of a vehicle.

(d) *Person in charge.*

"Person in charge" means the person who owns, operates, or manages a place subject to this subtitle.

(e) *Smoke.*

“Smoke” means to:

- (1) inhale, burn, or carry any lighted cigarette, cigar, or pipe tobacco, or any other tobacco, weed, or plant product of any kind; or
- (2) to inhale vapors from or otherwise allow vapors to be emitted from an electronic smoking device.

(Ord. 07-392; Ord. 14-310.)

§ 12-102. Scope.

Nothing in this subtitle precludes an employer or other person in charge from prohibiting smoking in open or enclosed areas not covered by this subtitle.

(Ord. 07-392.)

§§ 12-103 to 12-104. {Reserved}

§ 12-105. Where smoking prohibited.

Except as otherwise specified in this subtitle, smoking is prohibited in:

- (1) any enclosed area to or in which the public is invited or permitted; or
- (2) any enclosed area that is part of a place of employment.

(Ord. 07-392.)

§ 12-106. Exceptions – General.

This subtitle does not apply to the following:

- (1) any part of a private residence that is not open to the public for business purposes, except as required by COMAR 13A.14.01.
- (2) a private vehicle.
- (3) a sleeping room in a hotel or motel, as long as that hotel or motel maintains at least 75% of all its sleeping rooms as smoke-free.
- (4) smoking as an integral part of a theatrical performance held in a facility primarily used for theatrical performances.
- (5) smoking as an integral part of a religious ceremony.
- (6) smoking at an analytical or educational laboratory as an integral part of scientific research into the health effects of smoke.

- (7) smoking that is permitted in a hospital, nursing home, or other health care facility under State Health-General Article, § 24-205.

(Ord. 07-392.)

§ 12-107. Exceptions – Retail tobacco establishments; Hookah lounges.

(a) *In general.*

This subtitle does not apply to a retail tobacco establishment or a hookah lounge that qualifies under this section.

(b) *Retail tobacco establishments.*

A retail tobacco establishment qualifies under this section only if it:

- (1) derives at least 75% of its revenues, measured by average daily receipts, from the sale of non-cigarette tobacco products;
- (2) has a ventilation system that prevents smoke from infiltrating into any area where smoking is prohibited under this subtitle; and
- (3) prohibits the entry of minors at all times.

(c) *Hookah lounges.*

(1) *“Hookah lounge” defined.*

In this subsection, “hookah lounge” means an establishment that is primarily devoted to the on-premises use of 1 or more hookahs (also known as a hookah pipe, water pipe, shisha, or narghile) for smoking tobacco or other substances.

(2) *Qualifications.*

A hookah lounge qualifies under this section only if it:

- (i) meets the criteria listed in State law;
- (ii) derives at least 75% of its revenues, measured by average daily receipts, from the sale or use of non-cigarette smoking products and accessories;
- (iii) has a ventilation system that prevents smoke from infiltrating into any area where smoking is prohibited under this subtitle; and
- (iv) prohibits the presence of minors at all times.

§ 12-107.1. Exceptions – Retail sellers of electronic smoking devices.

This subtitle does not apply to the use of electronic smoking devices in a business establishment in which:

- (1) the primary activity is the retail sale of electronic smoking devices, accessories, and related products;
- (2) the sale of other products is incidental; and
- (3) the entry of minors is prohibited at all times.

(Ord. 14-310.)

§ 12-107.2. Exceptions – Electronic smoking devices in certain restaurants and taverns.

(a) *Definitions.*

(1) *In general.*

In this section, the following terms have the meanings indicated.

(2) *Restaurant.*

“Restaurant” means a business establishment that:

- (i) is devoted primarily to serving food and drinks to the public for on-premises consumption by seated patrons; and
- (ii) might or might not also serve alcoholic beverages.

(3) *Tavern.*

“Tavern” means a business establishment that:

- (i) is devoted primarily to serving alcoholic beverages to the public for on-premises consumption; and
- (ii) might or might not also serve food.

(b) *In general.*

This subtitle does not apply to the use of electronic smoking devices in a restaurant or tavern or in 1 or more designated areas of a restaurant or tavern, as the case may be, if the establishment notifies its patrons and potential patrons that the use of electronic smoking devices is allowed on or in designated areas of the premises, as the case may be.

(c) *Method and tenor of notification.*

- (1) The notification required by this section must be provided both:

- (i) by a prominently posted notice, at least 17" x 22", that is clearly readable by all patrons on entry to the establishment; and
- (ii) by a conspicuous notice, in at least 20-pt. font size, printed on each menu provided to patrons.

(2) The tenor of the notices must be substantially as follows:

“This {restaurant / tavern} allows the use of electronic smoking devices {in designated areas / throughout the premises}.”

§ 12-107.3. Exceptions – Electronic smoking devices in video lottery facility.

This subtitle does not apply to the use of electronic smoking devices in a facility that has been awarded a Video Lottery Operation License by the Maryland Video Lottery Location Commission under State Government Article, Title 9, Subtitle 1A.

§ 12-108. Waivers.

(a) *Authority to grant.*

On written application, the Commissioner may grant a waiver from the application of a specific provision of this subtitle, if the applicant for the waiver establishes that:

- (1) compliance with that provision would cause undue financial hardship; or
- (2) other factors exist that would render compliance unreasonable.

(b) *Conditions and restrictions.*

The Commissioner may impose conditions or restrictions on the waiver as necessary or appropriate to:

- (1) minimize the adverse effects of the waiver on individuals involuntarily exposed to second-hand smoke; and
- (2) ensure that the waiver is consistent with the purposes of this subtitle.

§§ 12-109 to 12-110. {Reserved}

§ 12-111. Enforcement by citation.

(a) *In general.*

In addition to any other civil or criminal remedy or enforcement procedure, this subtitle may be enforced by issuance of:

(1) an environmental citation as authorized by City Code Article 1, Subtitle 40 {"Environmental Control Board"}; or

(2) a civil citation as authorized by City Code Article 1, Subtitle 41 {"Civil Citations"}.

(b) *Process not exclusive.*

The issuance of a citation to enforce this subtitle does not preclude pursuing any other civil or criminal remedy or enforcement action authorized by law.

(Ord. 07-392.)

§ 12-112. Penalties: Varied.

(a) *Smoker: \$500.*

Any person who smokes in violation of this subtitle is subject to a civil fine of not more than \$500 for each offense.

(b) *Employer or person in charge: \$750.*

(1) Any employer or other person in charge who violates a provision of this subtitle or who knowingly allows a violation is subject to a civil fine of not more than \$750 for each offense.

(2) It is an affirmative defense that the employer, other person in charge, or an agent of the employer or other person in charge:

(i) posted a "No Smoking" sign at each entrance used by the public; and

(ii) removed all ashtrays and other smoking paraphernalia from all areas where smoking is prohibited; and

(iii) in a bar or restaurant:

(A) refused to seat or serve any person who smoked where smoking is prohibited; and

(B) if the person continued to smoke after an initial warning, asked the person to leave the establishment.

(3) Each day that a violation continues is a separate offense.

Upon review of fire permit, the establishment's capacity was 90 people on the 1st floor and 60 people on the 2nd floor. Inspector Tudhope took a quick count on the second floor and found there to be approximately 60 people. During the time of the inspection, Mr. Pratt instructed security to not allow anyone in and the establishment had tried to get their numbers on the 1st floor in compliance. Inspector Tudhope informed Mr. Pratt they would be receiving a violation for being over capacity. Inspector Tudhope then left the establishment without further incident.

If you fail to appear at the above location at the date and time as instructed by the agency, the Board will proceed with the hearing and will take such action regarding the suspension or revocation of your license and permits as warranted by evidence. On 1/21/2023 at approx. 10:09PM a 311 complaint #23-00054272 was received for 3000 O'Donnell street at establishment know as Southern Provisions for Disturbing the peace/noise/loud music/front door open. I Inspector Tudhope responded at approx. 11:56PM. I observed the front door was closed and music was at an acceptable volume, I observed that the outside area was closed and no outside speakers where on. I inspector Tudhope was returning to my car and heard people screaming and observed people pushing and being shoved out the front door of establishment. I returned to the front door of the bar and made contact with the security officer. I observed the establishment inside and could see that there was a large amount of people right up to the front door. I, Inspector Tudhope asked security how many people where inside and he stated it was around 83 people downstairs and 30 people upstairs. I asked him what his capacity was and he stated 90 downstairs and 30 upstairs. i entered the establishment to get a head count as it appeared to me that there were significantly more than 83 patrons inside. upon entering I was unable to make it to the bar area as there was no room to walk and patrons where shoulder to shoulder trying to move around, I started to count and counted approx. 120 people excluding the staff and the room to the side where I guessed approx. 20 more people where, I was unable to get to that area to do an exact count. I exited the building and asked security to get me a manager. The Manger a Mr. Ben Pratt made contact with me outside and I asked to see the liquor license and fire permit to verify the capacity. Mr. Pratt suggested we go through the side door as it would be easier to get upstairs. Upon review of fire permit the establishments capacity was 90 people on 1st floor and 60 people on the second floor. I took a quick count on second floor and found there to be approx. 60 people. **PART VIII
INTERNATIONAL FIRE CODE**

§ 8-101. CITY ADOPTION.

(a) *In general.*

The International Fire Code (2018 Edition) is adopted as part of the Building, Fire, and Related Codes of Baltimore City, subject to the additions, deletions, amendments, and other modifications contained in this Part VIII.

(b) *Codification.*

Unless otherwise specified, chapter and section numbers in this Part VIII refer to the chapter and section numbers of the International Fire Code.

§ 8-102. City modifications.

The additions, deletions, amendments, and other modifications adopted by the City are as follows:

**CHAPTER 1
SCOPE AND ADMINISTRATION**

SECTION 101 GENERAL

101.1 Title. The regulations contained in this Code constitute and are known as the “Baltimore City Fire Code”.

101.1.1 References to “this Code”. Throughout this Part VIII, all references to “this Code” refer to the Baltimore City Fire Code.

101.2 Scope. *{As in IFC}*

101.2.1 Appendices adopted. The following appendices to the International Fire Code are adopted as part of this Code:

1. Appendix B: “Fire-Flow Requirements for Buildings”.
2. Appendix E: “Hazard Categories”.
3. Appendix F: “Hazard Ranking”.
4. Appendix G: “Cryogenic Fluids – Weight and Volume Equivalents”.
5. Appendix H: “Hazardous Materials Management Plan (HMMP) and Hazardous Materials Inventory Statement (HMIS)”.
6. Appendix N. “Indoor Trade Shows and Exhibitions”.

107.5.1 Occupied premises. If the structure or premises is occupied, the Fire Code Official must first present proper credentials and request entry. If entry is refused, the Fire Code Official has the same authority to secure a search warrant as that vested in the Building Official by § 104.6 {"Right of entry"} of the Baltimore City Building Code.

SECTION 108 MAINTENANCE *{As in IFC}*

SECTION 109 APPEALS

109.1 Appeals to Board of Fire Commissioners. Any person who is aggrieved by any notice, decision, order, or determination of the Fire Code Official may appeal in writing to the Board of Fire Commissioners. The appeal must be filed with the Board within 30 days after the notice, decision, order, or determination is served.

109.2 Affect of appeal. An appeal filed within 5 days of service stays all proceedings on the notice, decision, order, or determination appealed from. An appeal filed later does not stay any proceedings; however, on application of the person taking the appeal and notice to the Fire Code Official, the Board may grant a restraining order for good cause shown.

109.3 Hearing. Within 10 days after the appeal is filed, the Board must grant a hearing to the appellant. All interested parties have a right to be heard at the hearing.

109.4 Board decision. Within 10 days after the hearing concludes, the Board must render its decision. In its decision, the Board may reverse, affirm, or modify the notice, decision, order, or regulation appealed from and may give or make any other notice, decision, order, requirement, or determination that ought to be made under the circumstances. To that end, the Board has all the powers that are conferred on the Fire Code Official by this Code. However, the Board does not have any authority to waive, set aside, or in any way change any specific provision of this Code.

109.5 Judicial and appellate review. A party aggrieved by a Board decision made under § 109.4 of this Code may seek judicial review of that decision by petition to the Circuit Court for Baltimore City in accordance with the Maryland Rules of Procedure. A party to the judicial review may appeal the court's final judgment to the Court of Special Appeals in accordance with the Maryland Rules of Procedure. A judicial review or appeal does not stay any criminal or equitable proceedings on the decision appealed from, nor does it prevent the Fire Code Official or any other City official from pursuing any other action or enforcement procedure authorized by law.

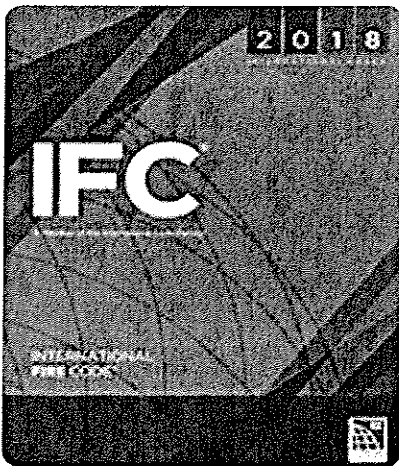
109.6 Limitations on instituting proceedings. After a notice, decision, order, or determination has been served, the Fire Code Official may not take any action, except in the case of imminent danger, or institute or cause to be instituted any civil or criminal proceedings in connection with the enforcement of the notice, decision, order, or determination until:

1. after 5 days has passed without an appeal having been taken, or
2. if an appeal was taken within that period, after the Board renders its decision in the case.

[A] 108.6 Overcrowding.

Overcrowding or admittance of any person beyond the *approved* capacity of a building or a portion thereof shall not be allowed. The *fire code official*, on finding any overcrowding conditions or obstructions in *aisles*, passageways or other *means of egress*, or on finding any condition that constitutes a life safety hazard, shall be authorized to cause the event to be stopped until such condition or obstruction is corrected.
