WE DOWNLOADED UPWARDS OF 60 UNFAVORABLE CRITIQUES BUT INCLUDED ONLY THE BOARD RELEVANT DOCS. ALSO, PLEASE FIND ENCLOSED OVER 110+ SIGNATURES OF RESIDENT/PROPERTY OWNERS IN LITTLE ITALY WHO ARE IMPLORING THIS BOARD TO DENY THE RENEWAL OF THE LIQUOR LICENSE FOR MO'S FISHERMAN,S WHARF AND SEAFOOD RESTAURANT. FOR MANY YEARS OUR COMMUNITY HAS EXPERIENCED MANY PROBLEMS WITH THIS RESTAURANT AND ITS CLIENTELLE, FROM ILLEGALLY PARKED VEHICLES, VEHICLES BEING DRIVEN AND SPEEDING THE WRONG WAY DOWN OUR ONE WAY STREETS, PUBLIC GAMBLING, OPEN AIR DRUG SALES AND USE, PUBLIC URINATION, CONSTANTLY LOUD, VERBAL AND/OR PHYSICAL ALTERCATIONS, GUN BATTLES ON OUR STREETS WHICH HAVE ENDED WITH SEVERAL NEIGHBORS EXPERIENCING BULLET HOLES IN THEIR BEDROOM AND/OR THEIR PARKED CAR WINDOWS, IN FRONT OF OUR HOMES, AND CULMINATING IN A 30 ROUND OF BULLETS

To whom it may concern,

My name is Alecsandra Roe and I live at Baltimore, MD 21218. I am writing to you to protest the renewal license of Geris Liquors, located at 2200 N Charles St, Baltimore, MD 21218.

This liquor store is located on the diagonal corner behind my apartment, and my building shares an alleyway with it. I walk my dog several times a day around the neighborhood; while I would like to enjoy walking along Charles Street, one of Baltimore's most prominent thoroughfares, I avoid walking past Geri's whenever possible. At any given time, on any given day, you can find numerous grown men posted up on the sidewalk that flanks the store. If they are not so intoxicated that they are passed out on the sidewalk (and sometimes even soiling themselves,) they are verbally harassing passersby. This includes hollering, and on several occasions, I have been followed down the alley way on my way home by a man shouting at me (and it was a different man each time that came from Geris.)

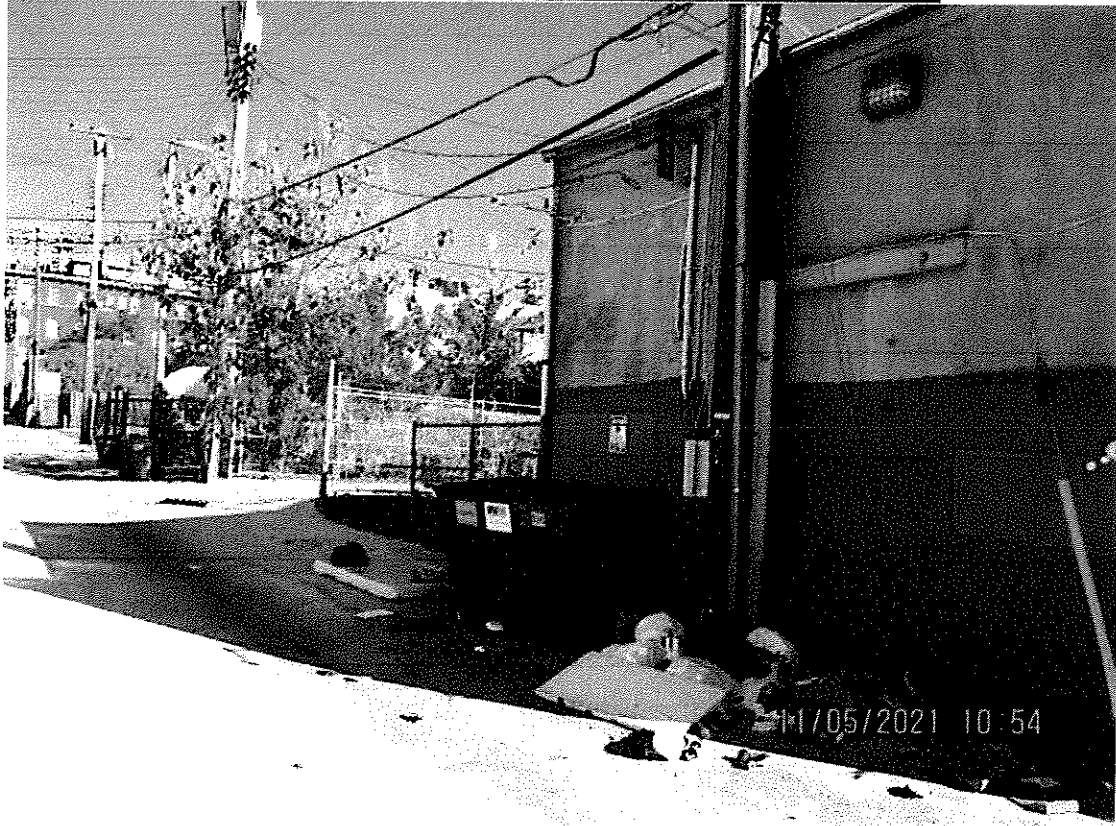
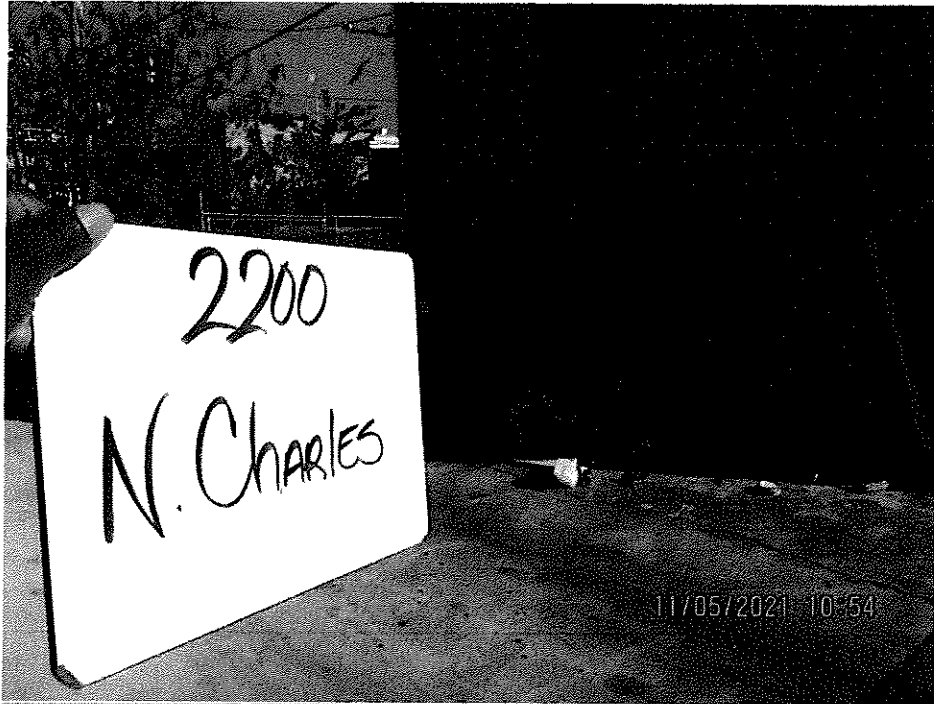
I have lived in the same apartment since 2018 and Old Goucher has seen some lovely changes over the last few years, but Geri's continues to be a stain on the neighborhood. It is a magnet for alcoholics with no interest in self-control, and the establishment seems to have no interest in the responsible sale of alcohol. There are several other liquor stores within a few blocks' radius- this type of loitering and harassment does not seem to occur at any of them like it does at Geris.

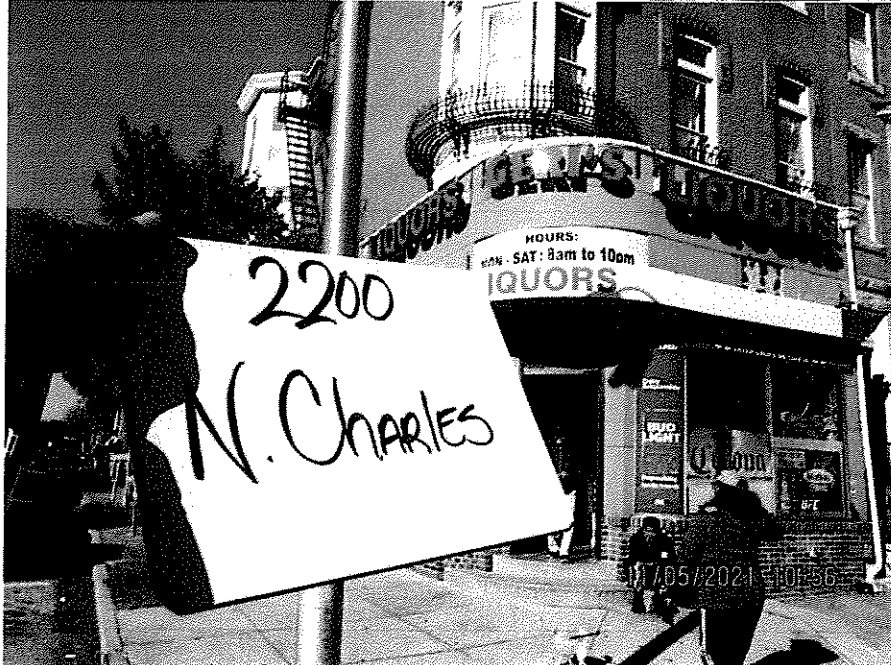
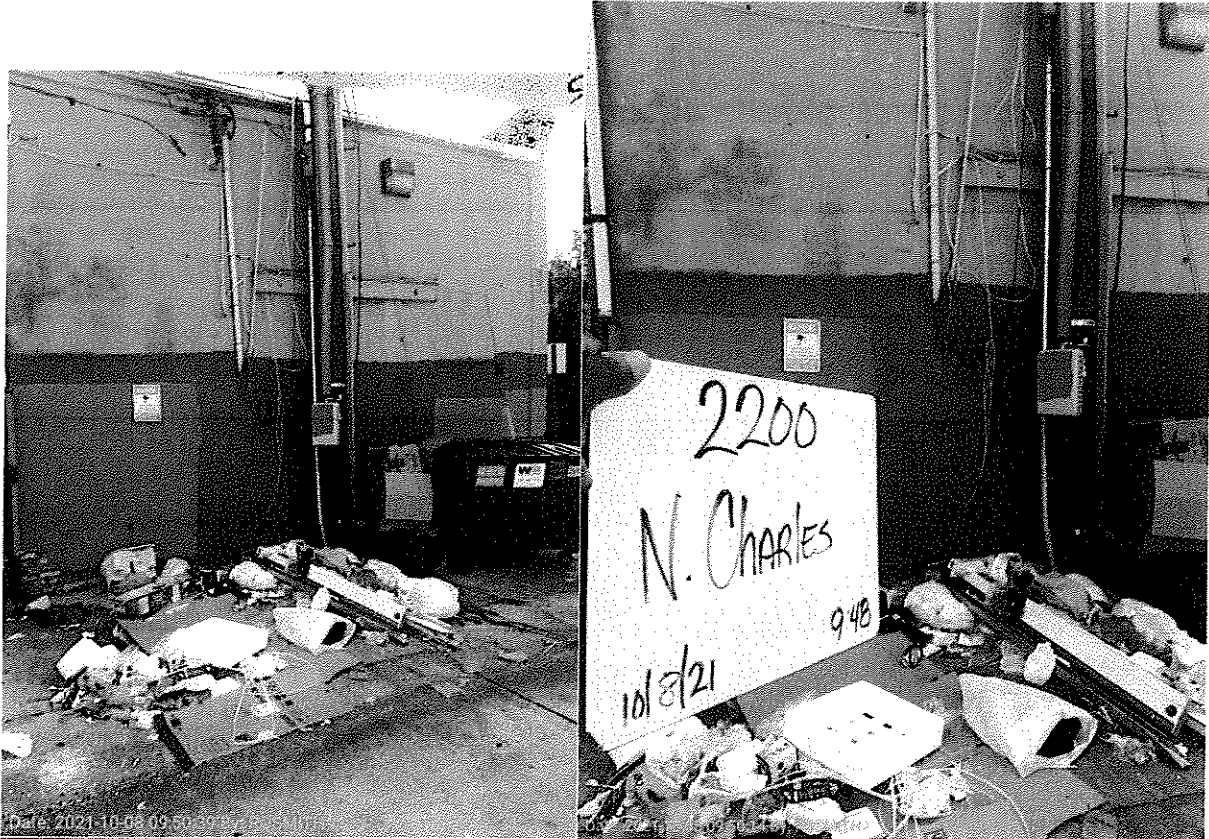
In addition to the health and safety issues that come with irresponsible sale of alcohol, Geri's negatively contributes to our neighborhood in an environmental way: instead of utilizing the dumpster behind the building, literal mountains of trash are dumped there on a weekly basis. In addition to this being an access issue by blocking the exit of the alleyway, it fuels the already overwhelming rat population in the neighborhood. The rats flock to these trash mountains at their own peril, and you can frequently find rats squashed by cars in the street on both 22nd and 23rd streets where the alleyway intersects. These rats are a health hazard, carrying diseases, and can chew wires out of cars, rendering the car undrivable and costing the owner potentially thousands of dollars.

I love Baltimore City, and I love the Old Goucher neighborhood. This is my home and I'm proud to live here. Though I am not naïve to the potential risks of living in a city, Geris Liquors has shown a complete lack of regard for the health and safety of our neighborhood and its residents and is a purely unnecessary risk. I urge you to deny the renewal of its liquor license in consideration of the well-being of all who live in the neighborhood.

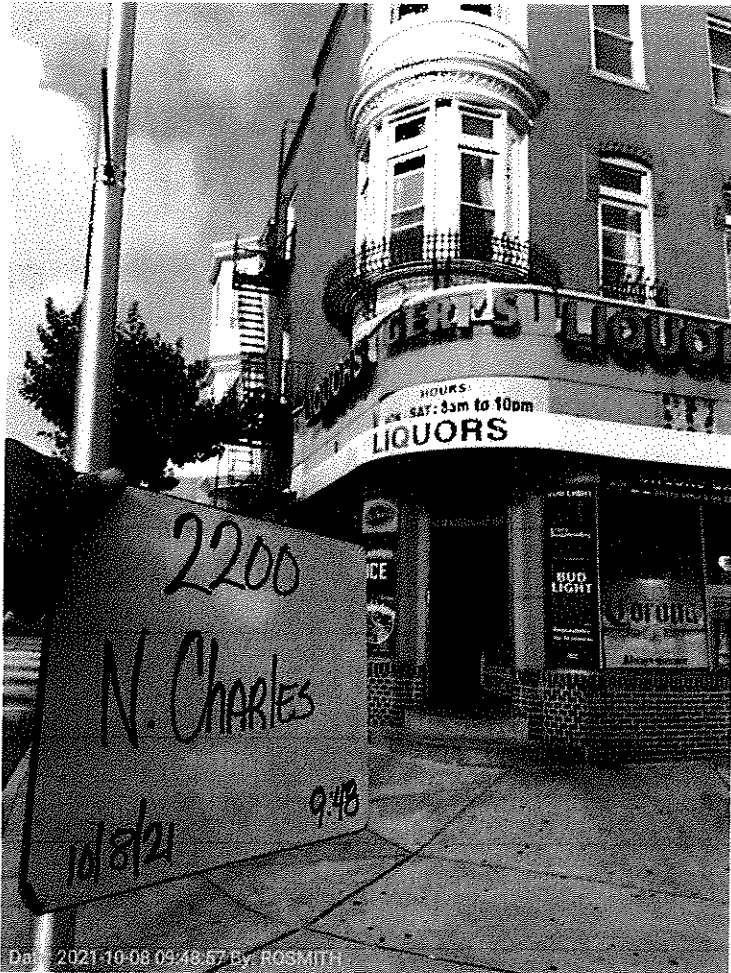

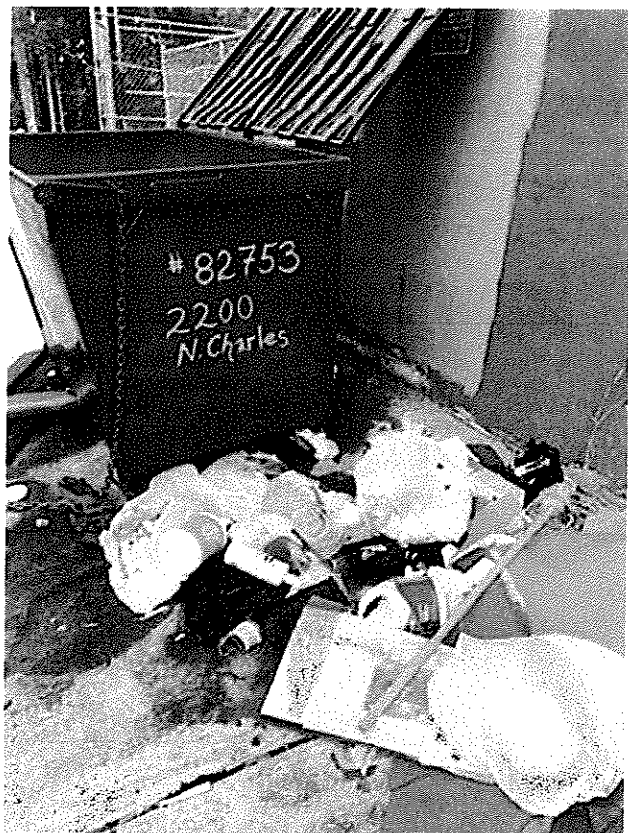
