(a) Applicant(s) Information: (1) Stephen Demby was born in Baltimore, MD in December 1980. He lives in Pasadena, MD; and (2) Alice March was born Baltimore, MD in May of 1955. She lives in Baltimore, MD. Alice March is the sole stock holder, and individual licensee for MARMC, Inc. T/a Knotty Pine Inn located at 801 S. Conkling Street.

(b) Ownership Breakdown: (1) Stephen Demby (95%); and (2) Alice March (5%).

(c) Purchase Price of Business: The purchase price of the business was \$190,000. Deposit of \$135,000 to be paid at settlement. Balance of \$45,000 at 9% interest rate for 24 months.

(d) Qualified Voters: Michael Corless, Jessica Martin, and Courtney Kearns are qualified Baltimore City voters.

(e) Zoning: The property was issued a USE permit (2011-01768) on 6/8/2011 allowing for the premise to be used as a Tavern / restaurant with outdoor table service.

(f) Corporate Standing: DEMBCO, Inc. is a MD Corporation and as of 8/3/2016 is active and in good standing.

(g) Posting Report: The location was posted on 7/20/2016 and checked on 8/1/2016. This meets the 10-day rule. There are 4 licensed liquor establishments in the 4x4 area: "B" BWL-1; "BD7" BWL-3.

(h) Timeline: Last inspection of establishment was performed on 8/4/2016. At that time, the establishment was open and operating.

(i) Letters of Support/Opposition: At this time the Board has no letters of support or opposition.
