This firm represents the applicants regarding the transfer of the above-referenced Beer, Wine, and Liquor License. Such transfer was approved by the Board at the hearing on Thursday, January, 25, 2024.

The transferee, MACON OPCO, LLC, has diligently pursued the completion of the liquor license transfer, including satisfaction of the checklist items required to be satisfied before the final transfer of the license. However, as a condition to obtaining a trader's license, a Certificate of Occupancy is being required.
