- (iii) the applicant does not create a separate package goods department;
  - (iv) alcoholic beverages are served to patrons seated at tables; and
- (v) alcoholic beverages are served only with meals to patrons provided with outdoor table service; [and]
- (15) a Class B-D-7 license in the 300 block of North Charles Street in the 40th alcoholic beverages district to an establishment that has a minimum capital investment, not including the cost of land and buildings, of \$50,000 for the establishment's facilities; AND
- (16) A CLASS C BEER, WINE, AND LIQUOR LICENSE IN THE 3600 BLOCK OF HICKORY AVENUE IN THE 40TH ALCOHOLIC BEVERAGES DISTRICT TO A HOLDER OF A CLASS C BEER AND LIGHT WINE LICENSE; AND

- (17) A CLASS A-7 BEER, WINE, AND LIQUOR LICENSE IN THE 1200 BLOCK OF WEST NORTH AVENUE IN THE 40TH ALCOHOLIC BEVERAGES DISTRICT, IF:
- (I) THE APPLICANT EXECUTES A MEMORANDUM OF UNDERSTANDING WITH THE PENN NORTH COMMUNITY ASSOCIATION;
- (II) ALCOHOLIC BEVERAGES ARE SOLD ONLY AS PART OF A GIFT BASKET OR FLORAL ARRANGEMENT; AND
- (III) THE APPLICANT DOES NOT HOLD OR APPLY FOR A CLASS BWLT BEER, WINE, AND LIQUOR (ON-PREMISES) TASTING LICENSE.

- Avenue, northwest on Reisterstown Road to the intersection with Wylie Avenue, northeast on Wylie Avenue to the intersection with Pimlico Road, northwest on Pimlico Road to the intersection with Dupont Avenue, east on Dupont Avenue to the intersection with Pall Mall Road, southeast on Pall Mall Road to the intersection with Edgecombe Circle North, east on Edgecombe Circle North to the intersection with Finney Avenue, south on Finney Avenue to the intersection with Oakford Avenue, west on Oakford Avenue to the intersection with Pall Mall Road, southeast on Pall Mall Road to the intersection with Loyola Northway, southwest on Loyola Northway to the intersection with Pimlico Road, southeast on Pimlico Road to the intersection with Quantico Avenue, and southwest on Quantico Avenue to the intersection with Reisterstown Road; and
- 2. from the intersection of Millington Avenue with Wilkens Avenue, northwest on Millington Avenue to the intersection with Frederick Avenue, northeast on Frederick Avenue to the intersection with West Pratt Street, east on West Pratt Street to the intersection with South Mount Street, south on South Mount Street to the intersection with Eagle Street, southwest on Eagle Street to the intersection with South Smallwood Street, northwest on South Smallwood Street to the intersection with Wilkens Avenue, and southwest on Wilkens Avenue to the intersection with Millington Avenue;
- (ii) within the area of West North Avenue between the [1300] **1000** block of West North Avenue and the 3200 block of West North Avenue, inclusive; and
- (iii) for a license holder within 250 yards in any direction of the area described in item (ii) of this paragraph.

b. Services to be rendered by PNCA include:

We are in support of the FDV expanding their business by adding additional value added services. We are in agreement with FDV packaging beer, wine, and liquor with their floral arrangements. We understand this is not a liquor store and beer wine and liquor will not be sold directly to customers as packaged goods.

### Resources

The Partners will endeavor to have final approval and secure any financing necessary to fulfill their individual financial contributions at the start of the planning for the development of the Project.

### Liability

No liability will arise or be assumed between the Partners as a result of this Memorandum.

### **Dispute Resolution**

In the event of a dispute between the Partners in the negotiation of the final binding contract relating to this Project, a dispute resolution group will convene consisting of the Chief Executives of each of the Partners together with one other person independent of the Partners appointed by the Chief Executives. The dispute resolution group may receive for consideration any information it thinks fit concerning the dispute. The Partners agree that a decision of the dispute resolution group will be final. In the event the dispute resolution group is unable to make a compromise and reach a final decision, it is understood that neither party is obligated to enter into any binding contract to complete the Project.

### Term

The arrangements made by the Partners by this Memorandum shall remain in place from as long as the A Class A-7 Beer Wine and Liquor licence is enforce.

### **Notice**

Any notice or communication required or permitted under this Memorandum shall be sufficiently given if delivered in person or by certified mail, return receipt requested, to the address set forth in the opening paragraph or to such other address as one party may have furnished to the other in writing.

### **Governing Law**

This Memorandum shall be construed in accordance with the laws of the State of Maryland.

### **Assignment**

Neither party may assign or transfer the responsibilities or agreement made herein without the prior written consent of the non-assigning party, which approval shall not be unreasonably withheld.

### Amendment

This Memorandum may be amended or supplemented in writing, if the writing is signed by the party obligated under this Memorandum.

### Severability

If any provision of this Memorandum is found to be invalid or unenforceable for any reason, the remaining provisions will continue to be valid and enforceable. If a court finds that any provision of this Memorandum is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision will be deemed to be written, construed, and enforced as so limited.

### **Prior Memorandum Superseded**

This Memorandum constitutes the entire Memorandum between the parties relating to this subject matter and supersedes all prior or simultaneous representations, discussions, negotiations, and Memorandums, whether written or oral.

### **Understanding**

It is mutually agreed upon and understood by and among the Partners of this Memorandum that:

- a. Each Partner will work together in a coordinated fashion for the fulfillment of the Project.
- b. In no way does this agreement restrict involved Partners from participating in similar agreements with other public or private agencies, organizations, and individuals.
- c. To the extent possible, each Partner will participate in the development of the Project.
- d. Nothing in this memorandum shall obligate any Partner to the transfer of funds. Any endeavor involving reimbursement or contribution of funds between the Partners of this Memorandum will be handled in accordance with applicable laws, regulations, and procedures. Such endeavors will be outlined in separate agreements that shall be made in writing by representatives of the Partners involved and shall be independently authorized by appropriate statutory authority. This Memorandum does not provide such authority.
- e. This Memorandum is not intended to and does not create any right, benefit, or trust responsibility.
- f. This Memorandum will be effective upon the signature of both Partners.
- g. Any Partner may terminate its participation in this Memorandum by providing written notice to other Partner.

# RESOLUTION

### **Background**

This matter comes before the Baltimore City Board of Municipal & Zoning Appeals ("Board") on appeal from the Zoning Administrator for Baltimore City denying the application of Cheryl Culley ("Appellant") to use first floor of the premises as a tavern without live entertainment requiring conditional use approval at 4505 Harford Rd ("Property").

Appellant filed this appeal to the Board on December 7, 2022 and appeared for a public hearing on May 16, 2023. Board and Planning Department staff prepared memoranda evaluating the appeal. Following deliberations and for the reasons set forth below, the Board voted to approve Appellant's request to use first floor of the premises as a tavern, without live entertainment, requiring conditional use approval, by a 4-0 vote.

### Facts

The Property is located in a C-1 Zoning District and is improved with a c. 1930 two-story detached building with 2,640 sq ft of above-grade floor area. The last authorized use of the premises is as an art gallery and art supplies store with accessory graphic design and tattoo studio.

The Department of Planning in its memorandum recommended that approval of the application be subject to the condition that all exterior improvements or modifications to the existing structure and property are completed or installed in accordance with plans approved by the Department of Planning.

Community residents and representatives of community associations in the area expressed concerns about the proposed use and the idea that the tavern use would be open daily from 6:00am to 2:00am. Community members were also concerned about the possibility that the business might end up operating like a liquor store for package goods only instead of a tavern for both on-premises and off-premises consumption.

Because of these concerns, the community association leaders and the Appellant negotiated a Memorandum of Understanding containing restrictions on the proposed use, with the goal of limiting harmful effects on surrounding communities. The signed MOU, dated May 9, 2023, was submitted to the Board during the hearing, and both sides requested that the Board include the MOU's conditions as official conditions placed on the conditional use for the tavern.

### Standard of Review

Conditional Use: Under City Code Article 32, § 5-406, the Board of Municipal and Zoning Appeals may not approve a conditional use unless, after public notice and hearing and on consideration of the standards required by this subtitle, it finds that: (1) the establishment, location, construction, maintenance, or operation of the conditional use would not be detrimental to or 2022-463

endanger the public health, safety, or welfare; (2) the use would not be precluded by any other law, including an applicable Urban Renewal Plan; (3) the authorization would not be contrary to the public interest; and (4) the authorization would be in harmony with the purpose and intent of this Code. As a further guide to its decision on the facts of each case, the Board of Municipal and Zoning Appeals must consider the following, where appropriate: (1) the nature of the proposed site, including its size and shape and the proposed size, shape, and arrangement of structures; (2) the resulting traffic patterns and adequacy of proposed off-street parking and loading; (3) the nature of the surrounding area and the extent to which the proposed use might impair its present and future development; (4) the proximity of dwellings, churches, schools, public structures, and other places of public gathering; (5) accessibility of the premises for emergency vehicles; (6) accessibility of light and air to the premises and to the property in the vicinity; (7) the type and location of adequate utilities, access roads, drainage, and other necessary facilities that have been or will be provided; (8) the preservation of cultural and historic landmarks and structures; (9) the character of the neighborhood; (10) the provisions of the City's Comprehensive Master Plan; (11) the provisions of any applicable Urban Renewal Plan; (12) all applicable standards and requirements of this Code; (13) the intent and purpose of this Code; and (14) any other matters considered to be in the interest of the general welfare.

Conditional uses are "presumed valid uses" of land but are subject to that presumption being rebutted by credible evidence indicating that "the proposed use has adverse effects above and beyond those inherently associated with such a [conditional use] irrespective of its location within the zone." Schultz v. Pritts, 291 Md. 1, 22-23 (1981). See also Attar v. DMS Tollgate, LLC, 451 Md. 272, 286-287 (2017).

### Discussion

After a thorough review of the file, evidence and testimony submitted in support of this application, the Board evaluated this application under the conditional use approval standards found in City Code Article 32 and Maryland law.

The Board found, by clear and convincing evidence, that, under the conditions listed in the MOU, which is attached to this Resolution, the establishment, location, construction, maintenance, or operation of the tavern conditional use would not be detrimental to or endanger the public health, safety, or welfare. The Board heard testimony from community and business leaders, who state that, while they are concerned about the possibility of the tavern being operated like a liquor store, they feel confident that the conditions that they negotiated with the Appellant will protect the neighborhood. The Board also found that the use would not be precluded by any other law, including an applicable Urban Renewal Plan, that the authorization would not be contrary to the public interest, and that the authorization would be in harmony with the purpose and intent of this Code.

Under the Schultz v. Pritts test, the Board found that there was no evidence presented to show that a tavern use at this location would have any adverse effects above and beyond those inherently associated with a tavern use anywhere else within this C-1 Commercial zoning district. Therefore, the Board voted unanimously to approve the tavern conditional use.

### Conclusion

For the reasons set forth above, and after giving public notice, reviewing the zoning records, holding a public hearing, considering all data submitted, and by authority of City Code Article 32, it is this 18th day of July, 2023, by the Baltimore City Board of Municipal and Zoning Appeals, hereby:

**RESOLVED**, that the Board finds sufficient evidence in the record to support the application of the Appellants to use first floor of the premises as a tavern without live entertainment requiring conditional use approval; and it is further,

**RESOLVED**, that Appeal No. 2022-463 is **GRANTED**, subject to the following **CONDITIONS**:

- (1) All exterior improvements or modifications to the existing structure and property must be completed or installed in accordance with plans approved by the Department of Planning.
- (2) Appellant shall abide by all of the terms of the Memorandum of Understanding with the Beverly Hills Improvement Association, dated May 9, 2023, including, but not limited to, the conditions listed below:
  - a. Hours of operation shall be limited to:
    - i. Sunday through Thursday: 10am 10pm.
    - ii. Friday through Saturday: 10am 12am.
    - iii. Outdoor service hours are the same as indoor operating hours.
  - b. Designated off-premise liquor sales shall be limited to the area set out in the MOU.
  - c. Outdoor seating: the Licensee may have up to 75-100 outdoor seats. Only guests seated at outdoor tables may consume alcoholic beverages.
