Violation of Rule 3.02 - Cooperation - June 24, 2023 - On June 24, 2023, Board of Liquor License Commissioners (BLLC) Chief Inspector John Chrissomallis was on duty working with the Baltimore City Fells Point Deployment. At approximately 2:30am, Baltimore Police Department (BPD) Major Saunders notified Chief Chrissomallis that a white male with a large knife had slashed the tires of the BPD wagon that was in the area. The wagon was parked directly across from the establishment. When Major Saunders approached the security manager and asked to view the exterior cameras so she could get a better description of the suspect running around with the large knife, she was told to get a subpoena. Major Saunders conveyed this information to Chief Chrissomallis, Chief Chrissomallis then went to the establishment and asked to speak to the manager on duty. Mrs. Janice Williams came out and Chief Chrissomallis explained to her that the outdoor security footage needed to be reviewed, because there was a suspect in the area with a large knife and potentially under the influence of some substance running around with a large knife. Mrs. Williams stated to Chief Chrissomallis that just as she told the Major, she was not willing to allow the footage to be viewed unless a subpoena or a warrant was provided. 





The Board may approve a conditional use subject to the requirements and provisions of Subsections 14-102, 14-103, 14-204, & 14-205.

The request in this case is to use a portion of the premises for outdoor table service accessory to the restaurant, in the B-3-1 Community Commercial District. It was testified by the appellant that this property contains a one story structure used as a restaurant located on an approximately ½ acre lot. The appellant is seeking authorization to use a 43 foot by 40 foot area for a crab garden. The outdoor seating will not reduce the existing off-street parking area and complies with the standards for conditional uses. The Board received a report from the Department of Planning recommending approval with the following conditions:

- The capacity of the outdoor seating area, with the number of tables and seats, should be specified in the Board's decision;
- The boundaries of the outdoor table service area should be clearly marked, and all tables and patrons must remain within that approved area;
- There will be no outdoor bar:
- There will be no jukebox, or other form of live entertainment; and
- · All patrons must be seated for dining, and served by wait staff.

The Board, in making its decision to approve this appeal, has given due regard to the nature and the condition of the adjacent uses and structures, the facts presented, reports from City agencies and the standards for conditional uses under Title 14 of the Zoning Code. The Board finds that the request is reasonable and will not have a negative impact on the adjacent properties or the immediate area. Therefore, based on the findings and facts, applicable laws and provisions of the Zoning Code, reasons expressed herein and subject to the aforementioned conditions, the Board approves the application.
