I Inspector Tudhope inform the manager of my findings and the manager told inspector Jordan that they allow patrons to get drinks at the bar inside and walk outside with them. I Inspector Tudhope informed manager he would be receiving violation, the manager was provided with a copy of with rule and regulations of the liquor board. I asked manager at this time to sign my inspection sheet, Manger handed it to a Mr. Curtis Conner as identified by his Maryland driver's license. Mr. Conner stated he was the spouse of licensee and signed inspection sheet. Task force left establishment without further incident
