of the premises and neighborhood and finds that the property is in the B-2-2 Community

Outdoor table service when accessory to a restaurant use and restaurants—including live entertainment and dancing are listed as a conditional uses in the B-2-2 Business District under Subsection 6-308. The Board may approve conditional uses subject to the requirements and provisions of Subsections 14-102, 14-103, 14-204, & 14-205. Under Subsection 14-103, before the



Board approves any conditional use, it may impose on the establishment, location, construction, maintenance, and operation of the conditional use any conditions, restrictions, or limitations that the Board considers necessary or desirable to:

- (1) reduce or minimize any effect of the use on other properties in the neighborhood;
- (2) secure compliance with the standards and requirements of this title; and
- (3) better carry out the intent and purposes of this article.

Under Subsection 14-309, any restaurant or tavern that seeks a conditional use authorization to provide live entertainment, dancing, or both as an accessory use;

- (1) In addition to the information required under § 14-201 ("Applications") of this title or otherwise required by the Board, the application for conditional use must include:
  - (i) a description of the type of live entertainment or dancing to be provided; and
  - (ii) a floor plan, in the form and with the detail that the Board requires, of:
    - (A) the establishment generally; and
    - (B) the live entertainment or dancing venue within the establishment.
- (2) If dancing is to be provided, the floor plan must show:
  - (i) the location and dimensions of the dance floor; and
  - (ii) the maximum authorized occupant load, as approved by the Fire Department, for all configurations of:
    - (A) the establishment generally; and
    - (B) the dancing venue within the establishment.

In approving a conditional use, the Board must specify precisely the types of live entertainment or dancing to which the use is limited and impose conditions, as appropriate, concerning:

- (1) days and hours:
  - (i) of the establishment's general operations as a restaurant or tavern; and
  - (ii) of the live entertainment or dancing to be provided;
- (2) use of amplification, noise levels, and need for noise proofing;
- (3) limits on the size of the establishment or on the size, location, or configuration of the entertainment or dancing venue within the establishment;
- (4) number of live entertainers:
- (5) number of seats proposed for outdoor table service;
- (6) exterior lighting:
- (7) public need and desire for the establishment;
- (8) number and location of other, similar establishments in the area and potential effect of the new use on those establishments;
- (9) proximity of residences, schools, religious institutions, or parks to the establishment;
- (10) maximum authorized occupant loads of the establishment and of the live entertainment or dancing venue within the establishment;
- (11) volume and types of vehicular and pedestrian traffic in the area of the establishment:
- (12) the establishment and maintenance of:
  - , (i) a traffic management plan;
    - (ii) a parking management plan;
    - (iii) an indoor and outdoor security plan; and
    - (iv) a sanitation plan.

The request in this case is to add live entertainment and outdoor table service to the existing restaurant in a B-2-2 Community Business District. It was testified by the appellant that this property is a two story attached building located on the interior of a row. The appellant stated that this property has been used as a restaurant/tavern for many years and currently operates under the name of "Los Amigos". The Board received a report from the Department of Planning indicating no objection to this appeal subject to a condition that Board's Official resolution completely and accurately reflects all of the conditions imposed by the Board, and that the appellant and any successors to this use remain aware of their responsibility for adhering to the terms and conditions of the Board. The Department of Planning recommends that as a condition of approval of live entertainment and/or dancing the written decision including copies of the approved application for live entertainment in which the appellant detailed self imposed limitations on live entertainment and agreements with the community, and copies of all licenses and permits otherwise required for operation of live entertainment and/or dancing on the premises, be kept on the premises and made available for inspection by authorized representatives of Baltimore City at any time during business hours. The Board received letters from the Hamilton Hills Neighborhood Association, Hamilton Business Association, Hamilton-Lauraville Main Street, and the HARBEL Community Organization. Inc. all in support of this appeal.

The appellant submitted a written report addressing the above conditions as follows:

- Los Amigos is open from 11:00 AM to 10:00 PM on Monday and Tuesday and from 11:00 AM to 2:00 AM Wednesday through Sunday;
- Los Amigos plans to provide live entertainment on Wednesday to Sunday evenings between 10:00 PM and 2:00 AM;
- Los Amigos will have from one to not more than four entertainers from a DJ or up to five persons playing acoustical guitars and related instruments limited to the interior of the premises. All necessary sound proofing measures will be taken to

ensure that the sound generated is contained within the interior of the premises, including but not limited to, low sound levels for microphones and amplified musical instruments. All doors and windows will be closed whenever there is live entertainment on progress. Sound levels emanating from the premises will not be greater than 75 decibels at 30 feet from the building:

- (1) a floor plan indicating a the proposed dance floor and entertainment area within the restaurant;
- (2) Los Amigos will make appropriate security arrangements to ensure that customers are not allowed to congregate on the exterior of the premises during the hours of operation (except in the limited outside seating for seated patrons) and that customers are not permitted to linger & loiter or the area after closing: and
- (3) also submitted a written report outlining their plan for food safety and sapitation.

The Board, in making its decision to approve this appeal finds that this request is reasonable, and will not have a negative impact on the adjacent properties or the immediate area, subject to the following conditions;

- The use of the premises with live entertainment and outdoor table service is subject to the above conditions submitted to the Board by the appellant and the conditions recommended by the Department of Planning; and
- The Board may require an adjustment to the noise level if necessary to lessen a negative impact on adjacent neighbors and the immediate area.

The Board has given due regard to the nature and condition of the adjacent uses and structures, the facts presented, reports from City agencies and standards for conditional uses in general under Title 14 of the Zoning Code, and in detail under Section 14-309 for restaurants or taverns with live entertainment or dancing. The Board finds that the proposed use at this location will not be detrimental to or endanger the public health, security, general welfare or morals of the community. The Board finds that this authorization is not otherwise in any way contrary to the public interest and is in harmony with the purpose and intent of the Master Plan and the Zoning Code of Baltimore City. Therefore, based on the findings and facts, applicable laws and

provisions of the Zoning Code, reasons expressed herein and subject to the aforementioned conditions, the Board approves the application.

(a) Applicant(s) Information: (1) Donald Higdon was born in Baltimore, MD in June of 1961. He lives in Pasadena, MD; (2) Anthony Scardina Jr. was born in Baltimore, MD in November of 1961. He lives in Severna Park, MD; and (3) Antony Scardina, III was born in Baltimore, MD in November of 1988. He lives in Baltimore, MD.

- (b) Ownership Breakdown: (1) Donald Higdon (50%); (2) Anthony Scardina, Jr (50%); and (3) Antony Scardina, III (0%).
- (c) Purchase Price of Business: The purchase price of the business is \$110,000 to be paid in cash at closing.
- (d) Qualified Voters: Robert Zaruba, James Battaglia, and Dean Anthony Albany are qualified Baltimore City voters.
- (e) Zoning: Applicants have applied for a USE permit, for the continued use of property as a tavern.







# **Opposition to Liquor License Transfer**

Higgy's, LLC, t/a Higgy's 1184 Cleveland St Baltimore, Md. 21230

August 27, 2017

To Whom It May Concern:

I am writing this letter in opposition to the transfer to the liquor license at 1184 Cleveland Street.

The property at 1184 Cleveland Street is at the corner with Ostend Street. In a five block section of Ostend Street between Washington Boulevard and W Hamburg Street there are already three taverns that are open for business.

The 1184 Cleveland Street property is R8 residential. The previous tavern was operating under non-conforming use. City zoning law states once this business is closed for one year it loses the non-conforming use. We have plenty of vacant buildings with commercial zoning available on Washington Boulevard (our main street).

This establishment has been closed for more than four years. Doesn't the law allow just two 180 day hardship extensions? Four years is much longer that that period of time.

A shortage of parking already exists in the immediate vicinity. This includes the 1100 and 1200 blocks of Cleveland Street, the 1100 and 1200 blocks of Carroll Street, and the 1100 block of Ostend Street. On days when there are stadium events (especially Ravens games) there is very little if any parking available.

This is a **quiet residential** section of our community and we would like to keep it that way. When this tavern was open it allowed people to hang out on the corner and set on the cover to their basement door. Drug dealers started blending right in with the patrons hanging on the corner. When the business started failing it was attracting a rowdy crowd.

I am worried that the hearing will be heard without Citizens of Pigtown community association input. Doesn't the Liquor Board ask the businesses applying for the Pansfer to contact the community association as they had been doing in the past?

To Whom It May Concern:

Citizens of Pigtown (COP) community association is submitting this letter of opposition to the transfer of the liquor license at 1184 Cleveland Street to Higgy's, L.L.C. T/A Higgy's. Our membership voted to submit this opposition letter at our last community meeting on September 12, 2017. COP is opposed to the transfer for the following reasons:

- Multiple residents in the immediate vicinity to 1184 Cleveland St. have stated that Shaffer's, the previous business/license holder, has not been open for business for approximately three years. While the Timeline in the application paperwork states that the establishment was inspected on 1/24/2017 and was open and operating, we believe that this was an abnormal occurrence on this particular day for the benefit of the inspector. We request that you please review the license history to verify it is a valid license that is eligible to be transferred.
- Shaffer's tavern operated as a nonconforming use on residential property and is surrounded by residential property. Neighbors have reported that the tavern has not been open for business for approximately 3 years and therefore, should lose the nonconforming zoning use. We request that the USE2017-50472 permit that tavern applied for is not granted.
- The applicants have not contacted COP to present their business plans to the community. We are
  unaware how their business may impact the community and believe that without this level of
  community engagement, this business cannot be a good neighbor.

COP is the only recognized community association in our Pigtown neighborhood and by the city. Our association's large membership has represented our community since 1971. For example, we have a board seat on the LDC, SBGP and SWP. We are aware that Richard Parker (who is not a resident of Pigtown and has not been for over a year) is misrepresenting the interests of the community through a non-existent Pigtown Community Association. The views and opinions of Richard Parker and his "community association" are not that of the wider community since they do not hold any public meetings, do not have a board of directors made up of residents, does not have bylaws, and is not registered as an organization with the state.

We hope that you will consider this letter as strong opposition from the residents of Pigtown to the transfer of this liquor license.

On June 28, 2017, at 12:13p.m., Supervisory Inspector Southworth and I conducted a routine tobacco and alcohol inspection at Whispers Tavern and package goods store, located at 1807-1811 Baker Street, Baltimore, Maryland 21217. I made contact with the business owner, Taek Kim, as I entered the business. I identified myself as an Agent for the Comptroller of Maryland, working for the Field Enforcement Division. I asked for the Trader's License, which is a document issued by the State of Maryland, which allows a business to sell products in their store, and receipts for the cigarettes and O.T.P. that were displayed for sale. I also asked for the Liquor License for the establishment. This establishment is a package goods store with an attached bar.

The owner, Taek Kim was able to provide me with an expired 2017 Trader's License. The Trader's License included cigarettes, special cigarettes and other tobacco products (O.T.P.), as items the business was authorized to sell. Other Tobacco products include cigars, cigarillos, chewing tobacco and loose tobacco products. She also provided the Liquor License (LBD7353) that allowed him to sell beer, wine and liquor. The Licensees on the liquor license are: Ashley Kim and Kyung Lee.

The cigarettes had Maryland Tax Stamps affixed to the individual packs. The O.T.P. receipts matched the inventory. I was given receipts from Costco and LG Distributors; both are licensed tobacco distributors in Maryland.

Supervisory Inspector Southworth assisted with the alcohol inspection. He advised the alcohol invoices matched the inventory in the business. The shipping labels for the alcohol boxes matched the business name and address for Whisper Tavern. The alcohol was purchased at local authorized wholesalers.

While Inspector Southworth was inspecting the bar side of the establishment, he noticed the alcohol being displayed was discolored. The bottle in question was a 750ml Montebello Iced Tea Cocktail, containing a clear liquid. Next to this bottle was a second 750 ml Montebello Iced Tea Cocktail bottle. The second bottle contained a dark liquid consistent with an unopened bottle of Montebello Iced Tea Cocktail displayed for sale in the package goods area of the business. Upon opening the suspected bottle I smelled a strong coconut smell consistent with the Malibu Coconut Rum on the shelf near the suspect bottle. Mr. Kim advised his bartender must have transferred the coconut rum to this bottle because it may have been damaged. I explained if a bottle of alcohol is delivered damaged he must report it to the vendor to have an undamaged bottle delivered and the damaged bottle returned. I further explained that at no time can a liquor establishment pour alcohol from one

bottle of alcohol into another bottle of alcohol. Inspector Southworth noticed several bottles appeared to have been refilled. There were "pour marks" on the outside of the bottles. Pour marks occur when alcohol is being transferred from one bottle to another. During refilling, the alcohol is spilled on the outside of the refilled bottle, and "runs" down the sides of the bottle. As the alcohol dries it leaves a "streaking effect" on the outside of the bottle. This is an indicator a bottle has been refilled. Inspector Southworth confronted Mr. Kim with his observations, Mr. Kim admitted to refilling a total of four other bottles, but stated he only used the same brand of alcohol that was in the original bottle. He advised sometimes the alcohol bottles arrive damaged and he transfers the contents to an undamaged bottle of alcohol. The four bottles of alcohol he admitted to refilling were: a 750ml bottle of Smirnoff Green Apple Vodka, a 200 ml bottle of Smirnoff Green Apple Vodka, a 750 ml bottle of Ciroc Peach Vodka and a second bottle of 750 ml Montebello Iced Tea Cocktail.

All 5 bottles of alcohol were seized from the shelf of the bar area.

I photographed the seized alcohol from the display shelves behind the bar. I also photographed the Maryland Driver's License for Mr. Kim.

Once the evidence was collected, I filled out a Notice of Seizure Receipt for Confiscation form. Mr. Kim signed the form and was given a copy. I transported the evidence to the Jessup temporary evidence storage for safekeeping. I filled out a property report form and submitted it with the evidence.

On June 29, 2018, Agent Michael Calvert #0046 transported the evidence to the Louis Goldstein Treasury Building 80 Calvert Street, Annapolis, Maryland, and placed it into evidence storage for safekeeping.

This case will be turned over to the Baltimore City Liquor Board for a hearing for tampering/refilling alcohol.


