

FIRST FLOOR PLAN 1/8"=1-0" 421 HOWARD 3004 GSF



SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Memorandum of Understanding

THIS MEMORANDUM OF UNDERSTANDING ("Agreement") dated 501 17th. 2021, by and between Current Forever Space LLC, a Maryland limited liability company whose address is 421 N. Howard Street, Baltimore, MD 21201 ("Establishment") and Downtown Partnership of Baltimore, Inc., a Maryland corporation whose current address is 20 South Charles Street, 6th Floor, Baltimore, MD 21201 ("Association").

RECITALS

- A. Establishment owns the real estate known as Current Gallery at 421 N. Howard Street, Baltimore, MD 21201 ("Property").
- B. Establishment intends to apply for a Class BD7 Liquor License ("Liquor License") through the Board of Liquor License Commissioners for Baltimore City ("Liquor Board") which was made possible through special legislation pass by the Maryland General Assembly in 2021, as an accessory to its current art gallery and performance space use (collectively, "Use").
- C. The Establishment desires to continue to use the Property for the Use but wishes to be able to serve beer, wine, and liquor on premises to its guests pursuant to a Liquor License issued to them by the Liquor Board.
- D. The Association desires to support the application for this Liquor License by the Establishment on the condition that the Establishment agrees to the terms set forth in this Agreement.

WHEREFORE, in consideration of the mutual promises contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. HOURS AND OPERATION OF ESTABLISHMENT: The Establishment agrees to follow all applicable laws pertaining to alcohol sales. The Establishment shall not serve alcohol to patrons who are visibly intoxicated, in accordance with the Rules and Regulations for the Board of Liquor License Commissioners of Baltimore City. Per the Alcoholic Beverages Statute, Title 12-1603(c)11, enabled by HB1288 (2021), the Establishment cannot sell any alcoholic beverages before 10:00 a.m. This MOU reiterates that restriction.
- 2. **VOLUME LEVEL:** All audio will be played at a volume limit not to exceed Baltimore City law. Live Entertainment shall cease at the establishment at least one hour before closing time.
- 3. **SECURITY:** The Establishment and its staff shall monitor the Property and the exterior of the premises immediately adjacent to the Property to ensure that it operates in a manner as to prevent patrons from disturbing the peace, and promote the general welfare of the community, a

lively nightlife block which includes multiple venues in the center of the Bromo Arts and Entertainment District and in the city's Downtown District. The Establishment and its staff shall actively discourage illegal activity and unruly behavior from occurring within and around the Property. To that end, all instances, and suspected instances of criminal activity, including but not limited to public drunkenness, fighting, and suspected drug transactions must be reported to the Baltimore City Authorities by the Establishment. For events where over 100 persons are in attendance, the Establishment shall ensure that staff or security will be present and monitoring patrons on the exterior and interior of the Property. The Establishment shall notify DPOB and MCMA within 72 hours of all calls to the Baltimore City Police Department concerning incidents reported by the Establishment or its staff that occurred within or immediately adjacent to the Property.

- 4. UPKEEP OF ESTABLISHMENT: Establishment and its staff shall ensure that the exterior and interior of the Property are clean and inviting to customers and to the surrounding community. Establishment shall adhere to all City ordinances regarding signage. The Establishment and its staff shall ensure that the sidewalk and gutter on the front and alley behind the property are free of trash, broken glass, and debris. Establishment will clean all graffiti from the building. All exterior lighting shall be maintained in proper working order. Non-working bulbs shall be replaced and malfunctioning or misaligned light fixtures shall be repaired within 72 hours of notice to Establishment.
- 5. **PROMOTERS:** The Establishment and its staff shall ensure that third party promoters follow all City regulations and this MOU for events hosted at the Establishment. The Establishment shall have staff or representation on site or available for assistance during these events. Any event that is promoted by third party promoters to be held at the Property, shall be communicated via the Current Space e-newsletter to the Chief Inspector of the Liquor Board, the Downtown Partnership of Baltimore, and the Market Center Merchants Association at least 7 days prior to the day of the event when possible (ex. of exceptions include emergency venue switches, rain dates, rescheduled events). If an event by a 3rd party promoter is not public. Current Space will notify the above parties about the event via email at least 7 days prior to the day of the event when possible. For purposes of this paragraph, a "promoter" is a person or entity who books the Establishment for the purposes of contracting bands for a public music event, promoting and managing ticket sales, and assumes all financial risk of performer fees and venue fees.
- 6. PARKING: The Establishment shall provide information on alternative means of transportation to its customers to reduce parking congestion.
- 7. **OUTDOOR SEATING:** The Establishment will follow occupancy limits as determined by the Fire Department. Alcoholic beverages are served outdoors only to patrons seated at tables or standing in a courtyard area.
- 8. HISTORICAL PRESERVATION: The Establishment will work in good faith to preserve any exterior historical features including fixtures of the building during renovation and

any future remodeling efforts. In addition, Establishment will adhere to any guidance from the Baltimore City Commission for Historical & Architectural Preservation (CHAP).

- 9. WASTE MANAGEMENT: The Establishment will adhere to City regulations regarding waste removal from establishment. If waste increases with more frequent programming and establishment is unable to adhere to City regulations, the Establishment will contract with a private waste removal company for collecting and transporting waste materials. Waste area will be kept screened as it is now. If dumpster is located on site, it must be regularly serviced and emptied. Establishment will try to recycle all paper, plastic, glass, and cans to reduce the amount of trash.
- 10. **COMPLAINT COORDINATION AND RESPONSE:** In order that any complaints about the operation of the establishment may be appropriately directed and efficiently addressed, the Establishment must provide the (DPOB/MCMA) with:

11. FUTURE TRANSFER OF THE LICENSE

- a. This Agreement will remain in effect as long as the Establishment is granted and continues to own the Liquor License. This Agreement will be maintained in the public file at the Liquor Board. This Agreement will not transfer with ownership of the Liquor License. The Association will automatically object to the transfer of the ownership of the Liquor License if a new memorandum of understanding is not signed with the new owners.
- b. Should the Liquor License be transferred to an entity other than the Establishment, a new Memorandum of Understanding with the Association is required. If the Liquor License is transferred, this Agreement is revoked. Any new applicant for the Liquor License would need to abide by regulations to enter into new MOU with the Association.
- 12. **TERMINATION OF THE AGREEMENT:** All parties agree that either party may terminate the Agreement based on one or more of the following grounds:
 - a. The Non-Terminating Party has committed a material breach of this Agreement at least three times during the prior six months from the date of the subject breach;

b. The Non-Terminating Party has engaged in fraud or a material misrepresentation of fact against the Terminating Party.

The Non-Terminating Party will have no less than 30 business days to resolve the material breach after it has been both brought to their attention in writing by another party to this Agreement, and all involved parties shall timely meet to attempt to work through the issue. If at the end of 30 days, the issue is not resolved, the parties agree to give a minimum of 5 business days written notice to the other parties if either party desires to terminate the Agreement based on the grounds set forth above.

- 13. **EMPOWERMENT:** The parties to this Agreement hereby authorize, designate, and request that the Board of Liquor License Commissioners does enforce and hold the parties to be bound by this Agreement. This Agreement is to be integrated but not merged with the license.
- 14. **PUBLIC RECORD**: This Agreement will be maintained in the public file at the office for the Liquor Board and the Liquor License issued by the Liquor Board to the Establishment. The Establishment enters into this Agreement voluntarily, with the knowledge that the terms of this Agreement will become enforceable restrictions on the service of alcoholic beverages at the Property pursuant to an approved Liquor License.
- 15. REPRESENTATIONS: Establishment and Association respectively represent and covenant as follows: (a) Each party represents that it is authorized to enter into this Agreement: (b) Each party has the duty to implement this Agreement in good faith: and (c) Each party shall rely on the other party's representations made in this Agreement.
- 16. **GOVERNING LAW**: This Agreement shall be governed by, construed, and enforced in accordance with the laws of the State of Maryland and Baltimore City.
- 17.
