


FRONT 1st. FLOOR

Mr. Strange requested to transfer the license to Jeremy Freeman. No community members have voiced any concerns to me regarding this transfer.

I do not plan to be involved with the new MOU due to health reasons, and there are no other Stanwood Ave volunteers that I am aware of. I can no longer walk adequately to communicate with community members or attend to problems if they would arise.

Mr. Darryl Strange would like to transfer the liquor license at Truth Lounge, 4507-09 Belair Road, Baltimore, MD 21206 to Mr. Jeremy Freeman. I have not been notified of any concerns related to the transfer.

Mr. Freeman has managed Truth Lounge since it opened. Mr. Freeman invites the area residents, organized by Sandra Davis, for a monthly meeting at the lounge. All Stanwood Ave residents receive an invitation to attend the meeting each month. In addition, they were given Mr. Freeman's phone number so that urgent issues could be addressed immediately. I find Jay to be reachable, approachable, & agreeable.

I provided Stanwood, 4500 Belair, & 4200 Moravia residents my phone number, email, and address many times. I have not received complaints related to the lounge or Mr. Freeman. Neighbors are also encouraged to contact Sandra Davis with complaints, and she has not informed me of receiving any related to Jay or the lounge.

Parking was a concern during our last hearing. I heard of a few minor parking issues in a meeting & during neighborly conversation. However, no events were serious or annoying enough to be documented (time, date, place, license, action) by the person communicating them, and frequently the complaint involved the carry out and not the bar.

Crime has increased tremendously in our zip code. However, our street remains unfazed and partial credit is due to Mr. Freeman's security team & street monitors.

Sanitation was a concern and Mr. Freeman gets a satisfactory mark for sanitation. Mr. Freeman works around obstacles like trash trucks being blocked from the alley with abandoned cars from another business parked opposite it and new renters unfortunately dump trash in the alley further blocking trash collection from the Stanwood side.

I have no reason to protest the transfer of this license. It appears to be more of a paperwork issue then something that would make any changes to the operation of the lounge.

Sadly, I cannot be part of the new MOU. My health declined, and I cannot walk to communicate with the neighbors, deliver correspondence, or to intervene with problems if they would arise. No one has volunteered to be the Stanwood Avenue representative for the MOU. In addition, I now own a home in Baltimore County and plan to move out of the city in the near future.

(c) **Timeline of request**: On 8/19/2016, Attorney Mr. Gordon Heyman filed a hardship extension on behalf of his client, Charles Stokes Inc., t/a Club Rio claiming that operations had ceased at the location on 6/19/2016. The Board scheduled a hearing for 9/22/2016 for the matter to be heard. However, on 9/13/2016, Mr. Heyman requested a postponement and rescheduling due to a conflict with his schedule. In early 2016 the BLLC contacted Mr. Heyman to inquire about this matter. Mr. Heyman did not contact this office to reschedule until 6/20/2017. 


