Rules & Regulations: Public Market License – Cross Street Market – Operations and Vendor Conduct

MD Code, Alc. Bev. Art. 12-1002.1(i), requires the Board of Liquor License Commissioners for Baltimore City ("Board") to adopt regulations to govern and regulate the activities within a Public Market. On January 23, 2019, the Board published proposed rules and regulations for the Public Market License and opened the public comment period for 30 days. After February 23, 2019, the Board closed the comment period. Upon receipt and review of the comments regarding the Public Market License, the Board will make a determination as to the final rules and regulations concerning the following activities in the Public Market: (1) the Conduct of Vendors; (2) the Conduct of License Holders within the Public Market; (3) the holding of events that are closed to the public; and (4) the maintaining of a common seating area.
