Upon arrival, the inspectors observed lights to be on in the interior and exterior of the establishment and voices could be heard coming from inside. Upon arrival, the inspectors observed lights to be on within the interior and exterior of the establishment and voices could be heard coming from inside the establishment with the exterior door unlocked. Upon entering the establishment, it was found to be open and operating with approximately 6 people seated at the bar. The inspector spoke with the bartender and asked them to produce the establishments permits and licenses while reminding the bartender they are not permitted to be open and operating past 10:00 p.m. as stated on the liquor license. The bartender stated that everyone seated were employees and one person was the cook. The inspector asked to see employee records to verify that the people inside were employees and the bartender stated that they did not have any employee records. The inspector then asked to see their health permit as the inspector did not recall the establishment having a kitchen and wanted to verify if they were allowed to prepare food inside. The bartender was unable to produce any health permit, and upon further inspection the inspector found a new kitchen on the first floor where food was clearly being prepared.

While outside of the establishment, the inspector observed the establishment's exterior lights being turned off and a large group leaving through the front door. At the time, the inspector believed that the establishment closed for the night. At approximately 10:15 p.m., the Housing inspector informed the inspector that they were parked across the street and observed people entering the establishment. At approximately 10:19 p.m., the inspectors entered the establishment and found it to be open and operating with approximately 6 people stated at the bar and one person smoking charcoal hookah. The inspector approached the bartender and asked if they were aware that the establishment should be closed. The bartender proceeded to call the manager, who came downstairs to speak to the inspectors. The inspectors informed the manager that the establishment was not permitted to be open and operating past 10:00 p.m. as stated on their liquor license. The manager stated that everyone seated were employees of the establishment, and the inspector asked to see employee records. The manager stated that they did not have any employee records as they were "rotating bartenders". The inspector reminded the manager that on June 28, 2024 they were required to keep employee records onsite. The inspector asked the manager if they have gotten the health permit, that they need in order to serve ice and utilize the new kitchen. The manager stated they did not know they needed one and claimed the inspector did not inform them of this requirement, but also stated that they do not use the kitchen but that it was for personal use. At this time, the manager started becoming combative and used profanity to the bartender regarding the inspector. The inspector informed the manager that a violation would be issued and proceeded outside. A patron was outside and asked if they could go back inside, the inspector stated that the establishment was closed.

While finishing up the BLLC paperwork, the Fire Marshall's informed the manager that they would be closing the establishment immediately since they were operating without power and using a generator which caused unsafe conditions.
