Summary of Violation: At approximately 9:45 p.m. on April 26, 2024, members of the BLLC along with members of the Social Club Task Force, that included members of the Department of Housing, Health Department, and Baltimore City Fire Department, conducted a joint inspection at the establishment. Upon entering the establishment to conduct their inspection, inspectors noticed a strong odor of smoke and observed numerous individuals smoking cigarettes and hookah inside. At the conclusion of the physical inspection, a check of the business records was performed, and the establishment could not produce a trader's license or invoices for alcohol purchases.

Summary of Violation: At approximately 9:00 p.m. on May 17, 2024, members of the BLLC along with members of the Social Club Task Force returned to the establishment to conduct a follow-up inspection. The inspector spoke to the licensee and requested the invoices that were not available during the previous inspection on April 26, 2024, in addition to invoices for the new stock located behind the bar. The licensee presented a 2022 invoice along with a handwritten invoice for bar equipment but did have an updated trader's license.

Summary of Violation: At approximately 10:15 p.m. on April 30, 2024, members of the BLLC responded to a 311 service call complaint for allegations of "Loud Music Every Tuesday Night". When the inspector approached the location, they noticed the front and rear door were open. They spoke to the licensee and explained the reason for their visit. The licensee requested to know who made the complaint and asked if they had a decibel reader. They explained that the Liquor Board does not utilize meters when responding to noise complaints but base findings on observations. They stated they were parked about a block away and could hear the music from their vehicle and from the surrounding alleyways as they approached. They requested to inspect the establishment and followed the licensee to the rear of the business where they observed a band with instruments, microphone and speakers. When the inspector requested the licensee to close the exterior doors, the licensee complied but continued to request a decibel reading then picked up their cell and shouted that they were going to contact their lawyer because they felt harassed. After the call, the inspector requested to see their liquor license to verify any other restrictions and complete the report. The licensee did provide their license and their frustration continued to escalate. The inspector explained that they would be receiving a violation for the loud music and the licensee refused to sign the violation and direction their employee not to sign it. Upon later review of the BMZA ruling, it was determined that, among other restrictions, this location is not permitted to have live entertainment Sunday through Thursdays after 9:00 p.m., and Friday and Saturdays after 11:00 p.m.

Upon arrival, the inspectors observed lights to be on in the interior and exterior of the establishment and voices could be heard coming from inside. asked them if the establishment was open. They stated yes and to just go through the front door was it was open.
