**2. Payment and Processing**

**REFILLABLE CONTAINER (GROWLER)** – Application fee is \$50.00. Upon approval the licensees shall have a Growler Privilege added to their license and will be subject to an annual \$50.00 fee as per Alc. Bev. Art. §12-1102, provided the licensee is allowed to sell alcoholic beverage for off premises consumption.

**WINE CORKAGE** – Application fee is \$20.00. Upon approval the licensees shall have a Wine Corkage Privilege added to their license. As per Alc. Bev. Art. §4-1102 there is no annual fee due to continue to offer the privilege.
