- (a) Applicant(s) Information: (1) John Poss was born in Nevada in August of 1980. He lives in Baltimore, MD; and

- (b) Ownership Breakdown: Alc. Bev. Article 12-1402- Applicants do not need to have "pecuniary interest", financial interest is enough.
- (c) Purchase Price of Business: This is a new Class "BHM" Beer, Wine and Liquor hotel license authorized Under Alc. Bev. Art. §12-1706 (D) (2) (I), which allows the Board to issue a license for use by a Hotel or Motel that, has: (1) at least 100 Rooms; and (2) a Capital Investment of \$500,000.
- (d) Qualified Voters: Kelly Horvath, Jennifer Dimattina, and Elizabeth Cooper are qualified Baltimore City voters.
- (e) **Zoning**: Applicants have applied for a USE permit, use of the property as a full service 128 room hotel and restaurant with off-premise catering.
- (f) Corporate Standing: 1715 Thames Street Licensee, LLC is a MD Corporation and as of 1/19/2017 is active and in good standing.
- (g) **Posting Report**: The location was posted on 1/4/2017 and checked on 1/17/2017. This meets the 10-day rule. There are 23 licensed liquor establishments in the 4x4 area: "D" BW-1; "A" BWL-1; "B" BWL-11; "BD7" BWL-10.
