The joint task force responded to the establishment and sent Baltimore City Police Cadet Charles Thomas, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). Violation of Adult Entertainment Rule 3.05(a) Incorporation of Liquor License Rules and Regulations to Applicable Licensees – December 20, 2017 – At approximately 12:00 AM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Charles Thomas, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). The joint task force responded to the establishment and sent Baltimore City Police Cadet

Charles Thomas, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). Upon confirming that there was an underage sale to a minor, the BLLC entered the establishment and conducted an inspection. At that time, they requested employee records from Mr. Dimitrios Bitsanis, the manager on-site, and he could not provide them to the BLLC.

2. **Mohammad Manockeh, Fisherman's Wharf Inner Harbor, Inc., T/a Mo's Fisherman's Wharf, 219 President Street – Class "B" Beer, Wine & Liquor License – Violation of Rule 4.01(a) Sales to Minors – December 19, 2017** – At approximately 11:05 PM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Charles Thomas, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time Thomas entered the establishment and ordered a 12 ounce bottle of Heineken beer. At that time, Ms. Amy Williams, the bartender on duty, set an open 12 ounce bottle of Heineken beer in front of Cadet Thomas. At no time did Ms. Williams ask Thomas for identification. Although he was not asked for payment by Ms. Williams, since he was furnished an alcoholic beverage, Thomas communicated to the task force that he was served an alcoholic beverage(s). Members of the task force entered the establishment and notified Ms. Williams that an alcoholic beverage(s) had just been furnished to a minor and it would be reported to the BLLC.
3. **Shawn Casserly, BMB Foods, Inc., T/a Kibby's Restaurant, 3450-56 Wilkens Avenue – Class "B" Beer, Wine & Liquor License – Violation of Rule 4.01(a) Sales to Minors – December 19, 2017** – At approximately 9:00 PM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Charles Thomas, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time Thomas entered the establishment and ordered a 12 ounce bottle of Corona beer. At that time, Ms. April Terzi, the bartender on duty, set an open 12 ounce bottle of Corona beer in front of Cadet Thomas. At no time did Ms. Terzi ask Thomas for identification. Although he was not asked for payment by Ms. Terzi, since he was furnished an alcoholic beverage, Thomas communicated to the task force that he was served an alcoholic beverage(s). Members of the task force entered the establishment and notified Ms. Terzi that an alcoholic beverage(s) had just been furnished to a minor and it would be reported to the BLLC.

Violation of Rule 4.16 Illegal Conduct – February 12, 2018 – At approximately 12:47 PM, BLLC staff conducted a review of the corporate status of the entity known as "BMB Foods, Inc." and found that the entity was deemed "forfeited" by the State Department of Assessments and Taxation.

The joint task force responded to the establishment and sent Baltimore City Police Cadet Charles Thomas, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time Thomas entered the establishment and

purchased an alcoholic cocktail consisting of Rum and Coca-Cola. Utilizing a departmental \$20 bill, Thomas purchased the alcoholic beverage(s). The joint task force responded to the establishment and sent Baltimore City Police Cadet Charles Thomas, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time Thomas entered the establishment and purchased a 375 ml bottle of New Amsterdam Peach Vodka. Utilizing a departmental \$20 bill, Thomas purchased the alcoholic beverage(s) for \$7.75.
