- ~~1. Sarbjit Singh and Sonya Walker, Badwal, LLC, T/a Lombard Liquor & Bar, 1000 W. Lombard Street – Class "BD7" Beer, Wine & Liquor License – Violation of Rule 4.16 Illegal Conduct –~~

October 10, 2018— At approximately 10:00 AM, the Maryland State Comptroller's Office conducted a routine liquor, business license, and tobacco inspection of the location. While conducting their inspections the Comptroller's agents discovered "other tobacco products" ("OTP"), which include cigars, cigarillos, chewing tobacco and loose tobacco products that were displayed for sale. Upon making these observations, the Comptroller's investigators asked the licensee, Ms. Sarbjit Singh and her husband, Mr. Harpal Badwal for receipts regarding these OTPs. Mr. Badwal provided numerous receipts for the Comptroller's investigators to review. Upon review of these receipts, the investigators could not account for all of the OTP that was on display for sale and stored within the establishment. Accordingly, the Comptroller's investigators seized all of the OTP that could not be accounted for based on the receipts submitted by Mr. Badwal.

Violation of Tax Gen'II Art. §13-1014 (a) Willful possession, sale, or offer to sell unstamped or improperly stamped cigarettes— **October 10, 2018**— At approximately 10:00 AM, the Maryland State Comptroller's Office conducted a routine liquor, business license, and tobacco inspection of the location. While conducting their inspections the Comptroller's agents discovered "other tobacco products" ("OTP"), which include cigars, cigarillos, chewing tobacco and loose tobacco products that were displayed for sale. Upon making these observations, the Comptroller's investigators asked the licensee, Ms. Sarbjit Singh and her husband, Mr. Harpal Badwal for receipts regarding these OTPs. Mr. Badwal provided numerous receipts for the Comptroller's investigators to review. Upon review of these receipts, the investigators could not account for all of the OTP that was on display for sale and stored within the establishment. Accordingly, the Comptroller's investigators seized all of the OTP that could not be accounted for based on the receipts submitted by Mr. Badwal. **POSTPONED**

- 2. Donald Savoy, Don West Management Services, LLC, T/a Indulge Night Club, 403-05 E. Baltimore Street – Class "BD7" Beer, Wine & Liquor License and Class "AE" Adult Entertainment License – Violation of Rule 4.08(a) Relations with Wholesalers – October 11, 2018** – At approximately 7:30 PM investigators from the Field Enforcement Division of the Maryland State Comptroller's Office entered the establishment to conduct a routine inspection of the premises. While on location, investigators asked a Mr. Aaron West, who described himself as the manager of the establishment, for all alcoholic beverage invoices for the purposes of comparing the invoices with the stock on the premises. Upon review of the invoices provided by Mr. West, the investigators discovered that approximately 61 bottles of alcohol within the establishment could not be verified as being purchased from a wholesaler or distributor. In addition, the Comptroller's Agents discovered that some of the bottles of alcohol that were on location could not be verified as the bottles which were actually purchased on specific dates as per the invoices. As a result, the Comptroller's Office seized and impounded all 61 bottles of alcohol and issued a Notice of Seizure Receipt for Confiscation From to a representative of the business.

Violation of Adult Entertainment Rule 3.05(a) Incorporation of Liquor License Rules and Regulations to Applicable Licensees – October 11, 2018 – At approximately 7:30 PM investigators from the Field Enforcement Division of the Maryland State Comptroller's Office entered the establishment to conduct a routine inspection of the premises. While on location, investigators asked a Mr. Aaron West, who described himself as the manager of the establishment, for all alcoholic beverage invoices for the purposes of comparing the invoices with the stock on the premises. Upon review of the invoices provided by Mr. West, the investigators discovered that approximately 61 bottles of alcohol within the establishment could not be verified as being

purchased from a wholesaler or distributor. In addition, the Comptroller's Agents discovered that some of the bottles of alcohol that were on location could not be verified as the bottles which were actually purchased on specific dates as per the invoices. As a result, the Comptroller's Office seized and impounded all 61 bottles of alcohol and issued a Notice of Seizure Receipt for Confiscation From to a representative of the business.

3. **Elaine Fordham, Isis, LLC, T/a Meadow Sports Lounge, 226-28 Park Avenue – Class "BD7" Beer, Wine & Liquor License – Violation of Rule 3.08(a) Sanitation and Safety– November 16, 2018** – At approximately 11:00 PM, investigators with the Social Club Task Force, which include members of the Police Department, Fire Department, Housing Department, Health Department, and BLLC, entered the location to conduct an inspection. While on location, inspectors from the Housing Department observed minor electrical violations and evidence of charcoal hookah use to include pipes, charcoal briquettes, ashes, and aluminum foil. In addition, health inspectors observed the following violations: No handsink was observed behind the bar and in the kitchen area, roach infestation on the premises, evidence of smoking inside of the establishment, and general unsanitary conditions. Due to the health code violations, the establishment was closed by the Health Department for evening.
4. **Tesfaye Birru and Fikremariam Worku, Jano Ethiopian Restaurant & Lounge, LLC, T/a Jano Ethiopia, 34 S. Eutaw Street – Class "B" Beer, Wine & Liquor License – Violation of Rule 3.08(a) Sanitation and Safety – November 21, 2018** – At approximately 11:15 PM, Baltimore City Police Detective L.C. Greenhill responded to the establishment to conduct a capacity check. Upon arrival, he observed a long line leading from the club out onto the street. Based on his observations he believed that establishment may be over capacity. Accordingly, Det. Greenhill called for assistance by the Fire Department. While waiting for the Fire Department to respond, Det. Greenhill made contact with the licensee, Mr. Fikremariam Worku, who upon observing the detective's presence exited the establishment and locked the front door (Eutaw side of the establishment). Det. Greenhill and Mr. Worku then walked to the Lombard Street entrance and went to the second floor of the establishment. Having reached the second floor of the establishment, Det. Greenhill estimated that there between 115-150 persons were on the second floor, which would be in violation of their fire rating – the establishment's fire rating is 27 for the 1st floor of the establishment and 90 for the second floor of the establishment. At that time, Det. Greenhill advised Mr. Worku that he would need to move individuals from the second floor of his establishment to the first floor to come into compliance with fire code safety standards. At this time, the fire department arrived and cited Mr. Worku for overcapacity and locking his front door as violations of the fire code. While on scene a fight broke out between female patrons of the establishment for which Central District police units were required to gain control of the crowd and prevent further acts of violence. Due to public safety concerns, Detective Greenhill decided to close the location for the evening.

Violation of Rule 3.12 General Welfare – November 21, 2018 – At approximately 11:15 PM, Baltimore City Police Detective L.C. Greenhill responded to the establishment to conduct a capacity check. Upon arrival, he observed a long line leading from the club out onto the street. Based on his observations he believed that establishment may be over capacity. Accordingly, Det. Greenhill called for assistance by the Fire Department. While waiting for the Fire Department to respond, Det. Greenhill made contact with the licensee, Mr. Fikremariam Worku, who upon observing the detective's presence exited the establishment and locked the front door (Eutaw side of the establishment). Det. Greenhill and Mr. Worku then walked to the Lombard Street entrance

and went to the second floor of the establishment. Having reached the second floor of the establishment, Det. Greenhill estimated that there between 115-150 persons were on the second floor, which would be in violation of their fire rating – the establishment’s fire rating is 27 for the 1st floor of the establishment and 90 for the second floor of the establishment. At that time, Det. Greenhill advised Mr. Worku that he would need to move individuals from the second floor of his establishment to the first floor to come into compliance with fire code safety standards. At this time, the fire department arrived and cited Mr. Worku for overcapacity and locking his front door as violations of the fire code. Violation of Rule 4.16 Illegal Conduct – January 22, 2019 – At approximately 10:22 AM, BLLC staff conducted a review of the corporate status of the entity known as “Jano Ethiopian Restaurant and Lounge, LLC” and found that the entity was “forfeited” as per the State Department of Assessments and Taxation.

5. **Ashley Orefice and Prakash Poudel, Mankamana, LLC, T/a Belair Discount Liquors, 3600 Belair Road – Class “A” Beer, Wine & Liquor License – Violation of Rule 3.08(a) Sanitation and Safety – November 30, 2018** – At approximately 8:40 PM, investigators with the Social Club Task Force, which include members of the Police Department, Fire Department, Housing Department, Health Department, and BLLC, entered the location to conduct an inspection. While on location, inspectors from the Fire Department observed the following issues: disorderly stock distribution throughout the premises, clutter and debris around the hot water heater, a lack of a 36-inch clearance around the furnace and other utilities, and improper blockage of egresses within the establishment. Due to the fire code violations, the establishment was closed by the Fire Department for evening.

Upon their arrival, both Police Officers and BLLC personnel observed multiple patrons loitering in front, and entering and exiting the establishment. While observing the establishment, patrons identified the Baltimore City Police Officers and BLLC inspectors. Patrons then notified the employees of the establishment of the presence of the Baltimore City Police Officers and BLLC inspectors. As a result, patrons began exiting the establishment. At this time, the Police Officers and BLLC exited their vehicles and approached the establishment. Upon approach of the establishment, police officers observed a female patron exiting the location with an open container in her hand. Police stopped the patron and identified the container as carrying an alcoholic beverage. Upon their arrival, both Police Officers and BLLC personnel observed multiple patrons loitering in front, and entering and exiting the establishment. While observing the establishment, patrons identified the Baltimore City Police Officers and BLLC inspectors. 7. **Daniel Macatee, 1222 Hull Street Corporation, T/a Hull Street Blues Café, 1222 Hull Street – Class “BD7” Beer, Wine & Liquor License – Violation of Rule 4.01(a) Sales to Minors – December 18, 2018** – At approximately 8:45 PM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Klado, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time, Klado entered the establishment and ordered a bottle of “Yuengling” beer from the store clerk/bartender, a Mr. Jon Kroeson. Upon ordering the alcoholic beverage, Mr. Kroeson opened the bottle of “Yuengling” beer and placed it in front of Klado for consumption. Klado then communicated to the task force that he had been furnished an alcoholic beverage(s). Members of the task force entered the establishment and notified Mr. Kroeson that an alcoholic beverage had just been furnished to a minor and it would be reported to the BLLC.

8. **David Berg and Bryan Spund, Admirals Cup, LLC, T/a Admirals Cup, 1645 Thames Street – Class “BD7” Beer, Wine & Liquor License – Violation of Rule 4.01(a) Sales to Minors – December 18, 2018** – At approximately 9:30 PM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Klado, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time, Klado entered the establishment and purchased a 12-ounce bottle of “Yuengling” beer from the store clerk/bartender, a Jessie Witt. Utilizing a departmental \$20 bill, Klado purchased the alcoholic beverage(s). Klado then communicated to the task force that he had purchased an alcoholic beverage(s). Members of the task force entered the establishment and notified Jessie Witt that an alcoholic beverage had just been purchased by a minor and it would be reported to the BLLC. The task force then recovered the marked currency and returned both the alcoholic beverage(s) to the licensee and/or any change that was provided to Klado.

9. **Patrick Russell, Kooper’s Tavern, Inc., T/a Kooper’s Tavern, 1702 Thames Street – Class “B” Beer, Wine & Liquor License – Violation of Rule 4.01(a) Sales to Minors – December 18, 2018** – At approximately 9:45 PM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Klado, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time, Klado entered the establishment and ordered a 12-ounce bottle of “Yuengling” beer from the store clerk/bartender, a Mr. Alexander Matthews. Upon ordering the alcoholic beverage, Mr. Matthews opened the bottle of “Yuengling” beer and placed it in front of Klado for consumption. Klado then communicated to the task force that he had been furnished an alcoholic beverage(s). Members of the task force entered the establishment and notified Mr. Matthews that an alcoholic beverage had just been furnished to a minor and it would be reported to the BLLC.

10. **Domingo Kim, Domingo Kim Enterprises, Inc., T/a Stadium Lounge, 3351-53 Greenmount Avenue – Class “BD7” Beer, Wine & Liquor License – Violation of Rule 4.01(a) Sales to Minors – November 14, 2018** – At approximately 9:50 PM the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Nolan Klado, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time, Klado entered the establishment and ordered a 375 ml bottle of “Fireball” whiskey. Utilizing a departmental \$20 bill, Klado purchased the alcoholic beverage(s) from bartender/store clerk Alicia Brown. Klado then communicated to the task force that he had purchased an alcoholic beverage(s). Members of the task force entered the establishment and notified Ms. Brown that a minor had just purchased an alcoholic beverage(s) and it would be reported to the BLLC. The task force then recovered the marked currency from the bartender/store clerk and returned both the alcoholic beverage and change from the transaction to Ms. Brown.
