As per the certified signing statement on the renewal application, Mr. Young, on May 5, 2017, stipulated that all of the facts contained in the application were "true and correct." Through an independent investigation of the BLLC, it was discovered that Mr. Kevin Young pled guilty and received a felony conviction in the Circuit Court of Baltimore City on March 28, 2017 – approximately one and a half months before the submission of his renewal application to the BLLC.**~~

~~**Violation of Rule 4.16 Illegal Conduct – March 1, 2018 – At approximately 1:03 PM, BLLC staff conducted a review of the corporate status of the entity known as "Touch Down, LLC" and found that the entity was deemed "forfeited" by the State Department of Assessments and Taxation.**~~
