**I. Regular Items (New, Transfers, Expansions and Hardships):**

1. **Arsh Mirmiran, CSM Ventures, LLC, T/a Cross Street Market, 1065 S. Charles Street** – Class “B-PML” Beer, Wine & Liquor Public Market License – Application for a new Class “B-PML” Beer, Wine & Liquor Public Market License under the provisions of Alcoholic Beverages Article §12-1002.1 requiring the applicant to be an operator of an enclosed public market, \$3,000,000 in capital investment, the location of the market to be surrounded by Charles Street on the West, East Cross Street on the North, Light Street on the East, and West Cross Street on the South. A Class “B-PML” Beer, Wine & Liquor Public Market License would allow for on-premises consumption and off-premises sales. The applicant is also requesting outdoor table service and off-premise catering.
2. **Karin Tiffany and Herbert T. Tiffany, III, Peter’s Inn, Inc., t/a Peter’s Inn, 504 S. Ann Street** – Class “D” Beer, Wine & Liquor License – Request for a hardship extension under the provisions of the Alcoholic Beverages Article § 12-2202.

**II. Violations:**

1. **George Divel, III, William Matricciani, and Donna Matricciani, Weidog, LLC, T/a Playbook, 6700 German Hill Road** – Class “BD7” Beer, Wine & Liquor License – **Violation of Rule 4.14(a) Live Entertainment without Authorization – January 20, 2018** – At approximately 8:30 PM members of the Baltimore City Police Department’s Vice Unit, the Housing Department, the Fire Department, the Health Department, and members of the BLLC’s Inspection Division conducted an inspection of the establishment. Upon entering the location, members of the joint team observed that there was a disc jockey operating a DJ stand that included two turn tables that was playing music over amplified portable speakers within the establishment. At this time, members of the joint team advised the bar manager, Mr. Walter Sevilla that the license issued to the establishment did not authorize live entertainment at the establishment and a violation was issued.

**Violation of Rule 3.03(c) Employee Records – January 20, 2018** – At approximately 8:30 PM members of the Baltimore City Police Department’s Vice Unit, the Housing Department, the Fire Department, the Health Department, and members of the BLLC’s Inspection Division conducted an inspection of the establishment. Upon entering the location, members of the joint team observed

approximately 6 female individuals running from behind the bar and into the bathroom. At this time, members of the joint team asked the bar manager, Mr. Walter Sevilla, for the establishment's employee records to verify the employment and identities of the female individuals running from behind the bar. Mr. Sevilla could not provide members of the joint team with copies of employee records for any of their current employees.

**Violation of Rule 3.09(b) Rest Room Facilities and Health Regulations – January 20, 2018 –**

At approximately 8:30 PM members of the Baltimore City Police Department's Vice Unit, the Housing Department, the Fire Department, the Health Department, and members of the BLLC's Inspection Division conducted an inspection of the establishment. Upon entering the location, members of the Health Department conducted an inspection of the kitchen area and found the following violations: improper hot/cold/cooling holdings, lack of functioning cooking equipment, non-functioning hand sinks in the bathroom, and a dog was observed caged up in a large gated area located near the alcoholic beverages stock. Due to the health code violations, the Health Department ordered that the establishment close for the evening.

The joint task force responded to the establishment and sent Baltimore City Police Cadet Bradford Day, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time Bradford Day entered the establishment and ordered a shot of "Crown Royal Apple" whiskey from Ms. Heather Marshall, the bartender on duty, for \$10.00. Utilizing a departmental \$20 bill, Bradford Day purchased the alcoholic beverage(s). Bradford Day then communicated to the task force that he had purchased an alcoholic beverage(s). Members of the task force entered the establishment and notified Ms. Marshall that an alcoholic beverage had been sold to a minor and it would be reported to the BLLC. The task force then recovered the marked currency and returned both the alcoholic beverage(s) to the manager/bartender and/or any change that was provided to Bradford Day.~~

The joint task force responded to the establishment and sent Baltimore City Police Cadet Bradford Day, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time Bradford Day entered the establishment and ordered a shot of "Crown Royal Apple" whiskey from Ms. Heather Marshall, the bartender on duty, for \$10.00. Utilizing a departmental \$20 bill, Bradford Day purchased the alcoholic beverage(s). Bradford Day then communicated to the task force that he had purchased an alcoholic beverage(s). Members of the task force entered the establishment and notified Ms. Marshall that an alcoholic beverage had been sold to a minor and it would be reported to the BLLC.
