Ponca Street – Class "BD7" Beer, Wine & Liquor License & Class "AE" Adult Entertainment License – Violation of Alcoholic Beverage Rule 4.01(a) Sales to Minors – April 18, 2018** – At approximately 9:50 PM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. 3. **Sumrit Deddechanukul and Rajwant Kaur, 1269 Washington Inc., T/a Chris Liquor & Grill, 1269 Washington Boulevard – Class “BD7” Beer, Wine & Liquor License – Violation of Rule 4.01(a) Sales to Minors – May 9, 2018** – At approximately 9:50 PM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Nolan Klado, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time Klado entered the establishment and purchased a 375ml bottle of “Fireball” Whiskey from the licensee/store clerk, Ms. Rajwant Kaur. Utilizing a departmental \$20 bill, Klado purchased the alcoholic beverage(s) for \$9.80. Klado then communicated to the task force that he had purchased an alcoholic beverage(s). Members of the task force entered the establishment and notified Ms. Kaur that an alcoholic beverage has been sold to a minor and it would be reported to the BLLC. The task force then recovered the marked currency and returned both the alcoholic beverage(s) and any change that was provided to Klado by Ms. Kaur.
4. **Claudia I. Cardona, Glen M. Izaquirre, and Ricardo Mouil, Wendy’s Bar, Inc., T/a Byzantio Café Bar, 4616-18 Eastern Avenue – Class “BD7” Beer, Wine & Liquor License – Violation of Rule 4.01(a) Sales to Minors – May 9, 2018** – At approximately 11:35 PM, the Baltimore City Police Department and the BLLC conducted random, joint investigations of establishments to determine if licensees would sell alcoholic beverages to minors. The joint task force responded to the establishment and sent Baltimore City Police Cadet Nolan Klado, who is under the age of 21, into the establishment to attempt to purchase an alcoholic beverage(s). At that time Klado entered the establishment and purchased a bottle of Corona beer from the bartender/store clerk, Ms. Josselyn Hernandez. Utilizing a departmental \$20 bill, Klado purchased the alcoholic beverage(s) for \$4.00. Klado then communicated to the task force that he had purchased an alcoholic beverage(s). Members of the task force entered the establishment and notified Ms. Hernandez that an alcoholic beverage has been sold to a minor and it would be reported to the BLLC. The task force then recovered the marked currency and returned both the alcoholic beverage(s) and/or change that was provided to Klado by Ms. Hernandez.
5. **Goya Choi, Jin Myung Seo, and Alfonzo Lee Wiggins, Club 4040, Inc., T/a Club 4040 Liquor & Grocery, 2139-43 Pennsylvania Avenue – Class “BD7” Beer, Wine & Liquor License – Violation of Rule 4.20(c)(ii) Class BD7 Licensees: Open and Operating Tavern at all Times – June 13, 2018** – At approximately 9:40 PM, members of the Baltimore City Police Department's Vice Unit and members of the BLLC's Inspection Division conducted an undercover investigation of this establishment to determine if staff would grant access to the tavern portion of the licensed premises to patrons. At this time, Inspector Ryan Crowder entered the establishment in an undercover capacity and attempted to gain access to the tavern portion of the premise. Mr. Shaquille Howell, who was the attendant present at the location, told Crowder “No” when Howell was asked if the bar was open. Furthermore Crowder was informed by Mr. Howell that there was

no alcohol in the bar area. Crowder left the establishment and informed members of the Vice Unit and BLLC inspection division of the violation. Members from each team entered the establishment and informed Mr. Howell, the manager on location, of the violation of Rule 4.20(c)(ii).

6. **Randal Etheridge, III and Brendan Finnerty, Brendal, Inc., T/a Idle Hour, 201 E. Fort Avenue – Class "BD7" Beer, Wine & Liquor License – Violation of Rule 4.14 (a) Live Entertainment without Authorization – January 19, 2018** – At approximately 8:30 PM, the Baltimore City Police Department, Fire Department, Housing Department, Health Department, and the BLLC conducted a joint investigation at the establishment. While on location, Housing Inspectors Crippen and Hensler observed that there was a disc jockey playing music from mixing board with amplified speakers and a microphone located within the establishment. Neither the establishment's Use and Occupancy permit nor its liquor license authorize the licensee to allow for live entertainment on premises.
7. **George Divel, III, William Matricciani, and Donna Matricciani, Weidog, LLC, T/a Playbook, 6700 German Hill Road – Class "BD7" Beer, Wine & Liquor License – Violation of Rule 4.14(a) Live Entertainment without Authorization – January 20, 2018** – At approximately 8:30 PM members of the Baltimore City Police Department's Vice Unit, the Housing Department, the Fire Department, the Health Department, and members of the BLLC's Inspection Division conducted an inspection of the establishment. Upon entering the location, members of the joint team observed that there was a disc jockey operating a DJ stand that included two turn tables that was playing music over amplified portable speakers within the establishment. At this time, members of the joint team advised the bar manager, Mr. Walter Sevilla that the license issued to the establishment did not authorize live entertainment at the establishment and a violation was issued.

Violation of Rule 3.03(c) Employee Records – January 20, 2018 – At approximately 8:30 PM members of the Baltimore City Police Department's Vice Unit, the Housing Department, the Fire Department, the Health Department, and members of the BLLC's Inspection Division conducted an inspection of the establishment. Upon entering the location, members of the joint team observed approximately 6 female individuals running from behind the bar and into the bathroom. At this time, members of the joint team asked the bar manager, Mr. Walter Sevilla, for the establishment's employee records to verify the employment and identities of the female individuals running from behind the bar. Mr. Sevilla could not provide members of the joint team with copies of employee records for any of their current employees.

Violation of Rule 3.09(b) Rest Room Facilities and Health Regulations – January 20, 2018 – At approximately 8:30 PM members of the Baltimore City Police Department's Vice Unit, the Housing Department, the Fire Department, the Health Department, and members of the BLLC's Inspection Division conducted an inspection of the establishment. Upon entering the location, members of the Health Department conducted an inspection of the kitchen area and found the following violations: improper hot/cold/cooling holdings, lack of functioning cooking equipment, non-functioning hand sinks in the bathroom, and a dog was observed caged up in a large gated area located near the alcoholic beverages stock. Due to the health code violations, the Health Department ordered that the establishment close for the evening.
