- 1. Jeremy Bratton and Laurie A. Davidow, 1715 Thames Licensee, LLC, T/a Pendry Hotel, 1715 Thames Street - Class "B" Beer, Wine & Liquor Hotel-Motel License - Violation of Rule 3.02 -Cooperation – June 24, 2023 – On June 24, 2023, Board of Liquor License Commissioners (BLLC) Chief Inspector John Chrissomallis was on duty working with the Baltimore City Fells Point Deployment. At approximately 2:30am, Baltimore Police Department (BPD) Major Saunders notified Chief Chrissomallis that a white male with a large knife had slashed the tires of the BPD wagon that was in the area. The wagon was parked directly across from the establishment. When Major Saunders approached the security manager and asked to view the exterior cameras so she could get a better description of the suspect running around with the large knife, she was told to get a subpoena. Major Saunders conveyed this information to Chief Chrissomallis. Chief Chrissomallis then went to the establishment and asked to speak to the manager on duty. Mrs. Janice Williams came out and Chief Chrissomallis explained to her that the outdoor security footage needed to be reviewed, because there was a suspect in the area with a large knife and potentially under the influence of some substance running around with a large knife. Mrs. Williams stated to Chief Chrissomallis that just as she told the Major, she was not willing to allow the footage to be viewed unless a subpoena or a warrant was provided. Chief Chrissomallis made Mrs. Williams aware that per the BLLC Rules and Regulations on the liquor license, the establishment was under an obligation to cooperate with representatives of the Board, the Police Department and other city, state, or federal agencies on official business and that a failure to do so would result in a violation being issued for non-cooperation. At that time, Mrs. Williams stated that she was following company rules and would not share footage. Chief Chrissomallis made her aware that he would be writing her a violation and left the establishment without any further incident.
- 2. Claudia Castro and Diana Rodriguez, Wendy's Bar, Inc., T/a Byzantio Café Bar, 4616-18 Eastern Avenue Class "BD7" Beer, Wine & Liquor License Violation of Rule 3.12 General Welfare (Cutting) June 11, 2023 On June 11, 2023, Board of Liquor License Commissioners (BLLC) Agent Andy Perez and Chief Inspector John Chrissomallis responded to the establishment for a report of an assault involving a bar patron and a security guard (bouncer). Upon arrival at approximately 12:00am, BLLC staff learned that one of the bouncers was cut on his face while attempting to remove an unidentified bar patron from the establishment. By the time of BLLC staff arrival, the bouncer had already been taken to Bayview Hospital for treatment. The bouncer could

not be identified, and no employee records for his employment at the establishment could be produced by the licensee, Ms. Claudia Castro.

During the course of further investigation, BLLC staff determined that security personnel working at the establishment are hired through Halal Protective Service LLC (Halal). Ms. Castro has been notified previously on multiple occasions—including at a prior violation hearing before the Board on 4/13/2023—that Halal is not licensed by the Maryland State Police as a security company, and that the establishment is liable for the actions of their bouncers. Ms. Castro had stated that all bouncers on her premises are employees of Halal; however, the signed contract she provided to BLLC Staff does not state such.

Violation of Rule 3.03(c) – Records (Employees) – June 11, 2023 – On June 11, 2023, Board of Liquor License Commissioners (BLLC) Agent Andy Perez and Chief Inspector John Chrissomallis responded to the establishment for a report of an assault involving a bar patron and a security guard (bouncer). Upon arrival at approximately 12:00am, BLLC staff learned that one of the bouncers was cut on his face while attempting to remove an unidentified bar patron from the establishment. By the time of BLLC staff arrival, the bouncer had already been taken to Bayview Hospital for treatment. The bouncer could not be identified, and no employee records for his employment at the establishment could be produced by the licensee, Ms. Claudia Castro.

During the course of further investigation, BLLC staff determined that security personnel working at the establishment are hired through Halal Protective Service LLC (Halal). Ms. Castro has been notified previously on multiple occasions—including at a prior violation hearing before the Board on 4/13/2023—that Halal is not licensed by the Maryland State Police as a security company, and that the establishment is liable for the actions of their bouncers. Ms. Castro had stated that all bouncers on her premises are employees of Halal; however, the signed contract she provided to BLLC Staff does not state such.

Xianting Charles Cao and Jason Jose Acevedo Rosario, Castle Seafood, Inc., T/a Castle Seafood Restaurant, 3720 Potee Street – Class "B" Beer, Wine & Liquor License – Violation of Rule – 4.14(a) – Live Entertainment without Authorization – June 17, 2023 – On June 17, 2023, Board of Liquor License Commissioners (BLLC) Inspector Rosalba Jordan received 311 Complaint #23-00456576 for the establishment describing "illegal outdoor entertainment, illegal outdoor bar." At approximately 10:15, Inspector Jordan arrived at the establishment in response to the 311 complaint.

As Inspector Jordan approached the establishment, she could hear loud music being played by a DJ who was set up in the outdoor courtyard as seen in the photograph attached to her Violation Report for this incident.
