Yumea Howard, Blu Ink Corporation, T/a 2 Twelve Lounge, 2709-11 Washington Boulevard – Class “BD7” Beer, Wine & Liquor License – Violation of Rule 3.03(a) – Records (Purchases of Alcoholic Beverages) – August 4, 2023** – On August 4, 2023, Board of Liquor License Commissioners (BLLC) Inspectors Cindy Tudhope and Rosalba Jordan, along with members of the Baltimore City Social Club Task Force (SCTF) that included the Baltimore Police Department Vice Unit (BPD Vice), Baltimore City Department of Housing and Community Development (Housing) inspectors conducted a joint inspection of the establishment for a permit check.

At approximately 8:55pm, the SCTF arrived at the establishment. At this time Inspector Tudhope made contact with the bartender who stated he did not know where anything was, as it was only his second day of employment. The bartender proceeded to contact the manager, who was on her way back to the bar. SCTF then made contact with Ms. Takerá Crander, who had no form of identification on her. Ms. Takerá stated she also did not know where any permits were, as the owner was away on vacation. After approximately 10 minutes, Ms. Takerá was able to produce a valid liquor license, but no other permits were made available to be inspected. At this time, Inspector Tudhope informed Ms. Takerá that the establishment would be receiving violations for failure to display or have permits available for inspection, having no fire permit, no health permit, no trader’s license, no invoices for purchases of alcohol, and no employee records.

Inspector Tudhope also issued a written warning to the establishment reminding them that they are not authorized to have live entertainment, as equipment was being set up at the time of inspection. Ms. Takerá complied and made the live entertainment equipment be packed away. SCTF left without further incident.
